ORDER

Considering the Debtors' *Motion to Assume Executory Contract* [P-109]; lack of objection thereto; representations of counsel at the hearing held on June 28, 2016 on this matter; and, good and sufficient cause having been shown;

IT IS ORDERED that the Debtors are authorized to assume their respective contracts with Langlinais, Broussard & Kohlenberg, CPAs ("LBK") for cost report accounting services;

IT IS FURTHER ORDERED that, pursuant to the provisions of 11 U.S.C. §365(a) and (b)(1)(A), adequate protection of future performance and all pre-petition defaults under the contracts shall be deemed compensated, cured and provided for as follows: (i) payment of \$15,000

to LBK on July 1, 2016, or as soon thereafter as practicable; (ii) payment to LBK of \$15,000 on

August 1, 2016; and, (iii) payment to LBK of \$15,012.79 on September 1, 2016;

IT IS FURTHER ORDERED that pursuant to its agreements with the Debtors, upon entry

of this order, LBK shall immediately perform under the Agreements, including providing work

papers and other information concerning the cost reports to the Debtors' management, SOLIC as

the consultants to the Debtors, and prospective purchasers of the Debtors' assets.
