OBJECTION TO CURE AMOUNT OF CONTRACT  
PROPOSED TO BE ASSUMED AND ASSIGNED

---

NOW INTO COURT, through undersigned counsel, comes De Lage Landen Financial Services, Inc. (“*DLL*”) who objects to the proposed cure amount of a certain lease agreement by and between DLL as lessor and Progressive Acute Care Oakdale, L.L.C. (“*PAC Oakdale*”) as lessee. In support thereof, DLL respectfully represents as follows:

1.

DLL and PAC Oakdale entered into a lease agreement whereby PAC Oakdale leased two RapidLab 248 machines along with all attachments and accessories thereto (the “*Lease Agreement*”). A copy of the Lease Agreement is attached hereto as Exhibit “A.”

2.

PAC Oakdale has not made all payments due under the Lease Agreement. As of the date of filing of this Objection and through the proposed assumption date, PAC Oakdale owes the sum of \$3,293.93 as shown on the account ledger attached as Exhibit “B.” Exhibit “A” to the Notice of (I) Bidding Procedures; (II) Auction; (III) Sale and Assignment Hearing and (IV) Related Relief and Dates which was attached as Exhibit 2 to this Court’s Order entered July 29, 2016 [P-226], designates the proposed cure for assumption and assignment as \$2,576.82.

3.

DLL hereby objects to the proposed cure amount as designated by the Debtor on the basis that such proposed cure amount does not accurately reflect all amounts owed under the lease proposed to be assumed and assigned.

**WHEREFORE**, DLL prays that this Court fix the cure amount for any assumption and assignment of the Lease Agreement attached hereto as Exhibit "A" at the sum of \$3,293.93 and for any such other relief deemed just.

**TERMS AND CONDITIONS**

1. **Lease:** You ("Lessee") agree to lease from us ("Lessor") the equipment (including software and/or software license fees ("Software"), if any, "Equipment") listed above and on any attached schedule (the "Lease"). You authorize us to adjust Lease Payments by up to 15% if the Equipment cost or taxes differ from the supplier's estimate. The Lease Payments are predicted on the five (5) Year Interest Rate Swap yield of 2.21 % ("Index Rate") as of January 12, 2011. The final Lease Payment may be adjusted upward in the amount of \$ .02 per one (1) basis point of increase in the Index Rate in effect at commencement and fixed for the term of the Lease. Interest Rate Swap yields are published daily in the Federal Reserve Statistical Release H-15 available at: <http://www.federalreserve.gov/releases/h15/update/h15updat.htm>. This Lease shall become effective when it is signed and accepted by us. The term of this Lease begins when we confirm your acceptance of the Equipment through a telephone verification ("Commencement Date"). The first Lease Payment is due on the date we accept this Lease or any later date designated by us and for each successive month until fully paid. If we designate Lease Payments to begin after the Commencement Date, you will pay an interim Lease Payment for Equipment use for the period from the Commencement Date until the first Lease Payment due date, calculated on the amount of the Lease Payments, the number of days in the period, and a year of 360 days. Your Lease obligations are absolute, unconditional, and are not subject to cancellation, reduction, setoff or counterclaim. You agree to pay a fee of \$125.00 to reimburse our expenses for preparing financing statements, other documentation costs and ongoing administration costs during the Lease term. Security deposits are non-interest-bearing and may be applied to cure a Lease default. If you are not in default, we will return your deposit when the Lease ends, without interest, unless otherwise required by law. If a Payment is not made when due, you will pay us a late charge of 5% for each Payment or \$10.00, whichever is greater. We may charge you a fee of \$25.00 for any check that is returned. YOU AGREE THAT NO ONE IS AUTHORIZED TO WAIVE OR CHANGE ANY LEASE TERM OR PROVISION.

2. **Title:** Unless you have a \$1.00 purchase option, we own the Equipment and you have the right to use the Equipment during the Lease term, provided you comply with the terms of this Lease. If you have a \$1.00 purchase option or this Lease is deemed to be a security agreement, you grant us a security interest in the Equipment and all proceeds therefrom, and authorize us to file financing statements on your behalf. If you are required to report the components of your payments to us hereunder to certain state and/or federal agencies or public health coverage programs such as Medicare, Medicaid, SCHIP or others, we will upon your written request, provide you with a detailed outline of the components of your payment(s) which may include equipment, software, service and other related components.

3. **Equipment Use, Maintenance and Warranties:** We are leasing the Equipment to you "AS-IS" AND MAKE NO WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. We transfer to you any manufacturer warranties. You must, at your cost, keep the Equipment in good working condition. If Lease Payments include third-party maintenance and/or service costs, you agree that (i) we are not responsible to provide the maintenance or service, (ii) you will make all maintenance and service related claims to the third party, and (iii) any maintenance or service claims will not impact your Lease Payment obligations. The Equipment cannot be moved from the location above without our prior written consent.

4. **Assignment:** You agree not to transfer, sell, sublease, assign, pledge or encumber the Equipment or any rights under this Lease without our prior written consent, and if you do, even with our consent, you will still be fully responsible for all your Lease obligations. You agree that we may sell, assign, or transfer ("Transfer") the Lease to a third party, and the third party will have our Transferred rights, but none of our obligations, and such rights will not be subject to any claims, defenses, or setoffs that you may have against us or any supplier.

5. **Risk of Loss and Insurance:** You shall bear all risk of Equipment loss or damage. If any such loss or damage occurs you still must satisfy all of your Lease obligations. You will (i) keep the Equipment insured against all risks of loss or damage for an amount equal to its replacement cost, (ii) list us as the insurance sole loss payee and (iii) give us written proof of the insurance. If you do not provide such insurance, we have the right, without obligation, to obtain such insurance and add an insurance fee (which may include a profit) to the amount due from you. We have no responsibility for any Equipment losses or injuries and you will reimburse us and defend us against any such claims, which obligation will survive Lease termination. You will obtain and maintain comprehensive public liability insurance naming us as an additional insured with coverages and amounts acceptable to us.

6. **Taxes:** You agree to pay when due, either directly or as reimbursement to us, all taxes (i.e., sales, use and personal property) and charges in connection with ownership and use of the Equipment. We may charge you a processing fee for administering property tax filings. You will indemnify us on an after-tax basis, on demand, against the loss or unavailability of any lessor-anticipated equipment ownership tax benefits caused by your act or omission.

7. **Default and Remedies:** You are in default on this Lease if: a) you fail to pay a Lease Payment or any other amount when due; or b) you breach any other obligation under the Lease or any other lease with us; or c) the Lessee principal owner or any Lease guarantor dies; or d) you or any guarantor becomes insolvent, bankrupt, merges, or is sold. Upon default, we may: a) declare the entire balance of unpaid Lease Payments for the full Lease term immediately due and payable; b) sue you for and receive the total amount due on the Lease plus the Equipment's anticipated end-of-Lease fair market value ("FMV") or fixed price purchase option (the "Residual") with future Lease Payments and Residual discounted to the date of default at the lesser of (i) a per annum interest rate equivalent to that of a U.S. Treasury constant maturity obligation (as reported by the U.S. Treasury Department) that would have a repayment term equal to the remaining Lease term, all as reasonably determined by us; or (ii) 3% per annum, but only to the extent permitted by law; c) charge you interest on all monies due at the rate of 18% per year from the date of default until paid; and/or d) require you to immediately return the Equipment to us or we may peaceably repossess it. Upon default, you will also pay all expenses including but not limited to reasonable attorneys fees, legal costs, cost of storage and shipping incurred by us in the enforcement and attempted enforcement of any remedies under this Lease. Any return or repossession will not be considered a Lease termination or cancellation. If the Equipment is returned or repossessed we may sell or re-rent the Equipment at terms we determine, at one or more public or private sales, with or without notice to you, and apply the net proceeds (after deducting any related expenses) to your obligations. You remain liable for any deficiency with any excess being retained by us.

8. **End of Lease:** You will give us at least 180 days but not more than 360 days written notice (to our address below) before the initial Lease term (or any renewal term) expiration of your intention to purchase or return the Equipment, whereupon you may: a) purchase all, but not less than all, of the Equipment as indicated above or b) return all of the Equipment in good working condition at your cost how, when and where we direct. Any FMV purchase option amount will be determined by us based on the Equipment's in place value. If you don't notify us, or if you don't a) purchase or b) return the Equipment as provided herein, this Lease will automatically renew at the same Payment amount for consecutive 180-day periods. If any Software license ("License") included hereunder passes title to you, such title shall automatically, and without further action, hereby vest in us, and you hereby agree to relinquish any subsequent Software title, purchase or use right claim. If, in connection with our Software rights, licensor's consent is required, you will assist us in obtaining such consent.

9. **Miscellaneous:** You agree the Lease is a Finance Lease as defined in Article 2A of the Uniform Commercial Code ("UCC"). You acknowledge we have given you the Equipment supplier's name. We hereby notify you that you may have rights under the supplier's contract and may contact the supplier for a description of these rights. This Lease was made in Pennsylvania ("PA"); is deemed to be performed in PA and shall be governed and construed in accordance with the laws of PA. You consent to the non-exclusive jurisdiction, personal or otherwise, in any state or federal court in PA and waive trial by jury. You agree (i) to waive any and all rights and remedies granted to you under UCC Sections 2A-508 through 2A-522, (ii) that the Equipment will only be used for business purposes and not for personal, family or household use and (iii) that a facsimile copy of the Lease and each document executed with the Lease may be treated as an original and will be admissible as legal evidence thereof. We may inspect the Equipment during the Lease term. This is the entire agreement of the parties. No failure to act shall be deemed a waiver of any rights hereunder.

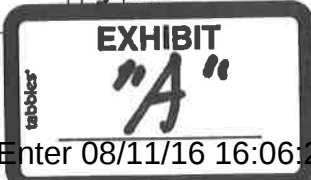


