ORDER PURSUANT TO BANKRUPTCY RULE 1015(b)
DIRECTING JOINT ADMINISTRATION OF CHAPTER 11 CASES

Considering the *Emergency Motion for Order Under Bankruptcy Rule 1015(b) Directing Joint Administration of Chapter 11 Cases* [P-7] (“Motion”) of Progressive Acute Care, LLC (“PAC”), Progressive Acute Care Avoyelles, LLC (“PAC Avoyelles”), Progressive Acute Care Oakdale, LLC (“PAC Oakdale”) and Progressive Acute Care Winn, LLC (“PAC Winn”) (collectively, the “Debtors”), for entry of an order pursuant to Rule 1015(b) of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), directing the joint administration of the Debtors’ chapter 11 cases; the Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; consideration of the Motion and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and, the Court having determined that the legal and factual bases set forth in the Motion establish sufficient cause for the relief granted herein;

IT IS HEREBY ORDERED that the Motion is **GRANTED**; and the above-captioned chapter 11 cases shall be jointly administered by this Court;

IT IS FURTHER ORDERED that nothing contained in this Order shall be deemed or construed as directing or otherwise affecting the substantive consolidation of any of the above-captioned cases;

IT IS FURTHER ORDERED that the caption of the jointly administered cases shall read as follows:
