in professional fees and \$8,079.08 in expenses incurred from May 31, 2016 through August 31, 2016, for a total of \$158,216.08 for that period; and, that the balance of said compensation due to Applicants shall be paid forthwith by the Debtors, Debtors' counsel, or any disbursing agent from the Debtors' funds held by them and out of the Debtors' estates as an allowed priority administrative claim pursuant to 11 U.S.C. §507(a)(2), provided that, if to be paid from Cash Collateral, such balance is within the limits of budgeted fees and expenses for such professionals as provided in the budgets approved by this Court in the Cash Collateral Orders, including those orders entered herein as Docket Nos. 89, 146, 241 and 304.
