**NOTICE OF ENTRY OF ORDER CONFIRMING JOINT CHAPTER 11 PLAN OF
ORDERLY LIQUIDATION FOR PROGRESSIVE ACUTE CARE, LLC, *ET AL.***

PLEASE TAKE NOTICE that on July 12, 2017 an order confirming the *Joint Chapter 11 Plan of Orderly Liquidation for Progressive Acute Care, LLC, et al.* [Doc. 550] (the “Confirmation Order”) was entered in the above-captioned matter.

PLEASE TAKE FURTHER NOTICE that in accordance with section 1141(d)(3) of the Bankruptcy Code, the Confirmation Order will not discharge Claims. However, no holder of a Claim may receive any payment from, or seek recourse against, any Assets that are to be distributed under the Plan other than Assets required to be distributed to that holder pursuant to the Plan. **AS OF THE CONFIRMATION DATE, ALL PERSONS ARE ENJOINED FROM ASSERTING AGAINST ANY PROPERTY THAT IS TO BE DISTRIBUTED UNDER THE PLAN ANY CLAIMS, RIGHTS, CAUSES OF ACTION, LIABILITIES, OR EQUITY INTERESTS BASED UPON ANY ACT, OMISSION, TRANSACTION, OR OTHER ACTIVITY THAT OCCURRED BEFORE THE EFFECTIVE DATE EXCEPT AS EXPRESSLY PROVIDED IN THE PLAN OR THE CONFIRMATION ORDER.**

PLEASE TAKE FURTHER NOTICE that through entry of the Confirmation Order, the Debtors’ Estates¹ have been substantively consolidated into a single Estate for those purposes set forth in and relating to the Plan.

PLEASE TAKE FURTHER NOTICE that Claims created by the rejection of executory contracts and unexpired leases pursuant to the Plan and the Confirmation Order must be filed with the Bankruptcy Court no later than thirty (30) days after the Confirmation Date.

PLEASE TAKE FURTHER NOTICE that, pursuant to the Confirmation Order, each Professional Person who holds or asserts a Fee Claim is required to file with the Bankruptcy Court, and serve on all parties required to receive notice, a Fee Application within forty-five (45) days

after the Effective Date. **The failure to timely file and serve such Fee Application shall result in the Fee Claim being forever barred and discharged, and no distribution shall be made under the Plan on account of any such barred and discharged Claim.**
