Stolier and the law firm of Sullivan Stolier, LLC ("Sullivan"), special counsel to Progressive Acute Care, LLC, Progressive Acute Care Avoyelles, LLC, Progressive Acute Care Oakdale, LLC and Progressive Acute Care Winn, LLC, (collectively, the "Debtors"), debtors, for the period October 1, 2016 through July 31, 2017; it appearing that Sullivan duly rendered the services and incurred the expenses on behalf of the Debtors in the performance of their duties as attorneys for the Debtors; and, that the services rendered and expenses incurred were necessary and reasonable, **IT IS ORDERED** that Sullivan is allowed compensation in the amount of \$962.50 in attorneys' fees and \$3.35 in expenses incurred from October 1, 2016 through July 31, 2017, for a total of \$965.85 for that period; and, that the compensation shall be paid forthwith by the Debtors, Debtors' counsel, or any disbursing agent from the Debtors' funds held by them and from the Debtors' estates as an allowed priority administrative claim pursuant to 11 U.S.C. §507(a)(2);

IT IS FURTHER ORDERED that this Application and all previously awarded applications are final.
