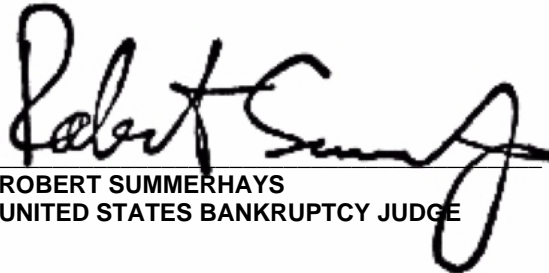

Considering the *Third and Final Application for Compensation and Reimbursement* [P-560] (“Application”) filed by Gregory Hagood and the firms of SOLIC Capital Advisors, LLC and SOLIC Capital, LLC (collectively, “Applicants”), as financial advisor for Progressive Acute Care, LLC, Progressive Acute Care Avoyelles, LLC, Progressive Acute Care Oakdale, LLC and Progressive Acute Care Winn, LLC (collectively, the “Debtors”), debtors-in-possession herein, for the period February 1, 2017 through July 31, 2017; this matter having been set for hearing on September 12, 2017; no objections to the Application having been filed; it appearing that SOLIC

duly rendered the services and incurred the expenses on behalf of the Debtors; and, that the services rendered and expenses incurred were necessary and reasonable,

IT IS ORDERED that Applicants are allowed compensation in the amount of \$44,717.00 in professional fees incurred from February 1, 2017 through July 31, 2017 and that the balance of said compensation due to Applicants shall be paid forthwith by the Debtors, Debtors' counsel, or any disbursing agent from the Debtors' funds held by them and out of the Debtors' estates as an allowed priority administrative claim pursuant to 11 U.S.C. §507(a)(2);

IT IS FURTHER ORDERED that this Application and all previously awarded applications are final.
