

Considering the *Second and Final Application for Compensation and Reimbursement* [P-565] (“Application”) filed by David D. Schmit and the firm of King, Reinsch, Prosser & Co., LLP (“KRP”), certified public accountants for Progressive Acute Care, LLC, Progressive Acute Care Avoyelles, LLC, Progressive Acute Care Oakdale, LLC and Progressive Acute Care Winn, LLC (collectively, the “Debtors”), debtors and debtors-in-possession herein, for the period of March 16, 2017 through July 31, 2017; this matter having been set for hearing on September 12, 2017; no objections to the Application having been filed; it appearing that KRP duly rendered the

services on behalf of each Debtor in the performance of their duties as certified public accountants for the Debtors; and, that the services rendered were necessary and reasonable,

IT IS ORDERED that the Application is granted and KRP is allowed compensation in the amount of \$18,862.50 for professional services rendered from March 16, 2017 through July 31, 2017;

IT IS FURTHER ORDERED that the compensation shall be paid forthwith by the Debtors, or any disbursing agent of the Debtors, from funds of the Debtors' estates as an allowed priority administrative expense claim pursuant to 11 U.S.C. §507(a)(2);

IT IS FURTHER ORDERED that this Application and all previously awarded applications are final.
