Orderly Liquidation of Progressive Acute Care, LLC, et al., as Jointly Proposed by the Debtors

and the Official Committee of Unsecured Creditors (the "Plan") (Doc. No. 550) shall be and

hereby is directed to immediately pay Kean Miller LLP all sums awarded in accordance with this

order to the extent such sums have not already been paid.
