

ORDER

Considering the *Final Application for Compensation and Reimbursement of Kean Miller LLP, Counsel for Official Committee of Unsecured Creditors* (Doc. No. 567) (the “Application”) filed by J. Eric Lockridge and the law firm of Kean Miller LLP (“Kean Miller”), counsel for the Official Committee of Unsecured Creditors Progressive Acute Care, LLC, *et al.* (the “Committee”) in the jointly administered Chapter 11 cases herein, for the period of January 1, 2017 through July 31, 2017; this matter having been set for hearing on September 12, 2017; no objections to the Application having been filed; the Court finding that Kean Miller actually rendered the services and incurred the expenses on behalf of the Committee in the performance of their duties as attorneys for the Committee; and, that the services rendered and expenses incurred were necessary and reasonable,

IT IS HEREBY ORDERED that the Application is Granted and Kean Miller is allowed final compensation in the amount of \$88,453.50 in attorneys' fees and \$929.91 in expenses incurred from January 1, 2017, through July 31, 2017, for a total of \$89,383.41 for that period, plus additional reasonable fees and expenses incurred by Kean Miller LLP in connection with the Application on or after the Effective Date of August 1, 2017; and

IT IS FURTHER ORDERED that the Liquidation Trustee (as defined in the *Joint Plan of Orderly Liquidation of Progressive Acute Care, LLC, et al., as Jointly Proposed by the Debtors and the Official Committee of Unsecured Creditors* (the "Plan") (Doc. No. 550) shall be and hereby is directed to immediately pay Kean Miller LLP all sums awarded in accordance with this order to the extent such sums have not already been paid.
