

**ORDER GRANTING FIRST INTERIM AND FINAL APPLICATION OF  
SILLS CUMMIS & GROSS P.C. FOR ALLOWANCE OF COMPENSATION  
AND REIMBURSEMENT OF EXPENSES INCURRED AS COUNSEL FOR  
THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS**

Considering the *First Interim and Final Application of Sills Cummis & Gross P.C. for Allowance of Compensation and Reimbursement of Expenses Incurred as Counsel for the Official Committee of Unsecured Creditors* (the “Application”) [Docket No. 564] filed by Sills Cummis & Gross P.C. (“Sills”), counsel for the Official Committee of Unsecured Creditors Progressive Acute Care, LLC, *et al.* (the “Committee”) in the jointly administered chapter 11 cases herein, for the period from June 21, 2016 and extending through July 31, 2017; and this matter having been set for hearing on September 12, 2017; and due and proper notice of the Application having been given, and no other or further notice being required; and the Court

having jurisdiction to consider the Application in accordance with 28 U.S.C. §§ 157 and 1334; and this being a core proceeding pursuant to 28 U.S.C. § 157(b); and no objections to the Application having been filed; and the Court finding that Sills actually rendered the services and incurred the expenses on behalf of the Committee in the performance of their duties as attorneys for the Committee, and that the services rendered and expenses incurred were necessary and reasonable;

IT IS HEREBY ORDERED that the Application is GRANTED and Sills is allowed interim and final compensation in the amount of \$314,511.70 (the “Fees”) and reimbursement of expenses in the amount of \$2,058.67 (the “Expenses”) for the period from June 21, 2016 through July 31, 2017, plus additional reasonable fees and expenses incurred by Sills in connection with the Application on or after the Effective Date of August 1, 2017 (the “Post-Effective Date Compensation”); and

IT IS FURTHER ORDERED that the Liquidation Trustee (as defined in the *Joint Plan of Orderly Liquidation of Progressive Acute Care, LLC, et al., as Jointly Proposed by the Debtors and the Official Committee of Unsecured Creditors* (the “Plan”) [Docket No. 550], the “Liquidation Trustee”) shall be and hereby is directed to immediately pay Sills all sums awarded in accordance with this order to the extent such sums have not already been paid.
