**AGREED ORDER TO RESOLVE OBJECTION TO  
PROOF OF CLAIM FILED BY GINA PRINCE**

Upon *PAC Liquidation Trust's First Omnibus Objection to Claims* (Doc. No. 580) (the "Objection") filed by Matthew E. Rubin, the Liquidation Trustee (the "Liquidation Trustee") for the PAC Liquidation Trust (the "Liquidation Trust"), appointed in the proceedings of the above-captioned debtors (collectively the "Debtors"); and it appearing that the Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and it appearing that this proceeding is a core proceeding pursuant to 28 U.S.C. § 157; and it

appearing that venue of this proceeding is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409; and based on the agreement of the undersigned counsel for Liquidation Trustee and Gina Prince, and the Court having determined that there exists just cause for the relief granted herein; and upon the record herein; and after due deliberation and sufficient cause appearing therefore, it is HEREBY ORDERED:

1. The Objection to Claim No. 156 filed by Gina Prince as an administrative priority claim in the amount of \$100,000 (“Claim No. 156”) is hereby sustained.
2. Claim No. 156 is hereby allowed as a priority claim only in the maximum amount of \$12,850.00 allowable under 11 U.S.C. § 507(a)(4), and the remainder of Claim No. 156 is allowed as a general unsecured claim in the amount of \$87,150.00.
3. Notwithstanding the possible applicability of Bankruptcy Rules 6004(h), 7062, 9014 or otherwise, the terms and conditions of this Order shall be immediately effective and enforceable upon its entry.
4. This Court shall retain jurisdiction with respect to all matters relating to the interpretation or implementation of this Order.
