Considering the Second and Final Application for Compensation and Reimbursement [P-582] ("Application") filed by Michael Freeman and the firm of TFG Consulting, LLC ("TFG"), healthcare accountants and consultants for Progressive Acute Care, LLC, Progressive Acute Care Avoyelles, LLC, Progressive Acute Care Oakdale, LLC and Progressive Acute Care Winn, LLC (collectively, the "Debtors"), debtors and debtors-in-possession herein, for the period of January 25, 2017 through July 31, 2017; this matter having been set for hearing on October 24, 2017; no objections to the Application having been filed; it appearing that TFG duly rendered the services

on behalf of each Debtor in the performance of their duties as healthcare accountants and

consultants for the Debtors; and, that the services rendered were necessary and reasonable,

IT IS ORDERED that TFG is allowed compensation in the amount of \$4,860.00 for

services rendered from January 25, 2017 through July 31, 2017 in connection with the completion

and filing of the final Medicaid and Medicare cost reports for the Debtors.

IT IS FURTHER ORDERED that the compensation shall be paid forthwith by any

disbursing agent of the Debtors, from funds of the Debtors' estates, as an allowed priority

administrative expense claim pursuant to 11 U.S.C. §507(a)(2);

IT IS FURTHER ORDERED that this Application and all previously awarded interim

applications are deemed final.
