Considering the *Motion to Pay Insiders* [P-20] filed by the above-captioned debtors (the "<u>Debtors</u>")¹, the arguments of counsel at the June 2, 2016 hearing held on this matter, and good and sufficient cause having been shown;

IT IS HEREBY ORDERED that the following insiders of Progressive Acute Care, LLC ("PAC") are authorized to receive compensation on an *interim basis* from PAC at the same rate as each was receiving prior to the Petition Date, effective *nunc pro tunc* to May 31, 2016:

Wayne Thompson: \$225,000.00 gross annually, plus the payment of his life insurance premium, medical insurance premium and dental insurance premium;

Michael Hurlburt: \$140,000.00 gross annually;

Daniel Rissing, Jr.: \$55,000.00 gross annually.

IT IS FURTHER ORDERED that the Debtor must have positive cash flow, current accounts payable (including all fees owed to the Office of the U.S. Trustee), and current monthly operating reports before making payments to insiders.

IT IS FURTHER ORDERED that a final hearing on the Motion will be held June 28, 2016, at 10:00 a.m.
