THIRD APPLICATION OF MOURANT OZANNES
AS SPECIAL CAYMAN ISLANDS COUNSEL FOR THE DEBTORS
FOR ALLOWANCE OF INTERIM COMPENSATION FOR SERVICES
RENDERED AND FOR REIMBURSEMENT OF ACTUAL AND NECESSARY
EXPENSES INCURRED FROM NOVEMBER 1, 2012 THROUGH MARCH 31, 2013

Mourant Ozannes, special Cayman Islands counsel for Arcapita Bank B.S.C.(c) and certain of its subsidiaries and affiliates, including Arcapita Investment Holdings Limited ("AIHL") as debtors and debtors in possession (collectively, the "Debtors"), pursuant to sections 330(a) and 331 of title 11 of the United States Code (the "Bankruptcy Code") and Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), hereby submits this third application (the "Application") for interim allowance of compensation for professional services performed by Mourant Ozannes for the period from November 1, 2012 through March 31, 2013

(the "*Third Compensation Period*"), and for reimbursement of its actual and necessary expenses incurred during the Third Compensation Period. Mourant Ozannes respectfully represents:

PRELIMINARY STATEMENT

- 1. Mourant Ozannes has assisted in ensuring that the Debtors' business continues to operate in chapter 11 as the Debtors move towards the completion of a successful reorganization of the Debtors.
- 2. By this Application, Mourant Ozannes applies to this Court for an order: (i) approving and allowing Mourant Ozannes' fees in the amount of \$524,573.00 and expenses in the amount of \$2,290.29, for a total amount of \$526,863.29 as administrative expenses of the Debtors' bankruptcy estates under section 503(b) of the Bankruptcy Code in connection with the professional services that Mourant Ozannes rendered as the Debtors' special Cayman Islands counsel during the Third Compensation Period; and (ii) authorizing the Debtors to immediately pay Mourant Ozannes the Second Holdback (as defined below) in the amount of \$61,305.60.

JURISDICTION

3. We are advised that this Court has jurisdiction to consider this Application pursuant to 28 U.S.C. §§ 157 and 1334. Consideration of this Application is a core proceeding pursuant to 28 U.S.C. § 157(b)(2). Venue of the Chapter 11 Cases (as defined below) is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409, respectively. The statutory predicates for the relief requested herein are sections 330 and 331 of the Bankruptcy Code.

GENERAL BACKGROUND

4. On March 19, 2012 (the "*Petition Date*"), Arcapita and five of its affiliates (collectively, the "*Initial Debtors*") commenced cases under chapter 11 of the Bankruptcy Code.

At the same time, AIHL presented a winding up petition in the Grand Court of the Cayman Islands and applied to appoint Mr Gordon Macrae and Mr Simon Appell of Zolfo Cooper as joint provisional liquidators (the "Joint Provisional Liquidators") to the company. We are advised that on April 30, 2012, Falcon Gas Storage Co., Inc. ("Falcon") commenced a case under chapter 11 of the Bankruptcy Code (along with the cases of the Initial Debtors, the "Chapter 11 Cases"). We are advised that the Chapter 11 Cases have been consolidated for procedural purposes only and are being jointly administered pursuant to Bankruptcy Rule 1015(b) and the Debtors are operating their businesses and managing their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

- 5. We are advised that on April 5, 2012, the United States Trustee for Region 2 appointed an Official Committee of Unsecured Creditors (the "*Committee*") pursuant to sections 1102(a) and (b) of the Bankruptcy Code. *See* Docket No. 60. No request has been made for the appointment of a trustee or an examiner in the Chapter 11 Cases.
- 6. Mourant Ozannes began performing legal services on behalf of the Debtors on the Petition Date in accordance with this Court's *Order Pursuant to Sections 327(e)* of the Bankruptcy Code Approving the Employment and Retention of Mourant Ozannes as Special Counsel for Debtors in Possession Nunc Pro Tunc to the Petition Date, entered on July 11, 2012 [Docket No. 313] (the "Retention Order"). The Retention Order approved Mourant Ozannes' retention nunc pro tunc to the Petition Date.
- 7. On May 18, 2012, this Court entered an *Order Granting Motion for Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Professionals and Committee Members* [Docket No. 159] (the "*Interim Compensation Order*").

¹ The Retention Order sets forth the terms and conditions of Mourant Ozannes' employment and compensation, the source of Mourant Ozannes' compensation, the existence and terms controlling use of a retainer, and any limitations on Mourant Ozannes' fees.

Pursuant to the Interim Compensation Order, each professional employed by the Debtors in these Chapter 11 Cases must file and serve a monthly fee statement (each, a "Monthly Fee Statement") detailing its fees and expenses incurred during the previous month. Unless a party in interest objects to the fees and expenses set forth in a professional's Monthly Fee Statement during a specified period (defined as the "Objection Period" in the Interim Compensation Order), the professional is entitled to be paid 80% of its fees and 100% of its expenses by the Debtors, subject to later allowance by an order of this Court.

8. The Interim Compensation Order also requires each professional employed by the Debtors to file and serve an application, pursuant to sections 330 and 331 of the Bankruptcy Code, for interim or final court approval and allowance of the compensation and reimbursement of expenses requested, approximately ever 120 days, but no more than every 150 days. On August 16, 2012, Mourant Ozannes filed its first fee application [Dckt. No. 424] (the "First Fee Application"), requesting interim approval and allowance of the fees and expenses incurred for the period from March 19, 2012 through July 31, 2012 (the "First Compensation **Period**"). No party filed an object to Mourant Ozannes' First Fee Application and, accordingly, on September 24, 2012, the Court entered an order [Dckt. No. 503] (the "First Fee Order") granting Mourant Ozannes' First Fee Application and approving and allowing fees in the amount of \$198,616.00 and expenses in the amount of \$11,878.61. The First Fee Order authorized the Debtors to immediately pay 100% of the allowed expenses and 80% of the allowed fees. The Court expressly reserved the right to authorize payment of the unpaid portion of the allowed fees for the First Interim Compensation Period, in the amount of \$36,491.00 (the "First Holdback"), at any time and without prior notice to any party.

- 9. On November 27, 2012, Mourant Ozannes filed its second fee application [Dckt. No. 675] (the "Second Fee Application") requesting interim approval and allowance of the fees and expenses incurred from August 1, 2012 through October 31, 2012 (the "Second Compensation Period"). On December 21, 2012, the Court entered an order [Dckt No. 748] (the "Second Fee Order") granting the Second Fee Application and approving and allowing fees in the amount of \$306,528.00 and expenses in the amount of \$2,047.10. The Second Fee Order authorized the Debtors to immediately pay 100% of allowed expenses, 80% of the allowed fees, and 100% of the First Holdback. The Court expressly reserved the right to authorize payment of the second holdback (\$61,305.60) (the "Second Holdback") in connection with the fee applications submitted by other professionals for the Second Compensation Period.
- During the Third Compensation Period, Mourant Ozannes' attorneys and paraprofessionals expended a total of 903.82 hours. However, Mourant Ozannes seeks compensation in respect of 902.02 hours only, as three attorneys billed less than three hours each during the course of the Third Compensation Period. We understand that these attorneys would be characterized as "transitory timekeepers". Accordingly, we have agreed to voluntarily write off their time in the amount of \$1,305.00. During that same period, Mourant Ozannes incurred fees in the amount of \$524,573.00² and reimbursable expenses in the amount of \$2,290.29.

 Assuming no objection is timely filed to Mourant Ozannes' Fifth, Sixth, Seventh, Eighth and Ninth Monthly Fee Statements, the Debtors are authorized, pursuant to the Interim Compensation Order, to pay Mourant Ozannes \$419,658.40³ for fees (80% of fees) and \$2,290.29 for costs (100% of costs) incurred during the Third Compensation Period. We

understand that no party has filed an objection to Mourant Ozannes' monthly statements pertaining to the Third Compensation Period during the relevant Objection Periods. To date Mourant Ozannes has received \$379,456.85⁴ comprising \$377,181.60 for fees and \$2,275.25 for costs incurred in respect of the Third Compensation Period.

- 11. By this Application, Mourant Ozannes seeks (i) the Court's approval of the total amount of its fees and expenses incurred during the Third Compensation Period (\$526,863.29), and (ii) authorization for the Debtors to immediately pay to Mourant Ozannes the Second Holdback in the amount of \$61,305.60.
- been full of activities critical to the Debtors' navigation of the requirements of Chapter 11, the provisional liquidation, continued business operation, and successful emergence from Chapter 11. Mourant Ozannes is working with Gibson Dunn & Crutcher LLP ("Gibson Dunn") (the Debtors' general insolvency counsel), the Debtors and their financial advisors, Alvarez & Marsal, to implement a plan of reorganization (the "Chapter 11 Plan") that will give effect to the Debtor's post-chapter 11 business plan. Mourant Ozannes are charged with obtaining the appropriate orders in the Cayman Islands to facilitate the Chapter 11 Plan and are working towards obtaining such orders on May 31, 2013.

SUMMARY OF PROFESSIONAL RETENTION, COMPENSATION AND REIMBURSEMENT OF EXPENSES REQUESTED

13. This Application is Mourant Ozannes' third interim application for compensation and reimbursement of expenses in these Chapter 11 Cases.

- Interim Compensation Order, Administrative Order M-447, Amended Guidelines for Fees and Disbursements of Professionals in Southern District of New York Bankruptcy Cases (the "Local Guidelines"), and the United States Trustee Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under 11 U. S. C. § 330, adopted on January 30, 1996 (the "U.S. Trustee Guidelines", and together with the Interim Compensation Order and the Local Guidelines, the "Guidelines"). Pursuant to the Local Guidelines, a certification regarding compliance with the Guidelines is annexed hereto as Exhibit A.
- 15. Pursuant to the U.S. Trustee Guidelines, annexed hereto as **Exhibit B** is a schedule setting forth all Mourant Ozannes' professionals and paraprofessionals who have performed services in the Chapter 11 Cases during the Third Compensation Period, the capacities in which each such individual is employed by Mourant Ozannes, the department in which each such individual practices, the hourly rate charged by Mourant Ozannes for services performed by such individual, the aggregate number of hours expended by each such individual on behalf of the Debtors during the Third Compensation Period, and the year in which each professional was first licensed to practice law.
- 16. Mourant Ozannes' fees in these Chapter 11 Cases were billed in accordance with its existing billing rates and procedures in effect during the Third Compensation Period. The rates Mourant Ozannes charged for the services rendered by its professionals and paraprofessionals in the Chapter 11 Cases are the same rates Mourant Ozannes charges for professional and paraprofessional services rendered in comparable non-bankruptcy related matters. Moreover, consistent with its belief that strict fee management inures to the benefit of the Debtors' estates, Mourant Ozannes diligently monitors the integrity of its bills associated

with these Chapter 11 Cases to ensure the reasonableness of the monthly totals for services rendered.

- 17. Annexed hereto as **Exhibit C** is a schedule specifying the categories of expenses for which Mourant Ozannes is seeking reimbursement and the total amount of reimbursement requested for each expense category during the Third Compensation Period. In connection with the provision of its legal services, Mourant Ozannes has sought, within the parameters required for effective legal representation, to minimize legal expenses.
- 18. Pursuant to Section II.D of the U.S. Trustee Guidelines, annexed hereto as **Exhibit D** is a summary by project category of the services performed by Mourant Ozannes during the Third Compensation Period.
- Mourant Ozannes maintains computerized records of time spent by all Mourant Ozannes attorneys and paraprofessionals in connection with the Chapter 11 Cases. Subject to redaction for attorney-client privilege, where necessary to protect the Debtors and their estates, copies of such computerized records are attached to this Application and will be furnished to the Court, the office of the United States Trustee for the Southern District of New York (the "*U.S. Trustee*"), and the Committee. Copies of the time records covering the Third Compensation Period are attached hereto as **Exhibit E.**
- 20. Mourant Ozannes has attempted to include in this Application all time and expenses relating to the Third Compensation Period. Delays in processing such time and receiving invoices for certain expenses may occur, however. Accordingly, Mourant Ozannes reserves the right to supplement this Application before the Application Hearing to request additional compensation for professional services rendered and reimbursement of expenses incurred during the Third Compensation Period.

21. There is no agreement or understanding between Mourant Ozannes and any other person for the sharing of compensation to be received for services rendered in these Chapter 11 Cases.

SERVICES RENDERED BY MOURANT OZANNES

- 22. During the Third Compensation Period, Mourant Ozannes rendered varied and complex professional services on behalf of the Debtors. The complexity and international nature of the Debtors has required the expenditure of time and effort on the part of many partners, senior associates, associates, and legal assistants of Mourant Ozannes. Moreover, these cases have posed unique issues for the Debtors and their professionals relating to the Debtors' ability to operate their businesses in Chapter 11 while maintaining the confidence of their employees, creditors, and the general public. To efficiently address these complicated issues in a timely manner, Mourant Ozannes has relied on senior personnel, primarily partners in the firm, to provide a great deal of the advice required by the Debtors. Of the total hours expended on this matter to date, approximately 51.46% were recorded by partners in the firm. While the hourly rate of these professionals is higher than the hourly rate of more junior personnel, the efficiency gain associated with the use of more experienced personnel in dealing with complicated issues of cross-border insolvency more than makes up for this rate differential. As a result, Mourant Ozannes has been able to provide a high quality of legal services using a core team of attorneys properly suited to provide efficient and timely advice.
- 23. The description of services below summarizes the most significant services rendered by Mourant Ozannes during the Third Compensation Period, and highlights the benefits conferred upon the Debtors, their estates, and their creditors as a result of those services. Because of the intricacy of the legal issues arising in the Chapter 11 Cases and the provisional

liquidation of AIHL, Mourant Ozannes has staffed the cases with attorneys in various areas of expertise, including insolvency and restructuring, litigation and corporate/funds. Any Mourant Ozannes professional or paraprofessional denoted as working in the litigation practice has extensive experience in dealing with insolvency matters, particularly contentious matters, on a daily basis. With regard to professionals and paraprofessionals denoted as working in the corporate practice, all such fee earners have extensive experience dealing corporate restructuring. During the Third Compensation Period, these lawyers and paraprofessionals performed work in the following key areas:

A. Asset Disposition/Sale Issues

[Total Hours 0.2 Total Fees \$120.00]

Compensation Period"), Mourant Ozannes assisted the Debtors in their efforts to sell certain assets and analyzed the bankruptcy implications of such sales under Cayman Islands law, including the implications of s.99 of the Companies Law (2012 Revision)(the "Companies Law") in respect of the agreement between the Debtors and Standard and Chartered Bank (the "SCB Settlement"). Most of this work was completed during the Second Compensation Period. However, a small amount of time was expended on this issue during the course of the Third Compensation Period. This work involved liaising with Gibson Dunn regarding the order made by the Cayman Court in respect of the SCB Settlement.

B. Case Administration

[Total Hours 4.6 Total Fees \$2,364.00]

25. During the Third Compensation Period, Mourant Ozannes worked with Gibson Dunn in performing a number of services necessary to the successful administration of the Chapter 11 Cases, including tasks associated with the other categories of services described

herein. During this period, such tasks related primarily to the preparation and delivery of a declaration in respect of Mourant Ozannes' professional fees and liaising with Alvarez and Marsal, the Debtors' financial advisors, in respect of Mourant Ozannes' outstanding fees.

C. Fee Applications/Retention Applications – Other Professionals [Total Hours 114.6 Total Fees \$51,157.00]

During the Third Compensation Period, Mourant Ozannes worked with Gibson Dunn in assembling and preparing its monthly fee statements, preparing and finalizing its Second Fee Application and preparing for the US Bankruptcy Court hearing held on December 18, 2012. In this regard, Mourant Ozannes carefully reviewed all draft monthly statements to avoid the disclosure of privileged or otherwise confidential material and ensured that all time entries complied with the Guidelines. Preparing and finalizing the monthly statements during the course of the Third Compensation Period was a particularly time-consuming exercise on the part of Mourant Ozannes' attorneys and paraprofessionals. This was due to the sharp increase in the volume of work undertaken between December 2012 and January 2013 which arose primarily from the DIP Financing and Plan and Disclosure Statement. During the Third Compensation Period, Mourant Ozannes also considered the Joint Provisional Liquidators' fee application before the Cayman Court to determine whether the fees sought were fair and reasonable in the circumstances.

E. DIP Financing

[Total Hours 639.82 Total Fees \$369,994.00]

27. Mourant Ozannes assisted Gibson Dunn with the task of obtaining debtor in possession financing ("DIP Financing") for the Debtors during the course of the Third Compensation Period. Mourant Ozannes expended substantial time and effort analyzing, arranging and obtaining the Cayman Court's authorization and approval of the DIP Financing.

The rendering of these services was critically important as we understand that budget forecasts indicated that additional financing would be necessary to support the Debtors' cash flow requirements through the Chapter 11 process.

- 28. The DIP Financing consists of a secured, super-priority, post-petition, Shari'ah compliant, Murabaha financing transaction with a value of up to \$150 million. Mourant Ozannes assisted and supported Gibson Dunn throughout the process of preparing a Shari'ah compliant, Murabaha-based post-petition financing package which we understand to be the first of its kind in United States bankruptcy jurisprudence. Overall, the DIP Financing process involved significant co-ordination between Mourant Ozannes and Gibson Dunn to ensure that the financing could be facilitated through AIHL and so that no application could be made to the Cayman Court, at a later date, seeking a declaration that the DIP Financing was void.
- 29. In connection with this work, Mourant Ozannes considered and advised on the bankruptcy implications of such a transaction, including s.99 of the Companies Law and the mechanics of obtaining a validation order in respect of the transaction.
- 30. Mourant Ozannes expended a significant amount of time in considering and advising on the proposed transaction, attending conference calls and meetings, considering, commenting on and finalising the transaction documents, liaising with Gibson Dunn regarding the proposed terms and liaising with Counsel to the DIP lender in this regard also.
- 31. Mourant Ozannes also expended significant time in advising on corporate aspects of the transaction under Cayman law, including the preparation of board minutes and shareholders' resolutions, the amendment of articles to facilitate the DIP lender enforcing its security, the preparation of directors' certificates, the provision of a legal opinion on capacity,

authority and due execution of the documents by certain of the Debtors under Cayman law, the carrying out of searches, attending to certain post-completion matters and conditions subsequent.

- 32. With regard to the necessary hearings to validate the DIP Financing in the US Bankruptcy Court and the Cayman Court, Mourant Ozannes worked with Gibson Dunn and other parties to co-ordinate the listing of these applications and the preparation of the requisite evidence. Mourant Ozannes also successfully moved the application seeking validation of the DIP Financing before the Cayman Court and obtained the requisite order approving the transaction.
- Tinally, the DIP Financing necessitated, at a late stage in the process, the taking of security over additional shares held within the Arcapita group. To give effect to this aim, Mourant Ozannes was required to make, on an expedited basis, a second application seeking the approval of this share transfer in the Cayman Courts during the course of the Third Compensation Period. This task involved liaising, at short notice, with the Cayman Court, Gibson Dunn, the Joint Provisional Liquidators, Counsel to the Creditors' Committee and other parties to obtain the requisite information and the preparation of the evidence needed to ground this application. The Cayman Court granted the application in the terms sought on January 10, 2013. As to the corporate aspects of the transfer of shares and the creation of security, Mourant Ozannes looked after certain aspects of this process, including the preparation of share transfer forms, directors' certificates and shareholders' resolutions, the carrying out of court searches and the preparation of a further legal opinion on capacity, authority and due execution.
 - 34. As a result, in part, of Mourant Ozannes' efforts and expertise, the DIP Financing to support the Debtors during the course of the Chapter 11 Cases was secured.

Mourant Ozannes achieved this goal under tight deadlines and obtained the necessary, ancillary orders from the Cayman Court in an efficient and diligent manner. While the fees in respect of this category are not insubstantial, they are reasonable in the circumstances and they are justified on the basis of the efforts expended by Mourant Ozannes' attorneys and paraprofessionals together with the positive result achieved on the Debtors' behalf.

F. Provisional Liquidation

[Total Hours 10.4 Total Fees \$6,258.00]

- 35. During the Third Compensation Period, Mourant Ozannes worked with Gibson Dunn and the Joint Provisional Liquidators with a view to coordinating efforts in the Chapter 11 Cases and the provisional liquidation. This co-operation is more fully outlined in the other categories of services described herein. To the extent that the tasks have not been summarized in these other categories, they are addressed here under this heading.
- 36. During the Third Compensation Period, Mourant Ozannes considered issues generally arising in the provisional liquidation including the Joint Provisional Liquidators' fee application before the Cayman Court.
- 37. Throughout this period, Mourant Ozannes have liaised with the Joint Provisional Liquidators in respect of the relevant categories addressed herein. These communications are detailed in the invoices produced at Exhibit E.

H. Creditor Committee Issues

[Total Hours 1.8 Total Fees \$1,404.00]

38. Mourant Ozannes have liaised with Cayman counsel to the Creditors'

Committee during the course of the Third Compensation Period. Various calls and emails were

exchanged by the parties regarding the disclosure and provision of documentation to the Creditors' Committee.

I. Plan and Disclosure Statement

[Total Hours 130.60 Total Fees \$93,276.00]

- 39. During the Third Compensation Period, Mourant Ozannes considered, in conjunction with Gibson Dunn, the various restructuring options open to the Debtors in great detail. In connection with this task, Mourant Ozannes attended meetings, participated on conference calls and engaged in research on the relevant points with a view to implementing a successful plan of reorganization. Mourant Ozannes liaised with Gibson Dunn, Linklaters and leading counsel, Mr Antony Zacaroli QC, with the aim of obtaining recognition by the Cayman Court in respect of the plan of reorganization in due course.
- Ozannes worked with Gibson Dunn on various corporate issues and the possible restructuring steps open to the Debtors in this context. This task has involved numerous conference calls and meetings with Gibson Dunn. It has also necessitated a review of underlying documents and a consideration of the various options proposed by Gibson Dunn with a view to ensuring the success of the Debtors' restructuring. The key documents necessary to implement the Chapter 11 Plan comprise, *inter alia*, (a) the plan document; (b) the disclosure statement that describes and makes key disclosures with respect to the proposed plan; and (c) a detailed steps plan itemizing the necessary corporate steps to implement a restructuring; (d) an equity term sheet that sets forth a summary of the equity and warrants in, and the corporate governance of, new holding companies and the restructured Debtors; and (e) a further term sheet describing the material terms of an agreement between the Debtors, the reorganized Arcapita and other parties for the

sale or other disposal of the portfolio investments. In this regard, Mourant Ozannes has reviewed and provided its comments on the various drafts of the above-mentioned documents to Gibson Dunn in order to assist in the implementation of the Chapter 11 Plan. In general, Mourant Ozannes has worked to ensure that any plan conforms with Cayman law and would be susceptible to recognition in the Cayman Courts. This task has involved significant expertise to formulate a plan of reorganization which would be acceptable to the Debtors' creditors generally, to bridge any issues arising from differences between US and Cayman law and to formulate a legal strategy by which recognition in the Cayman Court may be sought. Finally, Mourant Ozannes has considered and advised on discrete issues arising under Cayman Islands' employment law in the context of the proposed plan of reorganization.

41. In conclusion, Mourant Ozannes addressed complex areas of cross-border insolvency to assist Gibson Dunn in preparing the filed plan of reorganization. In light of the complexity of this matter and the necessity to find solutions to issues arising from the differences in Cayman and US law, Mourant Ozannes fees are reasonable in the circumstances.

ALLOWANCE OF COMPENSATION

- 42. We are advised that section 331 of the Bankruptcy Code allows a bankruptcy court to authorize interim compensation for "any professional person employed under section 327 or 1103 of this title ... not more than once every 120 days after an order for relief in a case under this title...." 11 U.S.C. § 331.
- 43. Further, we are advised that section 330 of the Bankruptcy Code authorizes the bankruptcy court to award a professional employed pursuant to section 327 of the Bankruptcy Code reasonable compensation for its services and reimbursement of its expenses. Specifically, section 330 of the Bankruptcy Code provides as follows:

- (a)(1) After notice to the parties in interest and to the United States Trustee and a hearing, and subject to sections 326, 328, and 329, the court may award to a trustee, an examiner, a professional person employed under section 327 or 1103
 - (A) reasonable compensation for actual, necessary services rendered by the trustee, examiner, professional person, or attorney and by any paraprofessional person employed by such person;
- (B) reimbursement for actual, necessary expenses.

 11 U.S.C. § 330(a)(1).
- 44. Section 330(a)(3) of the Bankruptcy Code provides that, in determining the amount of reasonable compensation to be awarded, the court should consider the nature and value of the services rendered to the estate, taking into account all relevant factors, including:
 - (A) the time spent on such services;
 - (B) the rates charged for such services;
 - (C) whether the services were necessary to the administration of, or beneficial at the time at which the service was rendered toward the completion of, a case under this title;
 - (D) whether the services were performed within a reasonable amount of time commensurate with the complexity, importance, and nature of the problem, issue, or task addressed;
 - (E) with respect to a professional person, whether the person is board certified or otherwise has demonstrated skill and experience in the bankruptcy field; and
 - (F) whether the compensation is reasonable, based on the customary compensation charged by comparably skilled practitioners in cases other than cases under this title.

11 U.S.C. § 330(a)(3)(A)-(F).

- 45. As analyzed below, Mourant Ozannes submits that the factors governing awards of compensation justify the allowance requested.
- 46. **The Time And Labor Required**. The professional services rendered by Mourant Ozannes have required substantial time and effort. During the Third Compensation

Period, Mourant Ozannes' partners, counsel, associates and paraprofessionals expended 902.02 recorded hours in providing the requested professional services. **Exhibit E** annexed hereto details the time and labor expended by Mourant Ozannes on behalf of the Debtors. The number of hours spent by Mourant Ozannes correlates with the Debtors' diligent efforts to operate as debtors in possession, to resolve significant issues, and to work rapidly with other professionals towards the implementation of a successful Chapter 11 plan of reorganization.

- 47. In connection with the provision of its legal services, Mourant Ozannes has sought, within the parameters required for effective legal representation, to minimize legal expenses. Mourant Ozannes has made every effort to coordinate its efforts with those of the Debtors' other professionals so as to avoid any duplication of efforts. Moreover, Mourant Ozannes has carefully reviewed the entries of all professionals and paraprofessionals who worked on these cases to determine the reasonableness of the monthly totals for services rendered.
- 48. **The Rates Charged For Such Services**. During the Third Compensation Period, Mourant Ozannes' hourly billing rates ranged from \$750 to \$800 per hour for partners, \$350 to \$650 for staff attorneys and associates, and \$250 to \$300 for paraprofessionals. Based on the recorded hours expended by Mourant Ozannes' attorneys and paraprofessionals, the average hourly billing rate for Mourant Ozannes' services during the Third Compensation Period was \$581.55.
- 49. The amounts charged to the Debtors for the services rendered approximate the rates charged to Mourant Ozannes' other clients for similar services. Indeed, if its retention in these matters was not pursuant to the Bankruptcy Code, Mourant Ozannes would charge the Debtors and expect to receive, on a current basis, an amount at least equal to the amount initially

charged for the professional services rendered. Accordingly, Mourant Ozannes believes that the fees sought in this Application are very reasonable for the services performed by Mourant Ozannes in effectively and efficiently assisting in the management and progression of the Chapter 11 Cases and the provisional liquidation of AIHL.

- 50. The Necessity Of The Services And Benefit To The Estate. As detailed above, the services that Mourant Ozannes provided to the Debtors were necessary to ensure the continuation of the Debtors' business and to work towards the implementation of the proposed plan of reorganization.
- 51. Mourant Ozannes has worked with Gibson Dunn, the Debtors and other professionals to achieve excellent results in the Chapter 11 Cases thus far, which has allowed the Debtors to stabilize their business. This success has enabled the Debtors, Gibson Dunn, Mourant Ozannes and other professionals engaged on the Debtors' behalf to direct their attention towards the proposed restructuring of the Debtors.
- Task Addressed, And The Time Spent On Such Tasks. The complexity, importance, and nature of the matters Mourant Ozannes has addressed in the Chapter 11 Cases justify the compensation sought by Mourant Ozannes in this application. This is particularly so in light of the complex cross-border elements of the matter. During the Third Compensation Period, Mourant Ozannes encountered and successfully assisted in resolving complex and difficult legal problems in many areas involving bankruptcy/insolvency and corporate, many of which required specialized expertise.
- 53. As is more fully detailed above, Mourant Ozannes believes that it has been able to assist in resolving many difficult and complex questions as they have arisen in an

expeditious and efficient manner. Mourant Ozannes believes that the services were performed in a reasonable amount of time, given the complexity of the issues involved and the many and varied legal issues facing the Debtors. Mourant Ozannes' detailed and thorough contemporaneous time records demonstrate that the time expended on various tasks was necessary and appropriate for the vigorous representation of the Debtors and their interests. From the earliest stages of Mourant Ozannes' involvement in the case, all appropriate attempts have been made to limit the hours worked to the lowest amount feasible, and to avoid duplication of effort and unnecessary costs.

- 54. Time Constraints Required By The Exigencies Of The Case. On many occasions, Mourant Ozannes attorneys rendered services on behalf of the Debtors under severe time constraints. Often, the services were performed well after regular business hours.

 Moreover, Mourant Ozannes' attorneys undertook matters on behalf of the Debtors to the preclusion of other firm matters and clients.
- 55. Experience, Reputation And Ability Of The Attorneys Rendering Services. Mourant Ozannes' services have been rendered in a highly efficient manner by attorneys who have a high degree of expertise in business reorganizations and corporate transactions.
- 56. The skill and competency of the Mourant Ozannes' attorneys who have represented the Debtors are unquestionable, and are amply demonstrated by the results achieved in these cases thus far. Mourant Ozannes' highly professional group of attorneys has ensured that these cases have been administered in the most efficient and expeditious manner possible under the circumstances.

- 57. **Customary Compensation**. Mourant Ozannes relies on the Court's experience and knowledge with respect to compensation awards in similar cases. Given that frame of reference, Mourant Ozannes submits that, in light of the circumstances of the case and the substantial benefits that the Debtors have derived from Mourant Ozannes' assistance thus far, compensation in the amount requested is fair and reasonable in the circumstances.
- 58. Based on the factors to be considered under section 330 of the Bankruptcy Code, we are advised that the results Mourant Ozannes has achieved in conjunction with other professionals to date more than justify allowance in full of Mourant Ozannes' compensation and reimbursement request.

DISBURSEMENTS

- 59. For the Third Compensation Period, Mourant Ozannes requests reimbursement of \$2,290.29 for reasonable and necessary out-of-pocket expenses incurred on behalf of the Debtors. **Exhibit C** attached hereto is a summary of such expenses, and **Exhibit F** attached hereto details each of the actual expenses incurred by Mourant Ozannes on behalf of the Debtors during the Third Compensation Period. Each of the charges reflected on **Exhibit C** and **Exhibit F** is based on the actual and necessary expenses incurred by Mourant Ozannes, in the exercise of reasonable discretion, on behalf of the Debtors.
- 60. Mourant Ozannes' normal billing rates do not take these expenses into consideration. Rather, Mourant Ozannes bills each expense to the applicable client. A prime example of the rationale for such an approach is the photocopying expense. Because of the great disparity between the photocopying requirements of different clients, it is virtually impossible to absorb photocopying costs fairly and equitably into Mourant Ozannes' normal billing rates.

 Accordingly, Mourant Ozannes charges each client separately for telephone, postage, overnight

courier, travel expenses and messenger services, in each case at Mourant Ozannes' cost. Mourant Ozannes does not charge for incoming or outgoing facsimile transmissions. Mourant Ozannes charges its clients \$0.61 per page for photocopying. The Local Guidelines, however, provide that photocopies shall be reimbursable at the lesser of \$0.10 per page or cost. In compliance with the Local Guidelines, Mourant Ozannes has sought reimbursement of photocopying costs in the amount of \$0.10 per page, and the amount of \$1,504.50 requested as reimbursement of in-house printing and duplication reflects this reimbursement rate.

- 61. Mourant Ozannes does not include the amortization of the cost of any investment, equipment, or capital outlay in its charges for these services.
- 62. Any services billed by a third party vendor are charged to the Debtors in the precise amount billed to and paid by Mourant Ozannes.
- 63. Mourant Ozannes has not sought reimbursement of any meal provided to attorneys or other employees devoting time to this matter over the weekend or during the evenings. Similarly, Mourant Ozannes has not sought reimbursement of transportation costs incurred by employees working late into the evening or night.
- 64. Mourant Ozannes has made reasonable efforts to minimize its disbursements in these Chapter 11 Cases. Each of the expenses incurred by Mourant Ozannes in providing professional services to the Debtors was necessary, reasonable, and justified under the circumstances to serve the needs of the Debtors, their estates, and creditors.

WHEREFORE, Mourant Ozannes requests: (a) that allowance be made to it in the sum of \$524,573.00 as compensation for necessary professional services rendered to the Debtors for the Third Compensation Period, and the sum of \$2,290.29 for reimbursement of actual necessary

costs and expenses incurred during the Third Compensation Period; (b) that the Debtors be immediately authorized to pay Mourant Ozannes the Second Holdback in the amount of \$61,305.60; and (c) that Mourant Ozannes be granted such other and further relief as this Court may deem just and proper.
