Johnson in Support of Debtors' Omnibus Claim Objections, dated July 15, 2013, filed as Exhibit F to the Supplement to the Debtors' Omnibus Claim Objections [Docket No. 1351] (the "Supplement"), (iii) the Declaration of Steven Kotarba in Support of Debtors' Omnibus Claim Objections, dated July 15, 2013, filed as Exhibit G to the Supplement, (iv) the Declaration of Steven Kotarba in Support of Debtors' Sixth Omnibus Objection to Claims, dated September 16, 2013, filed as Exhibit C to the Sixth Omnibus Objection [Docket No. 1515], (v) the Declaration of Scott A. Rinaldi in Support of Seventh Omnibus Objection to Claims, dated October 10, 2013, filed as Exhibit B to the Seventh Omnibus Objection [Docket No. 1623], (vi) the Statement in Connection with Hearing Scheduled for October 24, 2013 filed by the Reorganized Debtors [Docket No. 1641],

(vii) the Omnibus Reply to Certain Responses to Second Omnibus Objection to Claims filed by the Reorganized Debtors [Docket No. 1670], and (vii) the presentation of counsel at the hearing held on November 21, 2013; and the Court having jurisdiction to consider the Omnibus Objections pursuant to 28 U.S.C. §§ 157 and 1334; and venue of this proceeding in this district being proper pursuant to 28 U.S.C. §§ 1408 and 1409; and notice of the relief requested in the Omnibus Objections and the opportunity for a hearing being appropriate under the circumstances and no other or further notice being required; and the Court having determined that the legal and factual bases set forth in the Omnibus Objections, in the declarations in support thereof, and in the presentation of counsel at the hearing establish just cause for the relief granted herein; and the Court having found that the relief requested is in the best interest of the Debtors' estates, their creditors, and other parties in interest; and after due deliberation and sufficient cause appearing therefor, it is hereby:

1. **ORDERED** that the relief requested in the Omnibus Objections is granted to the extent provided herein.

2. **ORDERED** that, pursuant to section 502(b) of the Bankruptcy Code, each claim listed on Exhibit A annexed hereto is disallowed in its entirety and expunged.

3. **ORDERED** that the hearing with respect to claim numbers 45, 255, 289-294 and 517 is adjourned to **2:00 p.m. on December 17, 2013 (prevailing U.S. Eastern Time)**.

4. **ORDERED** that the hearing with respect to claim numbers 343-349 is adjourned to **11:00 a.m. on January 21, 2013 (prevailing U.S. Eastern Time)**.

5. **ORDERED** that the hearing with respect to claim numbers 376-379 is adjourned *sine die*.
