My name is Paul Davis and I am the authorized agent for Steven B. Toon. This email is to confirm in writing that our office, through a clerical error, sent duplicate proofs of claim for Steven B. Toon. I am requesting that claim #170 for "Steven Toon" be deleted from the register because it is a duplicate of claim number 172 for "Steven B. Toon." In other words, claim #172 should remain in the register, but we ask that claim #172 be removed.

Also, I spoke with Omar on the phone about internal errors by GCG in misspelling the names of the claimants in claims #167 and #182. He informed me that this matter should be taken care of today, but that I should include it in my email as well. The creditor name for #167 should read "Jeffery H. Foutch" and not "Jeffery H. Fautch" as it currently reads (change the "a" to "o"). The creditor name for claim #182 should read "Ellecia A. Knolle" and not "Ellecia A. Knolte" as it currently reads (change the "t" to "l").
