**DEBTORS’ REPLY TO RESPONSE AND LIMITED OBJECTION
OF OFFICIAL COMMITTEE OF UNSECURED CREDITORS
TO DEBTORS’ MOTION TO APPROVE
DIP COMMITMENT LETTER AND FEE LETTER**

Arcapita Bank B.S.C.(c) (“*Arcapita*”)¹ and certain of its affiliates (each, a “*Debtor*” and collectively, the “*Debtors*”) in the above referenced chapter 11 cases, hereby submit this reply (the “*Reply*”) to the *Response and Limited Objection of Official Committee of Unsecured Creditors to Debtors’ Motion to Approve DIP Commitment Letter and Fee Letter* [Docket No. 533], as revised by the *Statement in Connection with Response and Limited Objection of Official Committee of Unsecured Creditors to Debtors’ Motion to Approve DIP Commitment Letter and Fee Letter* [Docket No. 537] (as revised, the “*Limited Objection*”).

PRELIMINARY STATEMENT

The Limited Objection of the Official Committee of Unsecured Creditors (the “*Committee*”) does not dispute the Debtors’ need for financing. It does not challenge the arduous and well-documented debtor in possession financing solicitation process that took place prior to selection of Silver Point. It does not contest the fact that the Commitment Letter with Silver Point is clearly the subject of good faith, arm’s length negotiations. The Limited Objection does not even challenge the fact that, to date – after approximately a four month solicitation process – the Silver Point offer remains the best offer available.

Rather, the Limited Objection complains about the business terms of the Commitment Letter, terms that the Committee would have this Court “make better”. The Debtors do not disagree with the proposition that many of the provisions highlighted by the Committee could hypothetically be made better from the estate’s perspective. In a perfect world where the Debtors dictated all terms, the Debtors would condition allowance of Silver Point’s fees and expenses on the satisfaction of Silver Point’s diligence. But to date, no party – *absolutely none* – has committed to make such funds available on any such better or more relaxed terms, or even committed themselves to do the detailed diligence necessary to get to definitive documentation.

The Debtors believe, in their business judgment, that the Commitment Letter, although far from perfect, evidences a commitment on the part of Silver Point to extend arm’s length financing to the Debtors on terms that are within the range of reasonableness. Indeed, it remains the best available commitment towards a debtor in possession financing. Although the commitment is contingent on due diligence, Silver Point, *unlike any other potential lender*, is obligated to dedicate the substantial resources necessary to finalize its diligence and documentation in a commercially reasonable manner and thereby the most likely to consummate

definitive documentation of (to the Debtors' knowledge) the first ever Shari'ah compliant debtor in possession financing facility. Furthermore, the Commitment Letter represents the sole proposal received to date that combines satisfaction of the entirety of the Debtors' liquidity needs with a conversion-to-exit feature, and Silver Point has the greatest ability to deliver on a financing commitment within a relatively short timeline.

One further point is worth noting: the process embarked upon by the Debtors is working to the estate's benefit. Since the filing of the Commitment Letter Motion, negotiations between the various constituencies (including Debtors, Silver Point, Standard Chartered Bank, the Joint Provisional Liquidators, and the Committee) have resulted in material concessions from Silver Point,² concessions which are highlighted below and in the revised Commitment Letter, attached as **Exhibit B** hereto (the "*Revised Commitment Letter*")³ and in the revised Fee Letter, attached as **Exhibit C** hereto (the "*Revised Fee Letter*")⁴ and related documentation. Significantly, Silver Point has agreed to subordinate its DIP guarantees of Windturbine Holdings Limited, AEID II Holdings Limited, and RailInvest Holdings Limited to the guarantees issued by the same Debtors in favor of Standard Chartered Bank.⁵ Not only did this concession obviate Standard Chartered Bank's objection to the financing, but it also allowed the EuroLog IPO to go forward, which will benefit all estate constituencies. All the other terms and conditions of the Commitment Letter must be viewed with an eye on this integral concession by Silver Point.

Moreover, as noted by the Committee, subsequent to the filing of the Commitment Letter Motion there has been a marked increase in interest from other potential lenders who may seek to “outbid” Silver Point. Each of these developments is beneficial to the estates, and it is not surprising that Silver Point seeks reasonable compensation for its agreement to participate as the stalking horse in this process.

REPLY TO LIMITED OBJECTION⁶

A. Single / Multiple Draws

1. The Committee objects to the “single draw” provision contained in the Commitment Letter – the requirement that the Debtors draw the entire \$150 million (the “*DIP Facility*”) at one time. The Committee asserts that the Debtors do not require the full \$150 million to be drawn immediately.

2. Since the filing of the Commitment Letter Motion, the Debtors have been successful in negotiating with Silver Point on this issue, and Silver Point has agreed to provide the Debtors with multiple draws in the Revised Commitment Letter. Thus, the Debtors will not be required to draw down on the entire DIP Facility at once and will be able to make multiple draws, as necessary. This will generate savings as the unused line fee under the Revised Commitment Letter is less than the “Profit” due Silver Point for drawn amounts.

3. One of the Committee’s arguments against a “single draw” DIP Facility concerns other potential sources of cash. The Committee argues that these other sources, for instance, the \$35 million held in placement accounts held in Bahrain, could potentially obviate the need for \$150 million in total availability. But, in making this assertion, the Committee fails to take into account the following facts: that the Debtors have not been able to negotiate for the release of

this cash to date and may not be able to obtain such release absent timely and expensive litigation. Similarly, while the Debtors are hopeful that the EuroLog IPO will provide “cheaper” money to the estate, the actual timing and proceeds from that IPO are uncertain.

4. In any case, the Debtors have addressed any Committee objection to the size of the DIP Facility by negotiating for a voluntary reduction in the commitment based on their receipt of EuroLog IPO proceeds. Silver Point has agreed that the Debtors may voluntarily repay outstanding obligations under the Revised Commitment Letter with proceeds of the EuroLog IPO and concurrently, reduce Silver Point’s commitment thereunder. The Revised Commitment Letter obligates the Debtors to pay Silver Point for any undrawn commitments. A reduction in the commitment amount, therefore, will result in fewer fees, generating additional savings for the estates.

5. The Debtors believe that, rather than running the risk of having to upsize the facility after the fact, seeking an up-front commitment of up to \$150 million in financing, with the ability to draw less and voluntarily prepay and/or cancel commitments, provides for a more flexible approach to obtain required capital to continue operations in Chapter 11 and, therefore, is well within their reasonable business judgment.

B. Expense Reimbursement

5. The Committee objects to the terms of the Expense Reimbursement, asserting that absent a firm commitment from Silver Point to provide the DIP Facility, Silver Point should be entitled only to the \$500,000 expense reimbursement previously approved by the Court. Additionally, the Committee asserts that the uncapped Expense Reimbursement – payable once the Subject Conditions Precedent are met – should be capped.

6. The Debtors initially sought court approval to pay the \$500,000 expense reimbursement in order to incentivize Potential Lenders to submit financing proposals subject to certain contingencies. The Debtors were hopeful at the time (as the Committee is now) that the \$500,000 would be enough to incentivize lenders to complete diligence and complete documentation. Unfortunately, it is a simple fact that no lender to date has been willing to commit to complete diligence and documentation on such a basis.

7. In any event, the Debtors believe that the Expense Reimbursement is reasonable on several grounds. First, Silver Point has expended considerable time and resources in connection with the Proposed Transaction and thus, it is entirely reasonable that Silver Point would request full reimbursement for its out of pocket expenses. Second, the Proposed Order (a prior version of which was attached as Exhibit A to the Commitment Letter Motion) limits the Expense Reimbursement to reasonable and documented expenses. Thus, the estates are protected in that the Expense Reimbursement would only include Silver Point's reasonable expenses. Finally, the Proposed Order and the Revised Commitment Letter also provide the Committee with considerable rights to review and approve each invoice in connection with the Expense Reimbursement. Consequently, the Debtors, in the exercise of their business judgment, believe that the Expense Reimbursement is reasonable.

C. Conditions Precedent – Break Up Fee

8. The Committee is opposed to the Debtors being obligated to pay the .75% fee to Silver Point (referred to in the Committee's Limited Objection as the "***Break-Up Fee***"). The Committee also objects to the length of time Silver Point has to satisfy the Subject Conditions Precedent and suggests that Silver Point be required to complete its due diligence by October 9, 2012 and receive credit committee approval by a date to be determined.

9. The Debtors would certainly prefer that the Revised Commitment Letter contain as few conditions to reaching a firm commitment as possible. But the Debtors are also subject to the practical realities of the situation; to wit, Silver Point has neither completed its due diligence nor received credit committee approval for this complex, novel transaction. Those are the facts. The Debtors cannot change them.

10. Moreover, any assertion that Silver Point will not have “earned” any fee if the Debtors exercise their fiduciary out because Silver Point remains “uncommitted” is not accurate. First, the Revised Commitment Letter *requires* Silver Point to commit the time, energy and resources to complete its diligence and negotiate definitive documentation in a commercially reasonable manner.

11. Second, if Silver Point breaches its commitment to negotiate and document the financing in good faith and in a commercially reasonable manner at any time, the Debtors can immediately terminate the Revised Commitment Letter *without incurring any obligation to pay any fee* (other than reasonable expenses incurred by Silver Point prior to termination).

12. Third, the practical result of Silver Point publicly announcing its willingness to be bound to pursue this transaction and the proposed terms thereof has already, according to the Committee, resulted in other potential lenders surfacing who are expressing interest in providing financing on more favorable terms. One cannot reasonably expect Silver Point to publicly commit the capital, time, and resources to this transaction without some reasonable assurance that it will be compensated in the event the Debtors pursue an alternative transaction.

D. Fiduciary Out

13. Pursuant to the Commitment Letter, the Debtors may receive alternative proposals for financing and pursue such proposals; provided that, Silver Point may terminate the Revised

Commitment Letter if the Debtors decide to engage in negotiations and provide due diligence to a third party. The Debtors also retain the right to terminate the Revised Commitment Letter at any time, should the Debtors' board determine that such termination is required to comply with the board's fiduciary duties. In the event the Commitment Letter is terminated as a result of the Debtors' negotiation or execution of any debtor in possession financing other than the Commitment Letter, or a decision to discontinue pursuit of the Proposed Transaction consistent with their fiduciary duties, the Debtors are required pay to Silver Point the Break-Up Fee.

14. The terms of the Debtors' fiduciary out are the result of lengthy negotiations and significant back and forth between the parties. Silver Point wanted the right to terminate the Revised Commitment Letter if the Debtors started down the path of reaching an agreement with an alternative debtor in possession lender. Of course, the Debtors would prefer to have the broadest and most Debtor-friendly fiduciary out provision. However, based on the results of Rothschild's lengthy solicitation process and review of proposals and the significant back and forth between the parties, the Debtors, in their business judgment, determined that the proposed terms were reasonable under the circumstances.

15. Furthermore, although the Debtors determined to move forward with Silver Point, the Debtors never foreclosed the possibility of entertaining an alternative proposal featuring superior terms, and therefore, throughout the negotiations the Debtors ensured that they retain the right to receive proposals from third parties. Moreover, the fiduciary out language does not prohibit the Committee from actively pursuing alternative transactions with the Silver Point proposal acting as a backstop. That strategy has clearly proven successful, and the exclusivity provisions set forth in the Commitment Letter clearly have not shackled the Debtors to Silver Point's proposal. New potential lenders indicating an interest to provide cheaper financing have,

according to the Committee, recently surfaced. The fact that such lenders expressed interest *after* Silver Point's offer was publicly disclosed is no coincidence. This just further illustrates that the Debtors' process and strategy to obtain the best possible financing, and selecting and negotiating with Silver Point, has clearly succeeded.

16. Finally, as described in the Commitment Letter Motion, the Debtors have an immediate need for additional liquidity in order to maximize the value of the Arcapita Group Investments and bridge the Debtors' cash needs through their projected Chapter 11 emergence in the first quarter of 2013. Therefore, as a practical matter, the Debtors do not have the luxury of time to negotiate with potential lenders for better offers than the Silver Point proposal and can realistically only entertain serious offers from lenders that are committed to consummating a financing transaction on a shortened timeline. Consequently, in addition to being the best proposal to date, the entry into the Revised Commitment Letter with Silver Point may have the practical effect of incentivizing potential lenders to offer their best proposals with the fewest contingencies on an expedited basis.

E. Material Adverse Effect

17. The Committee also objects to the Material Adverse Effect clause in the Commitment Letter on the grounds that it is too broad.

18. While the parties engaged in hard fought negotiations regarding this provision, the Debtors submit that the Material Adverse Effect clause likely will have little effect on this transaction. Section 5(g) of the Revised Commitment Letter, together with Exhibit B attached to the Revised Commitment Letter, permits Silver Point to terminate its commitment in connection with its becoming aware of any "facts or conditions not previously known which has had, or could reasonably be expected to have, a material adverse effect," with the exception of the

continuation of the Chapter 11 Cases. Revised Commitment Letter § 5(g) and Exhibit B. However, the Revised Commitment Letter also contemplates Silver Point simultaneously engaging in due diligence and the negotiation of definitive documentation, both in a commercially reasonable manner and in a compressed time frame, and the Debtors will likely have to seek expedited approval of any transaction. Revised Commitment Letter § 1. Given the parties' expectations regarding the concurrent performance of the diligence and final documentation processes, practically there may be little, if any, opportunity for Silver Point to exercise its rights under the Material Adverse Effect clause. Viewed in light of Silver Point's other obligations under the Revised Commitment Letter, the Debtors respectfully submit that, in their considered business judgment, this provision is reasonable.

F. Avoidance Action Proceeds

19. When a debtor in possession requests approval of a post-petition debtor in possession financing, "there is no hard and fast prohibition against granting liens on avoidance actions, or granting [superpriority] claims that would have the same economic substance, that is, allowing the [superpriority claims] to siphon off value that would otherwise be available for admin claims or general unsecured claims." *In re Motors Liquidation Co.*, 460 B.R. 603, 627 n. 102 (Bankr. S.D.N.Y. 2011), *rev'd on other grounds sub nom. U.S. Dept. of Treasury v. Official Comm. of Unsecured Creditors of Motors Liquidation Co.*, 475 B.R. 347 (S.D.N.Y. 2012). Proceeds of avoidance actions are property of the Debtors' estate, and "there's nothing inherently wrong with allowing them to be used to satisfy claims in order of priority." *Id.*

20. This Court, therefore, can exercise its discretion to allow the proceeds of the Debtors' avoidance actions to be used to satisfy the administrative claims of Silver Point or the DIP Participants, if it finds that such measure is appropriate to obtain and secure the DIP

Facility. Other bankruptcy courts in this district have ordered avoidance action proceeds to serve as collateral for DIP financing obligations or to be made available to pay the superpriority claims of DIP lenders in large and complex chapter 11 cases comparable to those of the Debtors. *See, e.g., In re Patriot Coal Corp.*, Case No. 12-12900 (SCC) (Bankr. S.D.N.Y. Aug. 3, 2012) [Docket. No. 275] (ordering that proceeds of the debtors' avoidance actions shall be subject to liens granted in connection with a DIP financing and shall be available to pay the superpriority claims of the DIP lenders); *In re Lyondell Chemical Co.*, Case No. 09-10023 (REG) (Bankr. S.D.N.Y. Mar. 1, 2009) [Docket. No. 1002] (ordering that proceeds of the debtors' avoidance actions shall be subject to liens granted in connection with a DIP financing).

CONCLUSION

WHEREFORE, the Debtors respectfully request that the Court overrule the Limited Objection and authorize the Debtors' entry into the Revised Commitment Letter and incur related fees, expenses and indemnities, and such other and further relief as the Court may deem just and proper.

\$150,000,000 Murabaha Debtor-In-Possession Facility
Commitment Letter

Ladies and Gentlemen:

You have advised Silver Point Finance, LLC (“Silver Point”, “we” or “us”) that you have filed separate voluntary petitions for yourself and certain of your subsidiaries (excluding Falcon Gas Storage Company, Inc., the “Company”)¹ for reorganization under Chapter 11 of the U.S. Bankruptcy Code with the United States Bankruptcy Court for the Southern District of New York (the “Bankruptcy Court”), Case No. 12-11076 (the “Chapter 11 Cases”) and that you will require a Shari’ah-compliant term Murabaha debtor-in-possession facility (the “Murabaha DIP Facility”) in order to finance the Company’s operations, including on-going operating costs, general corporate purposes, certain investment deal fundings, and bankruptcy-related costs during the Company’s chapter 11 proceedings. Capitalized terms used but not defined herein shall have the meaning assigned to such term in the Murabaha DIP Facility term sheet (“Murabaha DIP Term Sheet”) attached hereto as Exhibit A.

This Commitment Letter (defined below) and the Murabaha DIP Term Sheet describe terms and conditions under which Silver Point currently would propose to provide to the Company \$150,000,000 (the “Facility Amount”) under the Murabaha DIP Facility.²

This Commitment Letter and the related fee letter of even date herewith (the "Fee Letter") set forth the entire agreement between the parties hereto as to the matters set forth herein and therein and supersede all prior understandings, whether written or oral, between us with respect to the matters herein and therein (including the Commitment Letter and Fee Letter dated September 25, 2012). Please note that those matters that are not covered or made clear herein, in the Murabaha DIP Term Sheet or the Fee Letter are subject to mutual agreement of the parties hereto.

1. Commitments.

In connection with the foregoing, Silver Point is pleased to advise you of its commitment to provide 100% of the commitments under the Murabaha DIP Facility, upon the terms and subject to the conditions set forth or referred to in this commitment letter (together with the Murabaha DIP Term Sheet, this "Commitment Letter") and in the Fee Letter. Silver Point agrees to conduct its due diligence under Section 5(a) below and to negotiate Definitive Financing Documentation (as defined in Exhibit B hereto) in a commercially reasonable manner after the entering of an order in form and substance reasonably acceptable to Silver Point by the Bankruptcy Court approving Sections 6 and 8 this Commitment Letter and Sections 1(a) and 1(b) of the Fee Letter; provided that, if Silver Point determines in good faith that the Company will not be required to reimburse it for fees and expenses due pursuant to the conditions set forth in Section 6 below, Silver Point shall not be required to continue such due diligence or negotiate Definitive Financing Documentation. Subject to the date hereof, from the date of acceptance of this Commitment Letter to the Murabaha DIP Closing Date or the termination of this Commitment Letter, you agree to diligently pursue Bankruptcy Court approval of this Commitment Letter and the Fee Letter, and the proposed Murabaha DIP Facility.

2. Titles and Roles.

Silver Point shall have the right (in consultation with you) to award such roles or titles as may be reasonably determined by Silver Point, to one or more other banks, financial institutions and other institutional lenders or affiliates thereof (together the "Participants"), in each case as determined by Silver Point. You agree that, except as contemplated above, no other agents, co-agents or arrangers will be appointed, no other titles will be awarded and no compensation (other than that expressly contemplated by this Commitment Letter and Definitive Financing Documentation) will be paid in connection with the Murabaha DIP Facility, unless you and we shall so agree.

3. Additional Participants.

In our sole discretion, we may commence our efforts to bring in additional Participants with respect to the Murabaha DIP Facility promptly upon your execution and delivery to us of this Commitment Letter. Timing for this, potential Participants to be approached, titles, allocations and division of fees, shall be determined by (and coordinated exclusively through)

Sheet and in Exhibit B shall also apply to any draws that occur after the Murabaha DIP Closing Date to the extent such conditions precedent are applicable.

Silver Point in consultation with you. You agree actively to assist us in this process in a manner that is reasonably satisfactory to us.

4. Information.

You represent, warrant and covenant that (a)(i) no information which has been or is hereafter furnished by you or on your behalf in connection with the Murabaha DIP Facility including, without limitation, information provided in response to the diligence requests set forth on Exhibit C hereto and other confirmatory due diligence (other than the estimates, forecasts, projections and other forward-looking financial information regarding the future performance of the Company (collectively, the “Projections”)) and (ii) no other information supplied or approved by you or on your behalf (other than the Projections) (such written information and other information being referred to herein collectively as the “Information”), taken as a whole contained (or, in the case of Information furnished after the date hereof, will contain), as of the time it was (or hereafter is) furnished, any material misstatement of fact or omitted (or will omit) as of such time to state any material fact necessary to make the statements therein taken as a whole not misleading, in the light of the circumstances under which they were (or hereafter are) made and (b) the Projections that have been or will be made available to us by you or any of your representatives have been or will be prepared in good faith based upon assumptions that you believe to be reasonable at the time made and at the time such Projections are made available to us, it being recognized by the Participants and Silver Point that such Projections are not to be viewed as facts and that actual results during the period or periods covered by any such Projections may differ significantly from the projected results, and that no assurance can be given that the projected results will be realized. You understand that, in arranging the Murabaha DIP Facility, we will be entitled to use and rely on the Information and the Projections without responsibility for independent verification thereof.

5. Conditions Precedent.

Silver Point’s agreement to provide commitments and agreements described herein, is subject to:

(a) Silver Point’s completion of its business, legal, tax, financial, and accounting due diligence with respect to the Murabaha DIP Facility and the Company including, without limitation, due diligence with regards to the high priority matters as set forth on Exhibit C hereto and confirmatory due diligence, in each case, to Silver Point’s full satisfaction with the results thereof;

(b) approval of this Commitment Letter and the Murabaha DIP Facility by Silver Point’s credit committee;

(c) Silver Point not becoming aware (whether as a result of its due diligence analyses and review or otherwise), after Silver Point has notified you in writing that the conditions precedent set forth in Sections 5(a) and 5(b) above have been satisfied, of any information not previously known to Silver Point which is materially negative information with respect to the property, assets, business, operations, liabilities, condition (financial or otherwise) or prospects of the Company, or which is inconsistent in a material and adverse manner with any

such information or other matter disclosed to Silver Point prior to the satisfaction of the conditions precedent set forth in Sections 5(a) and 5(b) above;

(d) your written acceptance of, and compliance with, the terms and conditions, of the Fee Letter and pursuant to which you agree to pay, or cause to be paid, to Silver Point certain fees and expenses and to fulfill certain other obligations including the reimbursement of expenses as provided in this Commitment Letter;

(e) the other conditions set forth or referred to in the Murabaha DIP Term Sheet or, when executed, the Definitive Financing Documentation;

(f) the Company having reasonably cooperated with Silver Point in arranging the Murabaha DIP Facility, including, without limitation, by promptly providing Silver Point with all information reasonably deemed necessary by it in order to bring in additional Participants; and

(g) satisfaction of the conditions precedent set forth on Exhibit B hereto.

6. Expenses; Indemnification.

To induce Silver Point to issue this Commitment Letter and to proceed with the Definitive Financing Documentation, you hereby agree that all reasonable and documented fees and expenses incurred prior to the date of the termination of this Commitment Letter (including the reasonable and documented fees and expenses of counsel and consultants) of Silver Point and its affiliates arising in connection with this Commitment Letter and the Murabaha DIP Facility and the preparation, negotiation, execution, delivery and enforcement of this Commitment Letter, the Fee Letter and the Definitive Financing Documentation (including in connection with our due diligence and syndication efforts), whether incurred before, on, or after the date hereof, shall be for your account (and that you shall, on demand, reimburse Silver Point and its affiliates for any reasonable and documented out-of-pocket outstanding and unreimbursed fees and expenses paid or incurred by them), whether or not the Murabaha DIP Facility is made available or the Definitive Financing Documentation is executed. Notwithstanding anything set forth herein, until Silver Point has notified you that the conditions precedent set forth in Sections 5(a) and 5(b) below have been satisfied, your obligation to reimburse the reasonable and documented fees and expenses of Silver Point shall be subject to a cap of \$900,000. In all instances, prior to payment of any expense reimbursement, the Committee and the Debtors shall have three days after Committee counsel's receipt of any related invoice to review such invoice and serve the Debtors and Silver Point with notice of any objection setting forth the amount of costs or expenses to which the Committee or the Debtors, as applicable, objects, consistent with the Bankruptcy Court's *Order Approving Expense Reimbursement in Connection with Prospective Post-Petition Financing* [Docket No. 500] in the Chapter 11 Cases. You further, jointly and severally, agree to indemnify and hold harmless Silver Point, each Participant, and their respective affiliates and each director, officer, employee, representative and agent thereof (each, an "Indemnified Person") from and against any and all actions, suits, proceedings (including any investigations or inquiries), claims, losses, damages, liabilities or expenses of any kind or nature whatsoever which may be incurred by or asserted against or involve Silver Point, any Participant or any other such Indemnified Person as a result of or arising out of or in any way related to or resulting from (i) this Commitment Letter, the Definitive Financing

Documentation, or any related transaction or (ii) the use or the contemplated use of the proceeds of the Murabaha DIP Facility and, upon demand, to pay and reimburse Silver Point, each Participant and each other Indemnified Person for any reasonable legal or other out-of-pocket expenses paid or incurred in connection with investigating, defending or preparing to defend any such action, suit, proceeding (including any inquiry or investigation) or claim (whether or not Silver Point, any Participant or any other such Indemnified Person is a party to any action or proceeding out of which any such expenses arise or such matter is initiated by a third party or by you or any of your affiliates); provided, however, that you shall not have to indemnify any Indemnified Person against any loss, claim, damage, expense or liability (a) to the extent same resulted from the gross negligence or willful misconduct of such Indemnified Person (as determined by a court of competent jurisdiction in a final and non-appealable judgment), (b) for any disputes solely among Indemnified Persons and not arising out of any act or omission of you or any of your subsidiaries or affiliates (other than any proceeding against any Indemnified Person fulfilling its role as agent or any similar role under the Murabaha DIP Facility) or (c) for a material breach of the obligations of such Indemnified Person (or any of such Indemnified Person's controlled affiliates or any of its or their respective officers, directors, employees, agents, controlling persons or members) under this Commitment Letter. Neither Silver Point nor any other Indemnified Person shall be responsible or liable to you or any other person or entity for (x) any determination made by it pursuant to this Commitment Letter in the absence of gross negligence or willful misconduct on the part of such person or entity (as determined by a court of competent jurisdiction in a final and non-appealable judgment), (y) any damages arising from the use by others of information or other materials obtained through electronic, telecommunications or other information transmission systems or (z) any indirect, special, exemplary, incidental, punitive or consequential damages (including, without limitation, any loss of profits, business or anticipated savings) which may be alleged as a result of this Commitment Letter or the financing contemplated hereby.

7. Sharing Information; Absence of Fiduciary Relationship; Affiliate Activities.

Silver Point reserves the right to employ the services of its affiliates in providing the commitments and/or the services contemplated by this Commitment Letter and to allocate, in whole or in part, to its affiliates certain fees payable to Silver Point in such manner as Silver Point and its affiliates may agree in their sole discretion. You acknowledge that (i) Silver Point may share with any of its affiliates, and such affiliates may share with Silver Point, any information related to the Company, or any of the matters contemplated hereby and (ii) Silver Point and its affiliates may be providing debt financing, equity capital or other services (including financial advisory services) to other companies in respect of which you may have conflicting interests regarding the transactions described herein or otherwise. Silver Point will not, however, furnish confidential information obtained from you by virtue of the transactions contemplated by this Commitment Letter, the Fee Letter or its other relationships with you to other companies (other than your and affiliates). You also acknowledge that Silver Point has no obligation to use in connection with the transactions contemplated by this Commitment Letter, or to furnish to you, confidential information obtained by it from other companies.

You further acknowledge and agree that (a) no fiduciary, advisory or agency relationship between you and us is intended to be or has been created in respect of any of the transactions contemplated by this Commitment Letter, irrespective of whether we or our affiliates have advised or are advising you on other matters, (b) we, on the one hand, and you, on the other

hand, have an arms-length business relationship that does not directly or indirectly give rise to, nor do you rely on, any fiduciary duty on our part, (c) you are capable of evaluating and understanding, and you understand and accept, the terms, risks and conditions of the transactions contemplated by this Commitment Letter, (d) you have been advised that we and our affiliates are engaged in a broad range of transactions that may involve interests that differ from your interests and that we and our affiliates have no obligation to disclose such interests and transactions to you by virtue of any fiduciary, advisory or agency relationship, and (e) you waive, to the fullest extent permitted by law, any claims you may have against us or our affiliates for breach of fiduciary duty or alleged breach of fiduciary duty with respect to the Murabaha DIP Facility and agree that we and our affiliates shall have no liability (whether direct or indirect) to you in respect of such a fiduciary duty claim or to any person asserting a fiduciary duty claim on behalf of or in right of you, including your stockholders, employees or creditors.

8. Exclusivity.

You acknowledge and agree that Silver Point has been appointed exclusively to provide and arrange the Murabaha DIP Facility and that the syndication of the Murabaha DIP Facility could be adversely affected if you or any of your affiliates raises, or attempts to raise, other financing prior to the Murabaha DIP Closing Date.

Save as set out below, from the date of acceptance of this Commitment Letter to the Murabaha DIP Closing Date or the termination of this Commitment Letter, you agree that you will not (and will ensure that none of your affiliates, agents, professionals or other representatives will) directly or indirectly raise or attempt to raise any debt financing (including debtor-in-possession financing or any similar transaction) or debt security to be syndicated, issued or privately placed by or on behalf of you or any of your affiliates (and there shall be no announcement, negotiations or discussion of, or any attempt to effect, any such syndication, issue or placement), other than to or with Silver Point or with the prior written consent of Silver Point.

In all events, the agreements in this Section 8 shall not prevent the Company's board of directors (or its equivalent, the "Board") from receiving any unsolicited proposal for debtor-in-possession financing or similar transaction during the Chapter 11 Cases from a third party and negotiating such proposal with a third party and providing due diligence information regarding the Company to such third party if the Board, on advice of its financial and legal advisors, determines (a "Determination") that doing so is reasonably required to comply with its fiduciary duties to the Company; provided that, in the event the Board or the Company receives any proposal, you shall promptly notify Silver Point of such receipt, and promptly deliver to Silver Point copies of all such proposal documents and summaries of any and all oral and other communications between the Company or the Board, on the one hand, and the proposed counterparty under such debtor-in-possession financing or similar transaction on the other, and cooperate with Silver Point in its reasonable requests for further information and communications regarding such proposal.

If the Company or the Board makes a Determination, enters into any transaction or series of transactions (such as raising equity, selling assets or securing other financing) that would render the Murabaha DIP Facility unlikely to be consummated or unnecessary, revises the Budget in such a way (or otherwise makes a determination) that the Company will not borrow

the full amount of the Murabaha DIP Facility (subject to the Company's right to consummate the Murabaha DIP Facility in multiple draws and to make voluntary prepayments as set forth herein), or fails to diligently pursue Bankruptcy Court approval of this Commitment Letter, the Fee Letter or the proposed Murabaha DIP Facility, (i) the Company shall immediately notify Silver Point in writing, and (ii) (a) Silver Point may thereafter terminate this Commitment Letter at any time and (b) the Company may terminate this Commitment Letter at any time after five business days' prior written notice to Silver Point if it has made a Determination and sought Bankruptcy Court approval to execute definitive documentation regarding a fully-financed, alternative debtor-in-possession financing or similar transaction from a creditworthy counterparty not subject to due diligence or credit committee approval, or the Board has determined based upon advice of financial and legal advisors (in respect of a matter other than an alternative debtor-in-possession financing or similar transaction as set forth above) that termination of this Commitment Letter is reasonably required for the Board to comply with its fiduciary duties to the Company, in which case, under the circumstances of either of the immediately preceding clauses (a) or (b), the expense reimbursement described in Section 6 of this Commitment Letter and the portion of the Commitment Fee described in clause (y) of paragraph 1(b) of the Fee Letter will, except if such termination is the result of a material breach by Silver Point, be payable immediately in cash on the date Silver Point or the Company terminates this Commitment Letter, provided, that, with respect to the portion of the Commitment Fee described in clause (y) of paragraph 1(b) of the Fee Letter, if the Company determines (acting reasonably) that it has insufficient funds on hand to immediately pay such portion of the Commitment Fee in cash, such amount shall be payable on the date of the closing of such alternative debtor-in-possession financing or other alternative transaction, if applicable, with the first proceeds of such financing or other transaction.

In any event, for the avoidance of doubt, any accrued and/or earned but unpaid amounts hereunder or under the Fee Letter payable to Silver Point shall have administrative expense priority status in the Chapter 11 Cases of the Debtor Obligors pursuant to section 503(b)(1) of the Bankruptcy Code.

9. Confidentiality.

This Commitment Letter is delivered to you on the understanding that neither this Commitment Letter nor the Fee Letter nor any of their terms or substance shall be disclosed, directly or indirectly, by you to any other person or entity except (a) to your affiliates, officers, directors, employees, attorneys, accountants and advisors who are directly involved in the consideration of this matter and on a confidential and need-to-know basis or (b) as required by applicable law or compulsory legal process or in connection with any pending legal proceeding (in which case you agree, to the extent permitted by applicable law, to inform us promptly thereof) or regulatory review; provided that you may disclose this Commitment Letter and the contents hereof (but you may not disclose the contents of the Fee Letter) to any rating agencies or pursuant to any public filings which in the opinion of your counsel are required pursuant to applicable law. Notwithstanding the foregoing, you shall be permitted, with prior notice to Silver Point, to furnish a copy of this Commitment Letter and the Fee Letter to any committee appointed in the Chapter 11 Case, the joint provisional liquidators appointed in the Cayman Island proceedings of Arcapita Investment Holdings Limited (the "Joint Provisional Liquidators"), the Office of the United States Trustee and such other parties in interest as may be

necessary to obtain the required Bankruptcy Court approvals of the Murabaha DIP Facility and the agreements and obligations related thereto, in all cases on a confidential basis. You may file this Commitment Letter with the Bankruptcy Court and to the court overseeing the Cayman Island proceedings of Arcapita Investment Holdings Limited; you may also file the Fee Letter under seal with either court and may disclose the aggregate fees thereunder, as well as the portion of the Commitment Fee described in clause (y) of section 1(b) of the Fee Letter, on the record in either proceeding.

Silver Point and its affiliates will use all confidential information provided to it or such affiliates by or on behalf of you hereunder solely for the purpose of providing the commitments and services which are the subject of this Commitment Letter and shall treat confidentially all such information and this Commitment Letter and the Fee Letter (and the respective terms and substance set forth herein and therein); provided that nothing herein shall prevent Silver Point from disclosing any such information (a) pursuant to the order of any court or administrative agency or in any pending legal or administrative proceeding, or otherwise as required by applicable law or compulsory legal process (in which case Silver Point, to the extent permitted by law, agrees to inform you promptly thereof), (b) upon the request or demand of any regulatory authority having jurisdiction over Silver Point or any of its affiliates, (c) to the extent that such information becomes publicly available other than by reason of improper disclosure by Silver Point or any of its affiliates, (d) to the extent that such information is received by Silver Point from a third party that is not to its knowledge (after due inquiry) subject to confidentiality obligations to you, (e) to the extent that such information is independently developed by Silver Point without the use of confidential information, (f) to Silver Point's affiliates and their respective employees, legal counsel, independent auditors and other experts or agents who need to know such information and are informed of the confidential nature of such information and without the use of confidential information, (g) to potential Participants or assignees or any potential counterparty (or its advisors) to any swap or derivative transaction relating to the Company or any of its affiliates or any of their respective obligations, in each case who agree in writing to be bound by the terms of this paragraph (or language substantially similar to this paragraph), (h) to the Bankruptcy Court for approval of this Commitment Letter, the Fee Letter and the Murabaha DIP Facility; provided further that such Confidential Information is filed under seal or to any other court of competent jurisdiction for purposes of establishing a "due diligence" defense, provided such information is filed under seal. Silver Point's obligations under this paragraph shall automatically terminate and be superseded by the confidentiality provisions in the Definitive Financing Documentation upon the Murabaha DIP Closing Date.

Silver Point shall have the right to review and approve any public announcement or public filing made by you or your representatives relating to the Murabaha DIP Facility or in connection therewith, before any such announcement or filing is made (such approval not to be unreasonably withheld or delayed). Silver Point shall also have the right to review and approve any public announcement or public filing made by you or your representatives relating to Silver Point before any such announcement or filing is made (such approval not to be unreasonably withheld or delayed).

10. Assignments; Etc.

This Commitment Letter (and your rights and obligations hereunder) shall not be assignable by you without the prior written consent of Silver Point (and any attempted

assignment without such consent shall be null and void), is intended to be solely for the benefit of the parties hereto (and Indemnified Persons), is not intended to confer any benefits upon, or create any rights in favor of, any person other than the parties hereto (and Indemnified Persons) and may not be relied upon by any person or entity other than you.

Silver Point shall not assign its rights hereunder absent the prior written consent of the Company (and any attempted assignment without such consent shall be null and void); provided that such consent shall not be unreasonably withheld and any and all commitments and other obligations of, and services to be provided by Silver Point hereunder may be performed, and any and all rights of Silver Point hereunder may be exercised, by or through any of its affiliates or branches.

11. Amendments; Governing Law; Etc.

This Commitment Letter and the Fee Letter may not be amended or modified, or any provision hereof waived, except by an instrument in writing signed by you and Silver Point. This Commitment Letter and the Fee Letter may be executed in any number of counterparts, each of which shall be an original and all of which, when taken together, shall constitute one agreement. Delivery of an executed signature page of this Commitment Letter or the Fee Letter by facsimile (or other electronic) transmission shall be effective as delivery of a manually executed counterpart hereof. Section headings used herein and in the Fee Letter are for convenience of reference only, are not part of this Commitment Letter or the Fee Letter, as the case may be, and are not to affect the construction of, or to be taken into consideration in interpreting, this Commitment Letter or the Fee Letter, as the case may be. You acknowledge that information and documents relating to the Murabaha DIP Facility may be transmitted through Intralinks, the internet, email or similar electronic transmission systems, and that Silver Point shall not be liable for any damages arising from the use by others of information or documents transmitted in such manner. Silver Point may, in consultation with you, place customary advertisements in financial and other newspapers and periodicals or on a home page or similar place for dissemination of customary information on the Internet or worldwide web as it may choose, and circulate similar promotional materials, after the Murabaha DIP Closing Date in the form of a “tombstone” or otherwise describing the names of the Company and its affiliates (or any of them), and the amount, type and closing date of the transactions contemplated hereby, all at the expense of Silver Point. This Commitment Letter and the Fee Letter set forth the entire agreement between the parties hereto as to the matters set forth herein and supersedes all prior understandings, whether written or oral, between us with respect to the matters herein. Matters that are not covered or made clear in this Commitment Letter or in the Fee Letter are subject to mutual agreement of the parties hereto. **THIS COMMITMENT LETTER AND THE FEE LETTER SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK (WITHOUT REGARD TO THE PRINCIPLES OF CONFLICTS OF LAWS THEREOF, TO THE EXTENT THAT THE SAME ARE NOT MANDATORILY APPLICABLE BY STATUTE AND WOULD REQUIRE OR PERMIT THE APPLICATION OF THE LAW OF ANOTHER JURISDICTION).**

12. Jurisdiction.

Each of the parties hereto hereby irrevocably and unconditionally (a) submits, for itself and its property, to the exclusive jurisdiction of the Bankruptcy Court for the Southern District of New York, and any appellate court from any thereof, in any action or proceeding arising out of or relating to this Commitment Letter or the transactions contemplated hereby, or for recognition or enforcement of any judgment, and agrees that all claims in respect of any such action or proceeding may be heard and determined only in such court, provided, however, that Silver Point shall be entitled to assert jurisdiction over you and your property in any court in which jurisdiction may be laid over you or your property, (b) waives, to the fullest extent it may legally and effectively do so, any objection which it may now or hereafter have to the laying of venue of any suit, action or proceeding arising out of or relating to this Commitment Letter, the Fee Letter or the transactions contemplated hereby or thereby in any New York State or Federal court, as the case may be, (c) waives, to the fullest extent permitted by law, the defense of an inconvenient forum to the maintenance of such action or proceeding in any such court and (d) agrees that a final judgment in any such action or proceeding shall be conclusive and may be enforced in other jurisdictions by suit on the judgment or in any other manner provided by law. Service of any process, summons, notice or document by registered mail or overnight courier addressed to you at the address above shall be effective service of process against you for any suit, action or proceeding brought in any such court.

13. Waiver of Jury Trial.

EACH OF THE PARTIES HERETO IRREVOCABLY WAIVES ANY RIGHT TO TRIAL BY JURY IN ANY ACTION, PROCEEDING, SUIT, CLAIM OR COUNTERCLAIM BROUGHT BY OR ON BEHALF OF ANY PARTY RELATED TO OR ARISING OUT OF THIS COMMITMENT LETTER, THE FEE LETTER OR THE PERFORMANCE OF SERVICES HEREUNDER OR THEREUNDER.

14. Surviving Provisions.

The provisions of Sections 6, 7, 9, 10, 11, 12, 13 and 14 of this Commitment Letter shall remain in full force and effect regardless of whether Definitive Financing Documentation shall be executed and delivered and notwithstanding the termination of this Commitment Letter and our agreements to provide commitments and perform the services described herein; provided that your obligations under this Commitment Letter, other than those provisions relating to confidentiality and the payment of agency fees to Silver Point as provided in the Fee Letter, shall automatically terminate and be superseded by the Definitive Financing Documentation upon the initial funding thereunder and the payment of all amounts owing at such time hereunder and under the Fee Letter.

15. PATRIOT Act Notification.

Silver Point hereby notifies you that pursuant to the requirements of the USA PATRIOT Act, Title III of Pub. L. 107-56 (signed into law October 26, 2001) (the "PATRIOT Act"), Silver Point is required to obtain, verify and record information that identifies the Company under the Murabaha DIP Facility, which information includes the name, address, tax identification number and other information regarding the Company that will allow Silver Point to identify the

To the extent the transactions contemplated herein have not been consummated, (x) Silver Point shall have the right to terminate its agreement to provide commitments and perform the services described herein by giving written notice to you (without further action or notice and without further obligation to you) (a) immediately, if the Company or the Board, for any reason, determines not to pursue Bankruptcy Court approval of the proposed Murabaha DIP Facility, or (b) any time after the later of (i) October 15, 2012 or (ii) 21 days after the Company has been notified in writing that the conditions precedent set forth in Sections 5(a) and 5(b) above have been satisfied; provided that, in no case may Silver Point terminate if such failure to meet one of the foregoing deadlines is a sole and direct consequence of Silver Point's material breach of its material obligations hereunder, and (y) you have the right to terminate this Commitment Letter by giving written notice to Silver Point (without further action or notice and without further obligation to Silver Point) if Silver Point is in material breach of its material obligations hereunder.

If the foregoing correctly sets forth our agreement with you, please indicate your acceptance of the terms of this Commitment Letter by returning to us executed counterparts hereof and of the Fee Letter not later than 11:59 P.M., New York City time, on October 9, 2012. Silver Point's agreement to provide commitments and perform the services described herein, will expire automatically (and without further action or notice and without further obligation to you) at such time in the event that we have not received such executed counterparts in accordance with the immediately preceding sentence.

Capitalized terms used in this Exhibit B but not defined herein shall have the meanings set forth in the commitment letter to which this Exhibit B is attached (the “Commitment Letter”) and in the other Exhibits to the Commitment Letter. In the case of any such capitalized term that is subject to multiple and differing definitions, the appropriate meaning thereof in this Exhibit B shall be determined by reference to the context in which it is used.

The transactions under the Murabaha DIP Facility on the Murabaha DIP Closing Date shall be subject to the following additional conditions precedent:¹⁶

1. Murabaha DIP Facility Documentation: The execution and delivery of definitive collateral and other credit documentation consistent with the terms of the Commitment Letter and the Murabaha DIP Term Sheet, in each case prepared by counsel to Silver Point and otherwise satisfactory to Silver Point (the “Definitive Financing Documentation”).
2. Murabaha DIP Order: The Murabaha DIP Order shall have been entered by the Bankruptcy Court on or prior to November 30, 2012 and shall be in full force and effect and unstayed.
3. Budget; Financial Statements: The Participants shall have received copies of (i) a 13-week cash flow forecast prepared by AIHL (as supplemented from time to time in accordance with the Murabaha DIP Facility, the “Budget”) in form and substance satisfactory to Silver Point and (ii) such historical and pro forma financial statements with respect to such periods as Silver Point may reasonably request, all of the foregoing to be in form and substance reasonably satisfactory to Silver Point.
4. Shari’ah Board Approval: The Obligors’ “Shari’ah Advisory Board” shall approve the execution of the Murabaha DIP Facility and the finance documents and issue a “Fatwa” that the Murabaha DIP Facility and the finance documents are in compliance with Shari’ah principles, as well as related Shari’ah compliance representations, warranties and covenants.
5. Intercreditor Arrangements: Intercreditor arrangements with or among Silver Point, the Company and/or third parties shall be in form and substance satisfactory to Silver Point.
6. Opinion from Third Party Shari’ah Consultant: The Participants shall have received an opinion from a third party Shari’ah consultant reasonably satisfactory to Silver Point.

¹⁶ These conditions precedent also apply to any draws that occur after the Murabaha DIP Closing Date to the extent such conditions precedent are applicable.

7. No Material Adverse Effect: Since the date of the Murabaha DIP Commitment Letter, nothing shall have occurred and Silver Point and the Participants shall not have become aware of any facts or conditions not previously known which has had, or could reasonably be expected to have, a material adverse effect, provided that the continuation of the Chapter 11 Cases shall not constitute a material adverse effect.
8. Fees and Expenses: All reasonable and documented costs, fees, expenses (including, without limitation, legal fees and expenses and the fees and expenses of any third party Shari'ah consultant and the fees, costs and expenses of the commodity brokers, to the extent the foregoing are reasonable and documented) and other compensation contemplated by the Fee Letter and herein, payable to Silver Point and the Participants or otherwise payable, shall have been paid to the extent due.
9. Events of Default: There shall exist no default or Event of Default (including, without limitation, with respect to the collateral value coverage covenant).
10. Representations and Warranties: All representations and warranties contained in the Commitment Letter, the Murabaha DIP Term Sheet and the Definitive Credit Documentation shall be true and correct in all material respects.
11. Miscellaneous: The Participants shall have received (x) legal opinions from counsel (including, without limitation, New York counsel) covering matters reasonably acceptable to Silver Point and (y) appropriate officer certifications relating to closing conditions and items to be delivered in connection therewith.

DUE DILIGENCE TOPICS

The due diligence topics listed below are high priority matters. However, Silver Point's diligence requests may be broader. Silver Point reserves its rights to request additional information in connection with its diligence efforts pursuant to the Commitment Letter.

Jill, (iii) Honiton, (iv) Arcapita European Industrial I, (v) Arcapita European Industrial II, (vi) Arcapita European Industrial Yielding I, (vii) Viridian, (viii) US Senior Living (Fountains), (ix) Lusail and (x) such other subsidiaries of Arcapita Bank B.S.C.(c) identified as material as a result of confirmatory due diligence (each of the entities described in clauses (i) – (x) an "Arcapita Company"), Silver Point requests confirmatory diligence with respect to each of the following:

1. Economic rights and obligations of each Arcapita Company, including, without limitation, confirmation of the distribution waterfalls and payment of management fees;
2. The governance and voting rights of each Arcapita Company;
3. Ownership of the collateral and material assets held by the Obligor as well as each Arcapita Company that is not an Obligor, including, in each case, applicable valuations;
4. Liens, restrictions, rights and other obligations with respect to a transfer, disposition or pledge of any Arcapita Company's capital stock or assets (including, for the avoidance of doubt, information regarding any limitations on establishing, or requirement to subordinate, the DIP Collateral package for the proposed transaction); and
5. Rights of third parties potentially triggered by the filing by the Company Group of the chapter 11 cases pending in the U.S. Bankruptcy Court for the Southern District of New York, Case No. 12-11076 and/or the Proposed Transaction, including, but not limited to, technical defaults, litigations, notice requirements, potential change of control or termination rights or obligations.

Commitment Letter

Ladies and Gentlemen:

You have advised Silver Point Finance, LLC (“Silver Point”, “we” or “us”) that you have filed separate voluntary petitions for yourself and certain of your subsidiaries (excluding Falcon Gas Storage Company, Inc., the “Company”)¹ for reorganization under Chapter 11 of the U.S. Bankruptcy Code with the United States Bankruptcy Court for the Southern District of New York (the “Bankruptcy Court”), Case No. 12-11076 (the “Chapter 11 Cases”) and that you will require a Shari’ah-compliant term Murabaha debtor-in-possession facility (the “Murabaha DIP Facility”) in order to finance the Company’s operations, including on-going operating costs, general corporate purposes, certain investment deal fundings, and bankruptcy-related costs during the Company’s chapter 11 proceedings. Capitalized terms used but not defined herein shall have the meaning assigned to such term in the Murabaha DIP Facility term sheet (“Murabaha DIP Term Sheet”) attached hereto as Exhibit A.

¹ The exclusion of Falcon Gas Storage Company, Inc. and any non-Debtor affiliates remains subject to due diligence.

This Commitment Letter (defined below) and the Murabaha DIP Term Sheet describe terms and conditions under which Silver Point currently would propose to provide to the Company \$150,000,000 (the “Facility Amount”) under the Murabaha DIP Facility.²

This Commitment Letter and the related fee letter of even date herewith (the “Fee Letter”) set forth the entire agreement between the parties hereto as to the matters set forth herein and therein and supersede all prior understandings, whether written or oral, between us with respect to the matters herein and therein (including the Commitment Letter and Fee Letter dated September 25, 2012). Please note that those matters that are not covered or made clear herein, in the Murabaha DIP Term Sheet or the ~~related fee letter of even date herewith (the “Fee Letter”)~~ are subject to mutual agreement of the parties hereto.

1. Commitments.

In connection with the foregoing, Silver Point is pleased to advise you of its commitment to provide 100% of the commitments under the Murabaha DIP Facility, upon the terms and subject to the conditions set forth or referred to in this commitment letter (together with the Murabaha DIP Term Sheet, this “Commitment Letter”) and in the Fee Letter. Silver Point agrees to conduct its due diligence under Section 5(a) below and to negotiate Definitive Financing Documentation (as defined in Exhibit B hereto) in a commercially reasonable manner after the entering of an order in form and substance reasonably acceptable to Silver Point by the Bankruptcy Court approving Sections 6 and 8 this Commitment Letter and Sections 1(a) and 1(b) of the Fee Letter; provided that, if Silver Point determines in good faith that the Company will not be required to reimburse it for fees and expenses due pursuant to the conditions set forth in Section 6 below, Silver Point shall not be required to continue such due diligence or negotiate Definitive Financing Documentation. Subject to the date hereof, from the date of acceptance of this Commitment Letter to the Murabaha DIP Closing Date or the termination of this Commitment Letter, you agree to diligently pursue Bankruptcy Court approval of this Commitment Letter and the Fee Letter, and the proposed Murabaha DIP Facility.

2. Titles and Roles.

Silver Point shall have the right (in consultation with you) to award such roles or titles as may be reasonably determined by Silver Point, to one or more other banks, financial institutions and other institutional lenders or affiliates thereof (together the “Participants”), in each case as determined by Silver Point. You agree that, except as contemplated above, no other agents, co-agents or arrangers will be appointed, no other titles will be awarded and no compensation (other than that expressly contemplated by this Commitment Letter and Definitive Financing Documentation) will be paid in connection with the Murabaha DIP Facility, unless you and we shall so agree.

² Silver Point will agree, if requested, to a multiple draw facility (with no more than four draws and a minimum draw of \$25,000,000 (or greater amounts in \$5,000,000 increments)), provided that all fees (other than the Unused Line Fee) calculated as a percentage of the full amount of the Murabaha DIP Facility are payable on the full amount of the Murabaha DIP Facility (i.e., \$150,000,000) as set forth herein. If the Murabaha DIP Facility becomes a multiple draw facility, the conditions precedent set forth in the Term Sheet and in Exhibit B shall also apply to any draws that occur after the Murabaha DIP Closing Date to the extent such conditions precedent are applicable.

3. Additional Participants.

In our sole discretion, we may commence our efforts to bring in additional Participants with respect to the Murabaha DIP Facility promptly upon your execution and delivery to us of this Commitment Letter. Timing for this, potential Participants to be approached, titles, allocations and division of fees, shall be determined by (and coordinated exclusively through) Silver Point in consultation with you. You agree actively to assist us in this process in a manner that is reasonably satisfactory to us.

4. Information.

You represent, warrant and covenant that (a)(i) no information which has been or is hereafter furnished by you or on your behalf in connection with the Murabaha DIP Facility including, without limitation, information provided in response to the diligence requests set forth on Exhibit C hereto and other confirmatory due diligence (other than the estimates, forecasts, projections and other forward-looking financial information regarding the future performance of the Company (collectively, the “Projections”)) and (ii) no other information supplied or approved by you or on your behalf (other than the Projections) (such written information and other information being referred to herein collectively as the “Information”), taken as a whole contained (or, in the case of Information furnished after the date hereof, will contain), as of the time it was (or hereafter is) furnished, any material misstatement of fact or omitted (or will omit) as of such time to state any material fact necessary to make the statements therein taken as a whole not misleading, in the light of the circumstances under which they were (or hereafter are) made and (b) the Projections that have been or will be made available to us by you or any of your representatives have been or will be prepared in good faith based upon assumptions that you believe to be reasonable at the time made and at the time such Projections are made available to us, it being recognized by the Participants and Silver Point that such Projections are not to be viewed as facts and that actual results during the period or periods covered by any such Projections may differ significantly from the projected results, and that no assurance can be given that the projected results will be realized. You understand that, in arranging the Murabaha DIP Facility, we will be entitled to use and rely on the Information and the Projections without responsibility for independent verification thereof.

5. Conditions Precedent.

Silver Point’s agreement to provide commitments and agreements described herein, is subject to:

(a) Silver Point’s completion of its business, legal, tax, financial, and accounting due diligence with respect to the Murabaha DIP Facility and the Company including, without limitation, due diligence with regards to the high priority matters as set forth on Exhibit C hereto and confirmatory due diligence, in each case, to Silver Point’s full satisfaction with the results thereof;

(b) approval of this Commitment Letter and the Murabaha DIP Facility by Silver Point’s credit committee;

(c) Silver Point not becoming aware (whether as a result of its due diligence analyses and review or otherwise), after Silver Point has notified you in writing that the conditions precedent set forth in Sections 5(a) and 5(b) above have been satisfied, of any information not previously known to Silver Point which is materially negative information with respect to the property, assets, business, operations, liabilities, condition (financial or otherwise) or prospects of the Company, or which is inconsistent in a material and adverse manner with any such information or other matter disclosed to Silver Point prior to the satisfaction of the conditions precedent set forth in Sections 5(a) and 5(b) above;

(d) your written acceptance of, and compliance with, the terms and conditions, of the Fee Letter and pursuant to which you agree to pay, or cause to be paid, to Silver Point certain fees and expenses and to fulfill certain other obligations including the reimbursement of expenses as provided in this Commitment Letter;

(e) the other conditions set forth or referred to in the Murabaha DIP Term Sheet or, when executed, the Definitive Financing Documentation;

(f) the Company having reasonably cooperated with Silver Point in arranging the Murabaha DIP Facility, including, without limitation, by promptly providing Silver Point with all information reasonably deemed necessary by it in order to bring in additional Participants; and

(g) satisfaction of the conditions precedent set forth on Exhibit B hereto.

6. Expenses; Indemnification.

To induce Silver Point to issue this Commitment Letter and to proceed with the Definitive Financing Documentation, you hereby agree that all reasonable and documented fees and expenses incurred prior to the date of the termination of this Commitment Letter (including the reasonable and documented fees and expenses of counsel and consultants) of Silver Point and its affiliates arising in connection with this Commitment Letter and the Murabaha DIP Facility and the preparation, negotiation, execution, delivery and enforcement of this Commitment Letter, the Fee Letter and the Definitive Financing Documentation (including in connection with our due diligence and syndication efforts), whether incurred before, on, or after the date hereof, shall be for your account (and that you shall, on demand, reimburse Silver Point and its affiliates for any reasonable and documented out-of-pocket outstanding and unreimbursed fees and expenses paid or incurred by them), whether or not the Murabaha DIP Facility is made available or the Definitive Financing Documentation is executed. Notwithstanding anything set forth herein, until Silver Point has notified you that the conditions precedent set forth in Sections 5(a) and 5(b) below have been satisfied, your obligation to reimburse the reasonable and documented fees and expenses of Silver Point shall be subject to a cap of \$900,000. In all instances, prior to payment of any expense reimbursement, the Committee and the Debtors shall have three days after Committee counsel's receipt of any related invoice to review such invoice and serve the Debtors and Silver Point with notice of any objection setting forth the amount of costs or expenses to which the Committee or the Debtors, as applicable, objects, consistent with the Bankruptcy Court's Order Approving Expense Reimbursement in Connection with

Prospective Post-Petition Financing [Docket No. 500] in the Chapter 11 Cases. You further, jointly and severally, agree to indemnify and hold harmless Silver Point, each Participant, and their respective affiliates and each director, officer, employee, representative and agent thereof (each, an “Indemnified Person”) from and against any and all actions, suits, proceedings (including any investigations or inquiries), claims, losses, damages, liabilities or expenses of any kind or nature whatsoever which may be incurred by or asserted against or involve Silver Point, any Participant or any other such Indemnified Person as a result of or arising out of or in any way related to or resulting from (i) this Commitment Letter, the Definitive Financing Documentation, or any related transaction or (ii) the use or the contemplated use of the proceeds of the Murabaha DIP Facility and, upon demand, to pay and reimburse Silver Point, each Participant and each other Indemnified Person for any reasonable legal or other out-of-pocket expenses paid or incurred in connection with investigating, defending or preparing to defend any such action, suit, proceeding (including any inquiry or investigation) or claim (whether or not Silver Point, any Participant or any other such Indemnified Person is a party to any action or proceeding out of which any such expenses arise or such matter is initiated by a third party or by you or any of your affiliates); provided, however, that you shall not have to indemnify any Indemnified Person against any loss, claim, damage, expense or liability (a) to the extent same resulted from the gross negligence or willful misconduct of such Indemnified Person (as determined by a court of competent jurisdiction in a final and non-appealable judgment), (b) for any disputes solely among Indemnified Persons and not arising out of any act or omission of you or any of your subsidiaries or affiliates (other than any proceeding against any Indemnified Person fulfilling its role as agent or any similar role under the Murabaha DIP Facility) or (c) for a material breach of the obligations of such Indemnified Person (or any of such Indemnified Person’s controlled affiliates or any of its or their respective officers, directors, employees, agents, controlling persons or members) under this Commitment Letter. Neither Silver Point nor any other Indemnified Person shall be responsible or liable to you or any other person or entity for (x) any determination made by it pursuant to this Commitment Letter in the absence of gross negligence or willful misconduct on the part of such person or entity (as determined by a court of competent jurisdiction in a final and non-appealable judgment), (y) any damages arising from the use by others of information or other materials obtained through electronic, telecommunications or other information transmission systems or (z) any indirect, special, exemplary, incidental, punitive or consequential damages (including, without limitation, any loss of profits, business or anticipated savings) which may be alleged as a result of this Commitment Letter or the financing contemplated hereby.

7. Sharing Information; Absence of Fiduciary Relationship; Affiliate Activities.

Silver Point reserves the right to employ the services of its affiliates in providing the commitments and/or the services contemplated by this Commitment Letter and to allocate, in whole or in part, to its affiliates certain fees payable to Silver Point in such manner as Silver Point and its affiliates may agree in their sole discretion. You acknowledge that (i) Silver Point may share with any of its affiliates, and such affiliates may share with Silver Point, any information related to the Company, or any of the matters contemplated hereby and (ii) Silver Point and its affiliates may be providing debt financing, equity capital or other services (including financial advisory services) to other companies in respect of which you may have conflicting interests regarding the transactions described herein or otherwise. Silver Point will not, however, furnish confidential information obtained from you by virtue of the transactions

contemplated by this Commitment Letter, the Fee Letter or its other relationships with you to other companies (other than you and affiliates). You also acknowledge that Silver Point has no obligation to use in connection with the transactions contemplated by this Commitment Letter, or to furnish to you, confidential information obtained by it from other companies.

You further acknowledge and agree that (a) no fiduciary, advisory or agency relationship between you and us is intended to be or has been created in respect of any of the transactions contemplated by this Commitment Letter, irrespective of whether we or our affiliates have advised or are advising you on other matters, (b) we, on the one hand, and you, on the other hand, have an arms-length business relationship that does not directly or indirectly give rise to, nor do you rely on, any fiduciary duty on our part, (c) you are capable of evaluating and understanding, and you understand and accept, the terms, risks and conditions of the transactions contemplated by this Commitment Letter, (d) you have been advised that we and our affiliates are engaged in a broad range of transactions that may involve interests that differ from your interests and that we and our affiliates have no obligation to disclose such interests and transactions to you by virtue of any fiduciary, advisory or agency relationship, and (e) you waive, to the fullest extent permitted by law, any claims you may have against us or our affiliates for breach of fiduciary duty or alleged breach of fiduciary duty with respect to the Murabaha DIP Facility and agree that we and our affiliates shall have no liability (whether direct or indirect) to you in respect of such a fiduciary duty claim or to any person asserting a fiduciary duty claim on behalf of or in right of you, including your stockholders, employees or creditors.

8. Exclusivity.

You acknowledge and agree that Silver Point has been appointed exclusively to provide and arrange the Murabaha DIP Facility and that the syndication of the Murabaha DIP Facility could be adversely affected if you or any of your affiliates raises, or attempts to raise, other financing prior to the Murabaha DIP Closing Date.

Save as set out below, from the date of acceptance of this Commitment Letter to the Murabaha DIP Closing Date or the termination of this Commitment Letter, you agree that you will not (and will ensure that none of your affiliates, agents, professionals or other representatives will) directly or indirectly raise or attempt to raise any debt financing (including debtor-in-possession financing or any similar transaction) or debt security to be syndicated, issued or privately placed by or on behalf of you or any of your affiliates (and there shall be no announcement, negotiations or discussion of, or any attempt to effect, any such syndication, issue or placement), other than to or with Silver Point or with the prior written consent of Silver Point.

In all events, the agreements in this Section 8 shall not prevent the Company's board of directors (or its equivalent, the "Board") from receiving any unsolicited proposal for debtor-in-possession financing or similar transaction during the Chapter 11 Cases from a third party and negotiating such proposal with a third party and providing due diligence information regarding the Company to such third party if the Board, on advice of its financial and legal advisors, determines (a "Determination") that doing so is reasonably required to comply with its fiduciary duties to the Company; provided that, in the event the Board or the Company receives any proposal, you shall promptly notify Silver Point of such receipt, and promptly deliver to

Silver Point copies of all such proposal documents and summaries of any and all oral and other communications between the Company or the Board, on the one hand, and the proposed counterparty under such debtor-in-possession financing or similar transaction on the other, and cooperate with Silver Point in its reasonable requests for further information and communications regarding such proposal; ~~and provided further that if~~.

If the Company or the Board makes a Determination, enters into any transaction or series of transactions (such as raising equity, selling assets or securing other financing) that would render the Murabaha DIP Facility unlikely to be consummated or unnecessary, revises the Budget in such a way (or otherwise makes a determination) that the Company will not borrow the full amount of the Murabaha DIP Facility (subject to the Company's right to consummate the Murabaha DIP Facility in multiple draws and to make voluntary prepayments as set forth herein), or fails to diligently pursue Bankruptcy Court approval of this Commitment Letter, the Fee Letter or the proposed Murabaha DIP Facility, (i) the Company shall immediately notify Silver Point in writing, and (ii) (a) Silver Point may thereafter terminate this Commitment Letter at any time and (b) the Company may terminate this Commitment Letter at any time after five business days' prior written notice to Silver Point if it has made a Determination and sought Bankruptcy Court approval to execute definitive documentation regarding a fully-financed, alternative debtor-in-possession financing or similar transaction from a creditworthy counterparty not subject to due diligence or credit committee approval ~~if, or~~ the Board has determined based upon advice of financial ~~&~~ and legal advisors (in respect of a matter other than an alternative debtor-in-possession financing or similar transaction as set forth above) that termination of this Commitment Letter ~~under such circumstance~~ is reasonably required for the Board to comply with its fiduciary duties to the Company, in which case, under the circumstances of either of the immediately preceding clauses (a) or (b), the expense reimbursement described in Section 6 of this Commitment Letter and the portion of the Commitment Fee described in clause (y) of paragraph 1(b) of the Fee Letter will, except if such termination is the result of a material breach by Silver Point, be payable immediately in cash on the date Silver Point or the Company terminates this Commitment Letter, provided, that, with respect to the portion of the Commitment Fee described in clause (y) of paragraph 1(b) of the Fee Letter, if the Company determines (acting reasonably) that it has insufficient funds on hand to immediately pay such portion of the Commitment Fee in cash, such amount shall be payable on the date of the closing of such alternative debtor-in-possession financing or other ~~similar~~ alternative transaction, if applicable, with the first proceeds of such financing or other transaction, ~~and, in,~~

In any event, for the avoidance of doubt, any accrued and/or earned but unpaid amounts hereunder or under the Fee Letter payable to Silver Point shall have administrative expense priority status in the Chapter 11 Cases of the Debtor Obligors pursuant to section 503(b)(1) of the Bankruptcy Code.

9. Confidentiality.

This Commitment Letter is delivered to you on the understanding that neither this Commitment Letter nor the Fee Letter nor any of their terms or substance shall be disclosed, directly or indirectly, by you to any other person or entity except (a) to your affiliates, officers, directors, employees, attorneys, accountants and advisors who are directly involved in the

consideration of this matter and on a confidential and need-to-know basis or (b) as required by applicable law or compulsory legal process or in connection with any pending legal proceeding (in which case you agree, to the extent permitted by applicable law, to inform us promptly thereof) or regulatory review; provided that you may disclose this Commitment Letter and the contents hereof (but you may not disclose the contents of the Fee Letter) to any rating agencies or pursuant to any public filings which in the opinion of your counsel are required pursuant to applicable law. Notwithstanding the foregoing, you shall be permitted, with prior notice to Silver Point, to furnish a copy of this Commitment Letter and the Fee Letter to any committee appointed in the Chapter 11 Case, the joint provisional liquidators appointed in the Cayman Island proceedings of Arcapita Investment Holdings Limited (the “Joint Provisional Liquidators”), the Office of the United States Trustee and such other parties in interest as may be necessary to obtain the required Bankruptcy Court approvals of the Murabaha DIP Facility and the agreements and obligations related thereto, in all cases on a confidential basis. You may file this Commitment Letter with the Bankruptcy Court and to the court overseeing the Cayman Island proceedings of Arcapita Investment Holdings Limited; you may also file the Fee Letter under seal with either court and may disclose the aggregate fees thereunder, as well as the portion of the Commitment Fee described in clause (y) of section 1(b) of the Fee Letter, on the record in either proceeding.

Silver Point and its affiliates will use all confidential information provided to it or such affiliates by or on behalf of you hereunder solely for the purpose of providing the commitments and services which are the subject of this Commitment Letter and shall treat confidentially all such information and this Commitment Letter and the Fee Letter (and the respective terms and substance set forth herein and therein); provided that nothing herein shall prevent Silver Point from disclosing any such information (a) pursuant to the order of any court or administrative agency or in any pending legal or administrative proceeding, or otherwise as required by applicable law or compulsory legal process (in which case Silver Point, to the extent permitted by law, agrees to inform you promptly thereof), (b) upon the request or demand of any regulatory authority having jurisdiction over Silver Point or any of its affiliates, (c) to the extent that such information becomes publicly available other than by reason of improper disclosure by Silver Point or any of its affiliates, (d) to the extent that such information is received by Silver Point from a third party that is not to its knowledge (after due inquiry) subject to confidentiality obligations to you, (e) to the extent that such information is independently developed by Silver Point without the use of confidential information, (f) to Silver Point’s affiliates and their respective employees, legal counsel, independent auditors and other experts or agents who need to know such information and are informed of the confidential nature of such information and without the use of confidential information, (g) to potential Participants or assignees or any potential counterparty (or its advisors) to any swap or derivative transaction relating to the Company or any of its affiliates or any of their respective obligations, in each case who agree in writing to be bound by the terms of this paragraph (or language substantially similar to this paragraph), (h) to the Bankruptcy Court for approval of this Commitment Letter, the Fee Letter and the Murabaha DIP Facility; provided further that such Confidential Information is filed under seal or to any other court of competent jurisdiction for purposes of establishing a “due diligence” defense, provided such information is filed under seal. Silver Point shall have the right to review and approve any public announcement or public filing made by you or your representatives relating to the Murabaha DIP Facility or in connection therewith, before any such announcement or filing is made (such approval not to be unreasonably withheld or delayed). Silver Point shall also have the right to review and approve any public announcement or public filing made by you or your representatives relating to Silver Point before any such announcement or filing is made (such approval not to be unreasonably withheld or delayed).

10. Assignments; Etc.

This Commitment Letter (and your rights and obligations hereunder) shall not be assignable by you without the prior written consent of Silver Point (and any attempted assignment without such consent shall be null and void), is intended to be solely for the benefit of the parties hereto (and Indemnified Persons), is not intended to confer any benefits upon, or create any rights in favor of, any person other than the parties hereto (and Indemnified Persons) and may not be relied upon by any person or entity other than you.

Silver Point shall not assign its rights hereunder absent the prior written consent of the Company (and any attempted assignment without such consent shall be null and void); provided that such consent shall not be unreasonably withheld and any and all commitments and other obligations of, and services to be provided by Silver Point hereunder may be performed, and any and all rights of Silver Point hereunder may be exercised, by or through any of its affiliates or branches.

11. Amendments; Governing Law; Etc.

This Commitment Letter and the Fee Letter may not be amended or modified, or any provision hereof waived, except by an instrument in writing signed by you and Silver Point. This Commitment Letter and the Fee Letter may be executed in any number of counterparts, each of which shall be an original and all of which, when taken together, shall constitute one agreement. Delivery of an executed signature page of this Commitment Letter or the Fee Letter by facsimile (or other electronic) transmission shall be effective as delivery of a manually executed counterpart hereof. Section headings used herein and in the Fee Letter are for convenience of reference only, are not part of this Commitment Letter or the Fee Letter, as the case may be, and are not to affect the construction of, or to be taken into consideration in interpreting, this Commitment Letter or the Fee Letter, as the case may be. You acknowledge that information and documents relating to the Murabaha DIP Facility may be transmitted through Intralinks, the internet, email or similar electronic transmission systems, and that Silver Point shall not be liable for any damages arising from the use by others of information or documents transmitted in such manner. Silver Point may, in consultation with you, place customary advertisements in financial and other newspapers and periodicals or on a home page or similar place for dissemination of customary information on the Internet or worldwide web as it may choose, and circulate similar promotional materials, after the Murabaha DIP Closing Date in the form of a “tombstone” or otherwise describing the names of the Company and its affiliates (or any of them), and the amount, type and closing date of the transactions contemplated hereby, all at the expense of Silver Point. This Commitment Letter and the Fee Letter set forth the entire

agreement between the parties hereto as to the matters set forth herein and supersedes all prior understandings, whether written or oral, between us with respect to the matters herein. 14. Surviving Provisions.

The transactions under the Murabaha DIP Facility on the Murabaha DIP Closing Date shall be subject to the following additional conditions precedent:¹⁶

1. Murabaha DIP Facility Documentation: The execution and delivery of definitive collateral and other credit documentation consistent with the terms of the Commitment Letter and the Murabaha DIP Term Sheet, in each case prepared by counsel to Silver Point and otherwise satisfactory to Silver Point (the “Definitive Financing Documentation”).
2. Murabaha DIP Order: The Murabaha DIP Order shall have been entered by the Bankruptcy Court on or prior to November 30, 2012 and shall be in full force and effect and unstayed.
3. Budget; Financial Statements: The Participants shall have received copies of (i) a 13-week cash flow forecast prepared by AIHL (as supplemented from time to time in accordance with the Murabaha DIP Facility, the “Budget”) in form and substance satisfactory to Silver Point and (ii) such historical and pro forma financial statements with respect to such periods as Silver Point may reasonably request, all of the foregoing to be in form and substance reasonably satisfactory to Silver Point.
4. Shari’ah Board Approval: The Obligors’ “Shari’ah Advisory Board” shall approve the execution of the Murabaha DIP Facility and the finance documents and issue a “Fatwa” that the Murabaha DIP Facility and the finance documents are in compliance with Shari’ah principles, as well as related Shari’ah compliance representations, warranties and covenants.
5. Intercreditor Arrangements Intercreditor arrangements with or among Silver Point, the Company and/or third parties shall be in form and substance satisfactory to Silver Point.
6. Opinion from Third Party Shari’ah Consultant The Participants shall have received an opinion from a third party Shari’ah consultant reasonably satisfactory to Silver Point.
7. No Material Adverse Since the date of the Murabaha DIP Commitment Letter, nothing shall

Effect: have occurred and Silver Point and the Participants shall not have become aware of any facts or conditions not previously known which has had, or could reasonably be expected to have, a material adverse effect, provided that the continuation of the Chapter 11 Cases shall not constitute a material adverse effect.

8. Fees and Expenses: All reasonable and documented costs, fees, expenses (including, without limitation, legal fees and expenses and the fees and expenses of any third party Shari'ah consultant and the fees, costs and expenses of the commodity brokers, to the extent the foregoing are reasonable and documented) and other compensation contemplated by the Fee Letter and herein, payable to Silver Point and the Participants or otherwise payable, shall have been paid to the extent due.

9. Events of Default: There shall exist no default or Event of Default (including, without limitation, with respect to the collateral value coverage covenant).

10. Representations and Warranties: All representations and warranties contained in the Commitment Letter, the Murabaha DIP Term Sheet and the Definitive Credit Documentation shall be true and correct in all material respects.

11. Miscellaneous: The Participants shall have received (x) legal opinions from counsel (including, without limitation, New York counsel) covering matters reasonably acceptable to Silver Point and (y) appropriate officer certifications relating to closing conditions and items to be delivered in connection therewith.

DUE DILIGENCE TOPICS

The due diligence topics listed below are high priority matters. However, Silver Point's diligence requests may be broader. Silver Point reserves its rights to request additional information in connection with its diligence efforts pursuant to the Commitment Letter.

With respect to (i) Freightliner, (ii) J. Jill, (iii) Honiton, (iv) Arcapita European Industrial I, (v) Arcapita European Industrial II, (vi) Arcapita European Industrial Yielding I, (vii) Viridian, (viii) US Senior Living (Fountains), (ix) Lusail and (x) such other subsidiaries of Arcapita Bank B.S.C.(c) identified as material as a result of confirmatory due diligence (each of the entities described in clauses (i) – (x) an "Arcapita Company"), Silver Point requests confirmatory diligence with respect to each of the following:

1. Economic rights and obligations of each Arcapita Company, including, without limitation, confirmation of the distribution waterfalls and payment of management fees;
2. The governance and voting rights of each Arcapita Company;
3. Ownership of the collateral and material assets held by the Obligor as well as each Arcapita Company that is not an Obligor, including, in each case, applicable valuations;
4. Liens, restrictions, rights and other obligations with respect to a transfer, disposition or pledge of any Arcapita Company's capital stock or assets (including, for the avoidance of doubt, information regarding any limitations on establishing, or requirement to subordinate, the DIP Collateral package for the proposed transaction); and
5.
