**AMENDED DECLARATION OF JEFFREY S. STEIN OF
THE GARDEN CITY GROUP, INC. CERTIFYING THE
METHODOLOGY FOR THE TABULATION OF VOTES ON AND
RESULTS OF VOTING WITH RESPECT TO THE SECOND AMENDED
JOINT PLAN OF REORGANIZATION OF ARCAPITA BANK B.S.C.(C) AND
RELATED DEBORS UNDER CHAPTER 11 OF THE BANKRUPTCY CODE**

INTRODUCTION

1. I am the National Solicitation Consultant for The Garden City Group, Inc. (“**GCG**”), the claims, noticing and solicitation agent for the debtors and debtors-in-possession (the “**Debtors**”) in the above-captioned proceeding and have personal knowledge of the facts set forth herein. GCG is a bankruptcy and class action settlement administration firm headquartered in Lake Success, New York. On April 19, 2012, the Bankruptcy Court entered a Final Order Authorizing and Approving the Employment and Retention of GCG, Inc. as Administrative Agent for the Debtors and Debtors in Possession *nunc pro tunc* to the Petition Date (the “**Retention Order**”) (Docket No. 83).

2. On April 25, 2013, the Debtors filed with the Bankruptcy Court the Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors under Chapter 11 of the Bankruptcy Code (Docket No. 1036) (as amended, supplemented, or otherwise modified, the “**Plan**”) and the Second Amended Disclosure Statement in Support of the Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors under Chapter 11 of the Bankruptcy Code (Docket No. 1038) (as amended, supplemented, or otherwise modified, the “**Disclosure Statement**”)

3. On April 26, 2013, the Bankruptcy Court entered the Order (I) Approving the Disclosure Statement and the Form and Manner of Notice of the Disclosure Statement Hearing, (II) Establishing Solicitation and Voting Procedures, (III) Scheduling a Confirmation Hearing, and (IV) Establishing Notice and Objection Procedures for Confirmation of the Debtors’ Joint Chapter 11 Plan (Docket No. 1045) (the “**Solicitation Procedures Order**”), governing, among other things, the solicitation of votes to accept or reject the Plan from the following classes (the “**Voting Classes**”):

4. On June 3, 2013, GCG filed the Declaration of Jeffrey S. Stein of The Garden City Group, Inc. Certifying the Methodology for the Tabulation of Votes on and Results of Voting with Respect to the Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors Under Chapter 11 of the Bankruptcy Code (the “**Original Declaration**”). This Amended Declaration was occasioned by GCG’s receipt of a Ballot from SCB, the anticipated receipt of which is referenced in footnote 5 of the Original Declaration.

MAILING OF SOLICITATION MATERIALS

5. On or before May 2, 2013 (the “**Solicitation Mailing Date**”), in accordance with the Solicitation Procedures Order and at the direction of Gibson, Dunn & Crutcher LLP (“**Gibson Dunn**”), counsel for the Debtors, GCG caused a true and correct copy of the following documents to be served via first class mail, postage prepaid, on Holders of Claims or Interests in Classes 1(a) – 1(g) (Other Priority Claims); Classes 3(a) – 3(g) (Other Secured Claims); Classes 5(c) – 5(f) (General Unsecured Claims); Classes 7(c) – 7(f) (Intercompany Claims); Classes 9(b) – 9(f) (Interests); and Classes 10(a) and 10(g) (Super-Subordinated Claims):

- a. Notice of (I) Approval of Disclosure Statement, (II) Deadline for Voting on the Plan, (III) Confirmation Hearing Date, and (IV) Deadline for Filing Objections to the Confirmation of the Plan (the “**Confirmation Hearing Notice**”); and
- b. Notice of Non-Voting Status to Holders of Claims in Classes 1(a)-(g), 3(a)-(g), 5(c)-(f), 7(c)-(f), 9(a)-(f), 10(a), and 10(g) (the “**Notice of Non-Voting Status**”).

6. On or before the Solicitation Mailing Date, in accordance with the Solicitation Procedures Order and at the direction of Gibson Dunn, GCG caused a true and correct copy of the following documents to be served via overnight courier, postage prepaid, on the Holders of Claims in Classes 2(a) – 2(f) (SCB Claims):

- a. Confirmation Hearing Notice;
- b. Letter from The Official Committee of Unsecured Creditors in support of the Plan (the “**Committee Letter**”);
- c. CD-ROM containing the Disclosure Statement (with all exhibits thereto, including the Plan) (the “**Disclosure Statement CD-ROM**” and, together with the Confirmation Hearing Notice and Committee Letter, the “**Solicitation Package**”);
- d. Customized Ballot for Voting to Accept or Reject Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors under Chapter 11 of the Bankruptcy Code – Ballot for Voting Classes 2(a)-(f) SCB Claims (the “**Class 2(a)-2(f) Ballot**”); and
- e. Postage prepaid preaddressed return envelope for submission of the Ballot to GCG (the “**Return Envelope**”);

7. On or before the Solicitation Mailing Date, in accordance with the Solicitation Procedures Order and at the direction of Gibson Dunn, GCG caused a true and correct copy of the following documents to be served via overnight courier, postage prepaid, on the Holders of Claims in Classes 4(a) and 4(b) (Syndicated Facility Claims and Arcsukuk Claims):

- a. Solicitation Package;
- b. Customized Ballot for Voting to Accept or Reject Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors under Chapter 11 of the Bankruptcy Code – Ballot for Voting Classes 4(a) and (b) Syndicated Facility Claims and Arcsukuk Claims (the “**Class 4(a) and 4(b) Ballot**”); and
- c. Return Envelope.

8. On or before the Solicitation Mailing Date, in accordance with the Solicitation Procedures Order and at the direction of Gibson Dunn, GCG caused a true and correct copy of

the following documents to be served via overnight courier, postage prepaid, on the Holders of Claims in Class 5(a) (General Unsecured Claims):

- a. Solicitation Package;
- b. Customized Ballot for Voting to Accept or Reject Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors under Chapter 11 of the Bankruptcy Code – Ballot for Voting Class 5(a) General Unsecured Claims (the “**Class 5(a) Ballot**”); and
- c. Return Envelope.

9. On or before the Solicitation Mailing Date, in accordance with the Solicitation Procedures Order and at the direction of Gibson Dunn, GCG caused a true and correct copy of the following documents to be served via overnight courier, postage prepaid, on the Holders of Claims in Class 5(b) (General Unsecured Claims):

- a. Solicitation Package;
- b. Customized Ballot for Voting to Accept or Reject Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors under Chapter 11 of the Bankruptcy Code – Ballot for Voting Class 5(b) General Unsecured Claims (the “**Class 5(b) Ballot**”); and
- c. Return Envelope.

10. On or before the Solicitation Mailing Date, in accordance with the Solicitation Procedures Order and at the direction of Gibson Dunn, GCG caused a true and correct copy of the following documents to be served via overnight courier, postage prepaid, on the Holders of Claims in Class 5(g) (General Unsecured Claims):

- a. Solicitation Package;
- b. Customized Ballot for Voting to Accept or Reject Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors under Chapter 11 of the Bankruptcy Code – Ballot for Voting Class 5(g) General Unsecured Claims (the “**Class 5(g) Ballot**”); and
- c. Return Envelope.

11. On or before the Solicitation Mailing Date, in accordance with the Solicitation Procedures Order and at the direction of Gibson Dunn, GCG caused a true and correct copy of the following documents to be served via overnight courier, postage prepaid, on the Holders of Claims in Classes 7(a), 7(b), and 7(g) (Intercompany Claims):

- a. Solicitation Package;
- b. Customized Ballot for Voting to Accept or Reject Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors under Chapter 11 of the Bankruptcy Code – Ballot for Voting Classes 7(A), (B), and (G) Intercompany Claims (the “**Class 7(a), 7(b), and 7(g) Ballot**”); and
- c. Return Envelope.

12. On or before the Solicitation Mailing Date, in accordance with the Solicitation Procedures Order and at the direction of Gibson Dunn, GCG caused a true and correct copy of the following documents to be served via overnight courier, postage prepaid, on the Holders of Claims in Class 8(a) (Subordinated Claims):

- a. Solicitation Package;
- b. Customized Ballot for Voting to Accept or Reject Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors under Chapter 11 of the Bankruptcy Code – Ballot for Voting Class 8(a) Subordinated Claims (the “**Class 8(a) Ballot**”); and
- c. Return Envelope.

13. On or before the Solicitation Mailing Date, in accordance with the Solicitation Procedures Order and at the direction of Gibson Dunn, GCG caused a true and correct copy of the following documents to be served via overnight courier, postage prepaid, on the Holders of Interests in Class 9(g) (Interests):

- a. Solicitation Package;
- b. Customized Ballot for Voting to Accept or Reject Second Amended Joint Plan of Reorganization of Arcapita Bank B.S.C.(c) and Related Debtors under

Chapter 11 of the Bankruptcy Code – Ballot for Voting Class 9(g) Interests in Falcon Gas Storage Company, Inc. (the “**Class 9(g) Ballot**”); and

c. Return Envelope.

14. On or before the Solicitation Mailing Date, in accordance with the Solicitation Procedures Order and at the direction of Gibson Dunn, GCG caused a true and correct copy of the following documents to be served via overnight courier, postage prepaid, on the Holders of Interests in Class 9(a) (Interests in Arcapita Bank B.S.C.(c)):

- a. Confirmation Hearing Notice;
- b. Notice to Holders of Equity Interests in Arcapita Bank B.S.C.(c);
- c. Notice of Non-Voting Status; and
- d. Customized Shareholder Acknowledgment and Assignment (“**SAA**”).

15. On or before the Solicitation Mailing Date, in accordance with the Solicitation Procedures Order and at the direction of Gibson Dunn, GCG caused a true and correct copy of the following documents to be served via first class mail, postage prepaid, on the master service list that GCG maintains in these cases (which includes all parties that had filed requests for notice in these Chapter 11 Cases pursuant to Bankruptcy Rule 2002 as of the Solicitation Mailing Date):

- a. Disclosure Statement CD-ROM; and
- b. Confirmation Hearing Notice.

16. On or before the Solicitation Mailing Date, in accordance with the Solicitation Procedures Order and at the direction of Gibson Dunn, GCG caused a true and correct copy of the Confirmation Hearing Notice to be served via first class mail, postage prepaid, on all parties in GCG’s creditor database that did not fall within any of the categories set forth in paragraphs 5 through 15 of this certification.

17. On May 8, 2013, GCG filed an affidavit of service detailing its service of solicitation materials on behalf of the Debtors in accordance with the Solicitation Procedures Order (Docket No. 1076).

18. On April 26, 2013, GCG posted a copy of the Plan and Disclosure Statement and on April 29, 2013, GCG posted a copy of the Solicitation Procedures Order on the creditor information website established in the Chapter 11 Cases (<http://www.gcginc.com/cases/arcapita>).

19. GCG promptly complied with all requests from interested parties for copies of the solicitation documents, including ballots for those parties entitled to vote.

TABULATION PROCEDURES

20. Pursuant to the Solicitation Procedures Order, members of the Voting Classes were directed to return the applicable ballots either (a) if by first class mail, to: Arcapita Bank B.S.C.(c) – Ballot Processing, c/o GCG, P.O. Box 9881, Dublin, OH 43017-5781, Attention: Arcapita Bank B.S.C.(c) Ballot Processing; (b) if by personal delivery or overnight courier, to: Arcapita Bank B.S.C.(c) – Ballot Processing, c/o GCG, 5151 Blazer Parkway, Suite A, Dublin, OH 43017, Attention: Arcapita Bank B.S.C.(c) Ballot Processing; or (c) if by electronic mail, to: ArcapitaBallotProcessing@gcginc.com, so as to be received by GCG no later than 12:00 p.m. (prevailing Eastern Time) on May 30, 2013 (the “**Voting Deadline**”)⁴.

21. Upon GCG’s receipt of a Class 2(a)-(f) Ballot; Class 4(a) and 4(b) Ballot; Class 5(a) Ballot; Class 5(b) Ballot; Class 5(g) Ballot; Class 7(a), 7(b), and 7(g) Ballot; Class 8(a) Ballot; and Class 9(g) Ballot (each, a “**Ballot**” and together, the “**Ballots**”); or an SAA, GCG personnel opened the envelope containing the Ballot or SAA, stamped it with the date and time

received, scanned the Ballot or SAA into GCG's system, and assigned it a sequential number (the "Sequence Number"). If GCG received a Ballot or SAA by e-mail, GCG personnel printed out the Ballot or SAA, stamped it with the date and time received, and scanned the Ballot or SAA into GCG's system and assigned it a Sequence Number.

22. GCG personnel then entered into a computer database, reserved exclusively for recording Ballot votes and SAA submissions in these cases, all pertinent information from the Ballot or SAA, including, for Ballots, the date of receipt, Sequence Number, voting dollar or share amount, and acceptance or rejection of the Plan and, in the case of an SAA, the date of receipt, Sequence Number, and the number of shares held.

23. Except as set forth in paragraphs 24 and 25 below, each Claim in Classes 2(a)-2(f); Classes 4(a) - (b); Class 5(a); Class 5(b); Class 5(g); Classes 7(a), (b), and (g); and Class 8(a) was temporarily allowed for voting purposes in a dollar or share amount equal to the face amount of the Claim as set forth in (a) the Debtors' filed Schedules of Assets and Liabilities (the "Schedules"), (b) a timely filed Proof of Claim submitted by the voting party, or (c) as stipulated in an agreement between the Debtors and the voting party (with the stipulated amount taking precedence over the timely filed Proof of Claim, and the timely filed Proof of Claim taking precedence over the Scheduled amount). Each Claim in Class 9(g) was temporarily allowed for voting purposes in a share amount listed in Falcon's stock transfer ledger or similar register as of the Record Date.

24. If a timely filed Proof of Claim identified the Claim as contingent or unliquidated and did not specify the amount claimed or did not specify an amount claimed greater than \$0, then for voting purposes the Claim was temporarily allowed in the amount of one dollar (\$1.00).

25. If (a) a Claim or Interest is listed in the Schedules as contingent, unliquidated, or disputed only in part, or (b) the Debtors filed a Claim Objection to all or any portion of Claim or Interest asserted in a filed Proof of Claim or Proof of Interest on any basis, the Claim or Interest was temporarily allowed in the amount that was liquidated, non-contingent, and undisputed and not subject to the Claim Objection.

26. In accordance with the Solicitation Procedures Order, GCG solicited and tabulated the Ballots in accordance with the following procedures and assumptions:

a. a transfer of a Claim pursuant to Bankruptcy Rule 3001 was recognized for voting purposes only if (i) documentation evidencing the transfer was filed with the Bankruptcy Court and served on or before 21 days prior to the Record Date; and (ii) the transferor did not file a timely objection to the transfer; notwithstanding the foregoing, a transfer of a Claim related to the Syndicated Facility or Arcsukuk Facility was not recognized for voting purposes unless such transfer occurred prior to the Petition Date and in accordance with the transfer requirements of the underlying documents related to the Syndicated Facility or Arcsukuk Facility (as applicable);

b. a Claimant that filed a Proof of Claim or Proof of Interest that is subject to an objection on the basis that the Claim or Interest (i) is duplicative of another Claim or Interest within the same Voting Class; or (ii) amends or supersedes a previously filed Claim or Interest, was provided with only one Solicitation Package and one Ballot for voting a single Claim or Interest in such Voting Class;

c. if a Claimant cast more than one Ballot as to the same Claim or Interest and as to the same Subplan, the last properly executed Ballot received prior to the Voting Deadline was deemed to be the Claimant's final vote and superseded any prior Ballot;

d. for purposes of the “numerosity” requirement of section 1126(c) of the Bankruptcy Code, separate Claims held by a single Claimant in a particular Voting Class as to a particular Debtor were aggregated and treated as if the Claimant held one Claim in that Voting Class, and all votes related to the Claim were treated as a single vote to accept or reject the Subplan; and

e. a Ballot which was otherwise properly executed and received prior to the Voting Deadline, that included a vote to either to accept or reject one or more Subplans, but failed to include a vote to either accept or reject another Subplan on which the Claimant was entitled to vote, was counted only as to the Subplan on which the Claimant voted and was not counted as to the Subplan on which the Claimant failed to vote.

27. In accordance with the Solicitation Procedures Order, the following Ballots were not counted or considered for any purpose in determining whether the Plan has been accepted or rejected:

a. any Ballot received after the Voting Deadline, unless the Debtors, in their sole discretion, extended the Voting Deadline as to the Claimant submitting such Ballot or otherwise elected to accept such Ballot (see ¶ 33, below);

b. any Ballot submitted by facsimile;

c. any Ballot that is not legible, not properly completed, or fails to contain sufficient information to permit the identification of the Claimant or the authority of the party acting on behalf of a Claimant, or otherwise does not comply with the instructions in the Ballot, unless the Debtors, in their sole discretion, permitted the voting Claimant to cure any defect or provide the missing information;

- d. any Ballot cast by a person or entity that does not hold a Claim in a Class that is entitled to vote to accept or reject the Subplan;
- e. any unsigned Ballot;
- f. any Ballot that fails to either accept or reject a Subplan;
- g. any Ballot that both accepts and rejects a Subplan;
- h. any Ballot that partially accepts and partially rejects a Subplan; and
- i. any simultaneously submitted duplicate Ballots with votes that contradict one another with respect to the same Claim and as to the same Subplan.

28. GCG complied in all respects with the provisions of the Solicitation Procedures Order, including as to provisions thereof not explicitly set forth above.

29. GCG is in possession of the Ballots and the same are available for review during GCG's regular business hours at GCG, 5151 Blazer Parkway, Suite A, Dublin, Ohio 43017.

TABULATION RESULTS

30. The results of the tabulation of valid Ballots for the Voting Classes are set forth

32. Exhibit B attached hereto sets forth a detailed accounting of invalid Ballots. In connection therewith, the following entries under “Reason for Invalid Status” have the following meanings:

- a. “Aggregated” means that for purposes of numerosity, pursuant to paragraph 26(a) of the Solicitation Procedures Order, multiple Claims held by a single Creditor in a particular Class were aggregated on a single Ballot;
- b. “Duplicate” means that a voter has cast identical Ballots on account of the same Claim;
- c. “No Vote” means that the voter failed to indicate acceptance or rejection of the Plan or indicated both acceptance and rejection of the Plan;
- d. “Not Entitled to Vote” means that the Ballot was cast (i) by a party not entitled to vote in that Class or (ii) in connection with a scheduled Claim that was subsequently matched to its filed Claim;
- e. “Not Signed” means that the voter failed to sign the Ballot; and
- f. “Superseded” means that the Ballot was superseded by a later valid Ballot cast by the same party on account of the same Claim.

33. With respect to Ballots submitted to GCG after the Voting Deadline but prior to 4 p.m. on the date hereof, in accordance with instructions from Gibson Dunn and paragraphs 25 and 26(l) of the Solicitation Procedures Order, the Voting Deadline as to such Ballots was

extended or the Debtors agreed to accept them as valid. Such Ballots are included in the tabulation set forth herein.
