



## **BACKGROUND**

### **A. General Background**

4. On March 17, 2015 (the “Petition Date”), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code in this Court. The Debtors continue to operate their business and manage their properties as debtors in possession pursuant to Bankruptcy Code sections 1107(a) and 1108. These chapter 11 cases have been consolidated for procedural purposes only and are being jointly administered pursuant to Bankruptcy Rule 1015 and Local Rule 1015-1. On March 25, 2015, the Office of the Acting United States Trustee, Region 3 (the “U.S. Trustee”) appointed the Official Committee of Unsecured Creditors (the “Committee”). No request for the appointment of a trustee or examiner has been made in these chapter 11 cases.

### **B. Specific Background**

5. On September 18, 2015, the Debtors filed a motion seeking authorization to commence a marketing and sale process to sell substantially all of their assets [D.I. 636] (the “Sale Motion”). The Court approved procedures for soliciting bids and conducting an auction with respect to that sale on October 6, 2015 [D.I. 681]. Thereafter, the Debtors and their advisors spent nearly four months marketing the Debtors’ assets and working with potential bidders, followed by an auction that resulted in a winning bid of \$245 million submitted by BlueStone Natural Resources II, LLC (“BlueStone”) for substantially all of the Debtors’ assets. *See* D.I. 1072. The sale to BlueStone, which was approved by this Court on January 27, 2016 [D.I. 1095], closed on April 6, 2016 (the “Closing Date”) [D.I. 1298].

6. Following the Closing Date, substantially all of the Debtors' field operations have ceased. As a result, the Debtors no longer require the goods and services associated with such operations. Indeed, the Debtors expect that their post-Closing Date operations will be focused primarily on the administration and wind-down of their estates. Because the nature of the Debtors' ongoing operations has shifted as of the Closing Date, the Debtors evaluated all of the executory contracts and unexpired leases that were not assumed and assigned to BlueStone. The Debtors have determined that the executory contracts described on Exhibit 1 to Exhibit A (the "Rejected Contracts") are no longer necessary to the Debtors' operations and should be rejected.

7. Specifically, the Rejected Contracts relate predominantly to the Debtors' field operations, which, as noted above, have ceased as of the Closing Date. Following the Closing Date, the Rejected Contracts will not benefit the Debtors and their estates. By rejecting the Rejected Contracts *nunc pro tunc* to the date hereof, the Debtors will realize significant cost savings and avoid incurring unnecessary administrative expense claims. Therefore, the Debtors believe that rejection of these Rejected Contracts *nunc pro tunc* to the date hereof is essential to maximizing value for the benefit of all stakeholders during the wind-down of their estates.

8. To provide clarity and convenience to all parties in interest, the Debtors will serve on counterparties to the Rejected Contracts a customized version of the notice substantially in the form attached hereto as Exhibit B, without Exhibit 1, which notice will include (a) instructions regarding how to view Exhibit 1 on the Debtors' case website, (b) information necessary and appropriate to provide notice of the proposed rejection of the Rejected Contracts, and (c) instructions on how to file a claim for rejection damages. The Debtors will also serve a full copy of Exhibit 1 on the Rule 2002 Notice List.

**RELIEF REQUESTED**

9. By this motion, pursuant to Bankruptcy Code sections 105(a) and 365(a) and Bankruptcy Rule 6006, the Debtors request entry of the Proposed Order authorizing and approving the rejection of the Rejected Contracts, as set forth in **Exhibit 1** to the Proposed Order effective *nunc pro tunc* to the date hereof (April 12, 2016).

**SUPPORTING AUTHORITY**

**A. Rejection of the Rejected Contracts Is Appropriate and Provides the Debtors with Significant Cost Savings**

10. Bankruptcy Code section 365(a) provides that a debtor in possession, “subject to the court’s approval, may . . . reject any executory contract or unexpired lease of the debtor.” 11 U.S.C. § 365(a). The decision to assume or reject an executory contract is a matter within the “business judgment” of the debtor. *See Nat’l Labor Relations Bd. v. Bildisco & Bildisco (In re Bildisco)*, 682 F.2d 72, 79 (3d Cir. 1982) (“The usual test for rejection of an executory contract is simply whether rejection would benefit the estate, the ‘business judgment’ test.” (citing 2 COLLIER ON BANKRUPTCY ¶ 365.03 (15th ed. 1981))); *In re Trans World Airlines, Inc.*, 261 B.R. 103, 121 (Bankr. D. Del. 2001) (noting that the business judgment standard is “widely accepted” in the context of rejecting executory contracts). Application of the business judgment standard requires a court to approve a debtor’s business decision unless the decision is the product of bad faith, whim, or caprice. *Lubrizol Enters., Inc. v. Richmond Metal Finishes*, 756 F.2d 1043, 1047 (4th Cir. 1985); *In re Caribbean Petroleum Corp.*, 444 B.R. 263, 268 (Bankr. D. Del. 2010). Further, “[t]his provision allows a trustee to relieve the bankruptcy estate of burdensome agreements which have not been completely performed.” *Stewart Title Guar. Co. v. Old Republic Nat’l Title Ins. Co.*, 83 F.3d 735, 741 (5th Cir. 1996) (citation omitted); *see also In re Rickel Home Ctrs., Inc.*, 209 F.3d 291, 298 (3d Cir. 2000) (citing *Stewart Title*).

11. Rejection of an executory contract is appropriate where such rejection would benefit the estate. *Sharon Steel Corp. v. Nan Fuel Gas Distrib. Corp. (In re Sharon Steel Corp.)*, 872 F.2d 36, 39-40 (3d Cir. 1989). Upon finding that a debtor has exercised its sound business judgment in determining that rejection of certain contracts is in the best interests of its creditors and all parties in interest, a court should approve the rejection under Bankruptcy Code section 365(a). *In re Fed. Mogul Global, Inc.*, 293 B.R. 124, 126 (D. Del. 2003); *see also In re Wheeling-Pittsburg Steel Corp.*, 59 B.R. 129, 136 (Bankr. W.D. Penn. 1986) (discussing deference accorded by court to debtors' decision to assume or reject an executory contract, which "should be granted as a matter of course") (quoting *In re Summit Land Co.*, 13 B.R. 310, 315 (Bankr. D. Utah 1981)).

12. The rejection of the Rejected Contracts is a proper exercise of the Debtors' business judgment. As set forth above, the Debtors have consummated the sale of substantially all of their assets to BlueStone. Following the Closing Date, the Debtors no longer conduct field operations. Therefore they can no longer realize the benefits of the Rejected Contracts that were associated with their pre-petition business. In light of this, the Debtors, together with their advisors, analyzed all of their executory contracts that were not assumed and assigned to BlueStone in connection with the sale, and specifically identified the Rejected Contracts as those which the Debtors no longer need following the Closing Date. For the Debtors to wind down their estates and to maximize the value for the benefit of their creditors, the Debtors believe that the Rejected Contracts must be rejected. Accordingly, the decision to reject the Rejected Contracts is a proper exercise of the Debtors' business judgment, and rejection of the Rejected Contracts should be approved.

**B. Rejection of the Rejected Contracts *Nunc Pro Tunc* to the Date Hereof Is Appropriate Under the Circumstances**

13. In authorizing the Debtors' rejection of the Rejected Contracts, the Debtors request that such rejection be effective *nunc pro tunc* to the date hereof. Bankruptcy courts are empowered to grant such retroactive rejection of a contract or lease under Bankruptcy Code sections 105(a) and 365(a). *See, e.g., In re Chi-Chi's, Inc.*, 305 B.R. 396, 399 (Bankr. D. Del. 2004) (acknowledging that a bankruptcy court may approve a rejection retroactive to the date the motion is filed after balancing the equities in the particular case); *In re Fleming Cos.*, 304 B.R. 85, 96 (Bankr. D. Del. 2003) (stating that rejection has been allowed *nunc pro tunc* to the date of the motion in certain circumstances); *In re Filene's Basement, LLC*, No. 11-13511(KJC) (Bankr. D. Del. Nov. 22, 2011), [D.I. 246] (authorizing the rejection of executory contracts and unexpired leases *nunc pro tunc* to the petition date at a "second day" hearing); *Thinking Machines Corp. v. Mellon Fin. Servs. Corp. (In re Thinking Machines Corp.)*, 67 F.3d 1021, 1028 (1st Cir. 1995) (noting that "[i]n the section 365 context, this means that bankruptcy courts may enter retroactive orders of approval, and should do so when the balance of equities preponderates in favor of such remediation").

14. Indeed, courts in this jurisdiction have considered and allowed retroactive rejection to dates before entry of the order approving the rejection. *See, e.g., In re Energy Future Holdings Corp.*, No. 14-10979 (CSS) (Bankr. D. Del. June 30, 2014) [D.I. 1316] (authorizing *nunc pro tunc* rejection of lease); *In re Longview Power, LLC*, Case No. 13-1211 (BLS) (Bankr. D. Del. June 23, 2014) [D.I. 1309] (authorizing rejection of leases *nunc pro tunc* to filing date of motion); *In re QCE Fin. LLC*, Case No. 14-10543 (PJW) (Bankr. D. Del. Apr. 22, 2014) [Docket No. 238] (authorizing rejection of executory contract effective *nunc pro tunc* to petition date); *In re EWGS Intermediary, LLC*, No. 13-12876 (MFW) (Bankr. D. Del. Mar. 24, 2014) [D.I. 326]

(authorizing *nunc pro tunc* rejection of certain real property leases); *In re Old FENM Inc.*, No. 13-12569 (KJC) (Bankr. D. Del. Jan. 23, 2014) [D.I. 507] (same); *In re OnCure Holdings, Inc.*, No. 13-11540 (KG) (Bankr. D. Del. Aug. 20, 2013) [D.I. 274] (authorizing rejection of unexpired lease *nunc pro tunc* to petition date). This Court has also previously approved retroactive rejection in these chapter 11 cases. *See Order Authorizing and Approving Rejection of Certain Executory Contracts Nunc Pro Tunc to the Dates Specified* [D.I. 213]; *Order Authorizing and Approving Second Motion to Reject Executory Contracts Effective as of the Dates Specified* [D.I. 334].

15. Here, the balance of the equities favors rejection *nunc pro tunc* to the date hereof (April 12, 2016). As set forth above, following the Closing Date, the Rejected Contracts provide no benefit to the Debtors, and instead impose a financial burden on the Debtors' estates. Absent retroactive rejection, the Debtors could be forced to incur unnecessary administrative claims and obligations under the Rejected Contracts without any corresponding tangible benefit to their estates. The Debtors are also providing contract counterparties with notice of rejection via customized notices with detailed information and instructions. These customized notices will notify each counterparty that its respective executory contract(s) with the Debtors will be rejected as of the date hereof. Accordingly, the Debtors respectfully submit that it is fair and equitable for the Court to order that the Rejected Contracts be rejected *nunc pro tunc* to the date hereof.

#### **DEBTORS' RESERVATION OF RIGHTS**

16. Nothing contained herein is intended or should be construed as an admission as to the validity of any claim against the Debtors, a waiver of the Debtors' rights to dispute any claim, or an approval or assumption of any agreement, contract, or lease under Bankruptcy Code section 365. Likewise, if this Court grants the relief sought herein, any payment made pursuant

to the Court's order is not intended and should not be construed as an admission as to the validity of any claim or a waiver of the Debtors' rights to dispute such claim subsequently.

**NOTICE**

17. No trustee or examiner has been appointed in the Debtors' chapter 11 cases. The Debtors have provided notice of this motion to (a) the U.S. Trustee, Attn: Jane Leamy, Esq.; (b) the counterparties to the Rejected Contracts; (c) counsel to the Committee; (d) counsel to the agents under the Debtors' pre-petition credit facilities; (e) counsel to the Ad Hoc Group of Second Lienholders; (f) counsel to the Ad Hoc Group of Senior Noteholders; (g) counsel to the indenture trustees under the Debtors' pre-petition indentures; (h) the SEC; (i) the Internal Revenue Service; and (j) any parties entitled to notice pursuant to Local Rule 2002-1(b). In light of the nature of the relief requested in this motion, the Debtors respectfully submit that no further notice is necessary.



WHEREFORE, for the reasons set forth herein, the Debtors respectfully request that the Court (a) enter the Proposed Order, substantially in the form annexed hereto as **Exhibit A**, granting the relief requested in the motion and (b) grant such other and further relief as may be just and proper.

3. Any claims based on rejection of the Rejected Contracts shall be filed no later than thirty (30) days after entry of this Order in accordance with the *Order Establishing Deadlines and Procedures for Filing Proofs of Claim and Approving the Form and Manner of Notice Thereof* [Docket No. 417-2].

4. Notwithstanding the relief granted herein and any actions taken hereunder, nothing contained in this Order shall constitute, nor is it intended to constitute, an admission as to the validity or priority of any claim against the Debtors, the creation of an administrative priority claim on account of the pre-petition obligations sought to be paid, or the assumption or adoption of any contract or agreement under Bankruptcy Code section 365.

5. Notice of the motion as provided herein shall be deemed good and sufficient and such notice satisfies the requirements of Bankruptcy Rule 6004(a) and the Local Rules.

6. The Debtors are authorized to take all actions necessary to effectuate the relief granted pursuant to this order.

7. The Court retains jurisdiction with respect to all matters arising from or related to the interpretation or implementation of this order.
