DEBTORS' FIRST (NON-SUBSTANTIVE) OMNIBUS OBJECTION TO CERTAIN CLAIMS THAT ARE (A) DUPLICATIVE OF A CLAIM FILED ON THE CLAIMANT'S BEHALF, (B) ON ACCOUNT OF EQUITY INTERESTS, OR (C) LATE FILED

The debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the "<u>Debtors</u>") seek entry of an order, substantially in the form attached hereto as <u>Exhibit D</u>, expunging the claims set forth on <u>Exhibits A</u>, <u>B</u>, and <u>C</u> hereto because such claims either are duplicative of a claim filed on the claimant's behalf or are on account of equity interests and, in certain instances, were not timely filed. In support of the Objection, the Debtors rely on the *Declaration of Vanessa Gomez LaGatta in Support of the Debtors' First (Non-Substantive) Omnibus Objection to Certain Claims that are (A) Duplicative of a Claim Filed on the Claimant's Behalf, (B) Filed on Account of Equity Interests, or (C) Late Filed (the "<u>LaGatta Declaration</u>").² In support of this objection, the Debtors respectfully state as follows:*

JURISDICTION

- 1. This Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2).³
 - 2. Venue in this Court is proper pursuant to 28 U.S.C. §§ 1408 and 1409.
- 3. The predicates for the relief requested herein are sections 105 and 502 of chapter 11 of title 11 of the United States Code (the "Bankruptcy Code"), rule 3007 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), and Local Rule 3007-1.

BACKGROUND

A. General Background

- 4. On March 17, 2015 (the "Petition Date"), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code in this Court. The Debtors continue to operate their business and manage their properties as debtors in possession pursuant to Bankruptcy Code sections 1107(a) and 1108. These chapter 11 cases have been consolidated for procedural purposes only and are being jointly administered pursuant to Bankruptcy Rule 1015 and Local Rule 1015-1. No request for the appointment of a trustee has been made in these chapter 11 cases. On March 25, 2015, the Acting United States Trustee, Region 3 (the "U.S. Trustee") appointed the statutory committee of unsecured creditors (the "Committee") [D.I. 119].
- 5. A description of the Debtors and their business is set forth in greater detail in the *Declaration of Vanessa Gomez LaGatta in Support of First Day Pleadings* [D.I. 19] (the "<u>First Day Declaration</u>") filed on the Petition Date and is incorporated herein by reference.

B. Specific Background

- (i) The Schedules and Bar Date
- 6. On June 9, 2015, each Debtor filed its respective Schedule of Assets and Liabilities and Statement of Financial Affairs [D.I. 383-401; 403-412; 414] (collectively, the "Schedules and Statements"). Debtor Quicksilver Resources Inc. filed an amendment to its Schedule of Assets and Liabilities on June 25, 2015 [D.I. 443] and an amendment to its Statement of Financial Affairs on July 1, 2015 [D.I. 455].
- 7. On the May 19, 2015, the Debtors also filed the *Debtors' Motion for Entry of an Order Establishing Deadlines and Procedures for Filing Proofs of Claim and Approving the Form and Manner of Notice Thereof* [D.I. 349] (the "Bar Date Motion"). The Court entered an order on June 10, 2015 [D.I. 417] (the "Bar Date Order") granting the relief requested in the Bar Date Motion, which, among other things, established July 31, 2015 at 5:00 p.m. (prevailing Eastern Time) as the time and date by which any person or entity (excluding governmental units) asserting a claim against the Debtors in their chapter 11 cases was required to file a proof of claim (the "General Bar Date"). *See* Bar Date Order, ¶ 2.
- 8. In accordance with the Bar Date Order, Garden City Group LLC ("GCG"), the Debtors' court-appointed claims and noticing agent, mailed notices of the General Bar Date and proof of claim forms to, among others, all of the Debtors' creditors and other known parties in interest as of the Petition Date. Notice of the General Bar Date was also published once in the *New York Times*, *Fort Worth Star-Telegram*, and certain local publications. *See* D.I. 435, 436, 499, 518, and 520.
 - (ii) Proofs of Claim
- 9. To date, approximately 539 proofs of claim have been filed in these chapter 11 cases. The Debtors and their advisors are in the process of comprehensively reviewing and

reconciling each of the filed claims and comparing them with the Debtors' books and records to determine the validity of such claims. As part of this ongoing review, the Debtors have reviewed each of the claims listed on **Exhibit A**, **Exhibit B**, and **Exhibit C** hereto and have concluded that each such claim is appropriately objected to on one or more of the bases set forth below. Importantly, each of the late-filed claims listed on **Exhibit C** also appears on either **Exhibit A** or **Exhibit B**.

RELIEF REQUESTED

10. By this Objection, the Debtors respectfully request entry of an order, pursuant to Bankruptcy Code sections 105(a) and 502(b), Bankruptcy Rule 3007, Local Bankruptcy Rule 3007-1, and the Bar Date Order disallowing and expunging certain claims that (i) are individual noteholder claims that are duplicative of other claims filed by an indenture trustee on behalf of individual noteholders (the "Noteholder Claims"), (ii) were filed on account of equity interests in the Debtors (the "Equity Claims"), or (iii) were filed after the General Bar Date (the "Late Claims").

CLAIM OBJECTIONS

- 11. When asserting a proof of claim against a bankrupt estate, a claimant must allege facts that, if true, would support a finding that the debtor is legally liable to the claimant. *In re Allegheny Int'l, Inc.*, 954 F.2d 167, 173 (3d Cir. 1992); *Matter of Int'l Match Corp.*, 69 F. 2d 73, 76 (2d Cir. 1934) (finding that a proof of claim should at least allege facts from which legal liability can be seen to exist). Where the claimant alleges sufficient facts to support its claim, its claim is afforded *prima facie* validity. *In re Allegheny Int'l, Inc.*, 954 F.2d at 173.
- 12. As a result, a party wishing to dispute such a claim must produce evidence in sufficient force to negate the claim's *prima facie* validity. *Id.* The objecting party must produce evidence that would refute at least one of the allegations essential to the claim's legal

sufficiency. *Id.* Once the objecting party produces such evidence, the burden shifts back to the claimant to prove the validity of his or her claim by a preponderance of the evidence. *Id.* The burden of persuasion is always on the claimant. *Id.*

13. Accordingly, the Debtors submit that, for the reasons more fully set forth below, the Noteholder Claims, the Equity Claims, and the Late Claims should be disallowed and expunged in their entirety.

A. Noteholder Claims

- 14. Quicksilver, as issuer, and Cowtown Pipeline Funding, Inc., Cowtown Pipeline Management, Inc., Cowtown Pipeline L.P., Cowtown Gas Processing L.P., Barnett Shale Operating LLC, Silver Stream Pipeline Company LLC, QPP Parent LLC, and QPP Holdings LLC (collectively, the "Subsidiary Guarantors"), as subsidiary guarantors, are party to four issuances of bond debt: (i) the "Second Lien Notes"⁴; the "2019 Senior Notes"⁵; the "2021 Senior Notes"⁶; and the "Senior Subordinated Notes."⁷
- 15. The claims listed on **Exhibit A** hereto are claims that are limited exclusively to the repayment of principal, interest, and/or other applicable fees and charges (each a

"Debt Claim") owed under a bond or note issued by the Debtors pursuant to an indenture (a "Debt Instrument"). Pursuant to paragraph 7(l) of the Bar Date Order, however, holders of Debt Claims were not required to file a proof of claim on or before the General Bar Date, provided that an indenture trustee under a Debt Instrument (each an "Indenture Trustee") filed a proof of claim, on or before the General Bar Date, with respect to all of the amounts owed under each of the Debt Instruments. Bar Date Order, ¶ 7(l).

16. Each Indenture Trustee filed the requisite proof of claim. Specifically, on July 30, 2015 BNY, as indenture trustee for the Second Lien Notes, filed proofs of claim numbered 468 through 476 asserting Debt Claims against Quicksilver and the Subsidiary Guarantors on account of the Second Lien Notes (collectively, the "Master Second Lien Notes Claims"). On July 16, 2015, U.S. Bank, as indenture trustee for the 2019 Senior Notes Indenture, filed a proof of claim numbered 317 asserting a Debt Claim against Quicksilver and the Subsidiary Guarantors on account of the 2019 Senior Notes (the "Master 2019 Senior Notes Claim"). On July 10, 2015, Delaware Trust, as indenture trustee for the 2021 Senior Notes Indenture, filed proofs of claim numbered 255 through 263 asserting Debt Claims against Quicksilver and the Subsidiary Guarantors on account of the 2021 Senior Notes (the "Master 2021 Senior Notes Claims"). On July 27, 2015, Wilmington Trust, as indenture trustee for the Senior Subordinated Notes Indenture, filed a proof of claim numbered 401 asserting a Debt Claim against Quicksilver and the Subsidiary Guarantors on account of the Senior Subordinated Notes (the "Master Senior Subordinated Notes Claim" and together with the Master Second Lien Notes Claims, the Master 2019 Senior Notes Claim and the Master 2021 Senior Notes Claims, the "Indenture Trustee Claims").

- Exhibit A hereto are duplicative of one or more of the Indenture Trustee Claims. If an individual noteholder's claim were allowed in addition to the applicable Indenture Trustee Claim, the noteholder would recover twice—once under the applicable Indenture Trustee Claim, as well as under the individual claim. Double recoveries of this sort are not permitted under the Bankruptcy Code, and the Debtors should not be required to satisfy the same obligation twice. See, e.g., In re Handy Andy Home Improvement Ctrs., Inc., 222 B.R. 571, 575 (Bankr. N.D. Ill. 1998) ("it is axiomatic that one cannot recover for the same debt twice").
- Noteholder Claims included on **Exhibit A** hereto and (b) seek entry of an order disallowing and expunging in their entirety the Noteholder Claims under the column heading "Duplicate Claim to be Disallowed". If the Debtors' objection to the Noteholder Claims is sustained, the claims listed under the column heading "Remaining Claim Number" will survive on the claims register, subject to the Debtors' right to object on any grounds that bankruptcy or non-bankruptcy law permits.⁸ Therefore, any claimant holding a Noteholder Claim will suffer no prejudice by having the applicable Noteholder Claim disallowed.

B. Equity Claims

- 19. The claims listed on **Exhibit B** hereto under the heading labeled "Claim(s) to be Disallowed & Expunged" were each filed by a shareholder based on the ownership of equity securities in one of the Debtors. The Bankruptcy Code defines an "equity security" as:
 - (A) share in a corporation, whether or not transferable or denominated "stock", or similar security;
 - (B) interest of a limited partner in a limited partnership; or

(C) warrant or right, other than a right to convert, to purchase, sell, or subscribe to a share, security, or interest of a kind specified in subparagraph (A) or (B) of this paragraph.

11 U.S.C. § 101(16). Holders of equity securities, such as shares of stock, do not have "claims" under Bankruptcy Code section 101(5), but rather equity interests. *See In re Insilco Techs., Inc.*, 480 F.3d 212, 218 (3rd Cir. 2007) ("[an equity] interest is not a claim at all"); *In re Hedged-Invs. Assocs.*, 84 F.3d 1267, 1272 (10th Cir. 1996) ("Simply put, an equity interest is not a claim against the debtor" (quotations omitted)).

20. Each of the claimants set forth on **Exhibit B** hereto have filed proofs of claim that do not assert not any claim at all, but rather assert ownership of equity interests. The Debtors were able to identify the claimants that have asserted these Equity Claims because those claimants noted on the proof of claim form that the claim was filed on account of such an interest, or, in certain instances, the claimants submitted a brokerage statement with the proof of claim demonstrating such ownership. Because the equity interests asserted by holders of the Equity Claims are not in fact claims against the Debtors, the Debtors believe that all such Equity Claims should be disallowed and expunged. Accordingly, the Debtors (a) object to the Equity Claims listed on **Exhibit B** hereto, and (b) seek entry of an order disallowing the Equity Claims in their entirety.

C. Late Claims

21. The claims listed on <u>Exhibit C</u> hereto under the heading labeled "Claims to be Disallowed & Expunged" were filed after the General Bar Date. Importantly, each of the claims listed on <u>Exhibit C</u> also appear on either <u>Exhibit A</u> or <u>Exhibit B</u> hereto. Pursuant to the Bar Date Order, with certain exceptions, all holders of claims (except governmental units) were

required to file a proof of claim with supporting documentation on or before the General Bar Date. As noted, the Late Claims identified on **Exhibit C** were filed after the General Bar Date and, therefore, do not comply with the Bar Date Order. In addition, the Debtors have examined each of the Late Claims and determined that such claims are not specific amendments to a timely-filed claim. Failure to disallow the Late Claims will result in the applicable claimant receiving an unwarranted recovery to the detriment of the Debtors and creditors who complied with the Bar Date Order and timely filed proofs of claim in these chapter 11 cases. Accordingly, the Debtors hereby (a) object to the Late Claims listed on **Exhibit C** and (b) request entry of an order disallowing and expunging the Late Claims in their entirety.

RESPONSES TO THE OBJECTION

Exhibit C hereto, a claimant must file and serve a written response to this Objection (a "Response") so that it is actually received no later than October 27, 2015 at 4:00 p.m. (prevailing Eastern Time) (the "Response Deadline"). Every Response must be filed with the Office of the Clerk of the United States Bankruptcy Court for the District of Delaware (the "Clerk"), 824 North Market Street, Wilmington, Delaware 19801, and served upon the following entities, so that the Response is actually received no later than the Response Deadline, at the following addresses:

- (i) Every Response to this Objection must contain at a minimum the following information:
 - (a) a caption setting forth the name of this Court, the name of the Debtors, the case number, and the title of this Objection;
 - (b) the claimant's name, the claim number, and a description of the basis for the amount of the claim:
 - (c) the specific factual basis and supporting legal argument upon which the claimant will rely in opposing this Objection;
 - (d) any supporting documentation, to the extent it was not included with the claim previously filed with the Clerk or GCG, upon which the claimant will rely to support the basis for and amounts asserted in the claim; and
 - (e) the name, address, telephone number, and fax number of the person(s) (which may be the claimant or the claimant's legal representative) with whom counsel for the Debtors should communicate with respect to the claim or the Objection and who possesses authority to reconcile, settle, or otherwise resolve the Objection to the disputed claim on behalf of the claimant.

23. If a claimant fails to file and serve a timely Response by the Response Deadline, the Debtors may present to the Court an appropriate order disallowing and expunging the claim, without further notice to the claimant or a hearing.

REPLIES TO RESPONSES

24. Consistent with Local Rule 9006-1(d), the Debtors may, at their option, file and serve a reply to a claimant's Response no later than 4:00 p.m. (prevailing Eastern Time), one day prior to the deadline for filing the agenda for any hearing scheduled to consider the Objection.

SEPARATE CONTESTED MATTERS

25. To the extent a Response is filed regarding any claim listed in the Objection and the Debtors are unable to resolve the Response, the objection by the Debtors to such claim shall constitute a separate contested matter as contemplated by Bankruptcy Rule 9014. Any order entered by the Court regarding an objection asserted in this Objection shall be deemed a separate order with respect to each claim subject thereto.

RESERVATION OF RIGHTS

26. The Debtors hereby reserve the right to (i) file subsequent objections to any claims subject hereto on any ground, (ii) amend, modify, or supplement this Objection, including, without limitation, the filing of objections to further amended or newly-filed claims, (iii) seek to expunge or reduce any claim to the extent all or a portion of such claim has been paid; and (iv) settle any claim for less than the asserted amount. Separate notice and a hearing will be provided in respect of any such additional objections.

COMPLIANCE WITH LOCAL RULE 3007-1

27. To the best of the Debtors' knowledge and belief, this Objection and **Exhibit A**, **Exhibit B**, or **Exhibit C** attached hereto, comply with Local Rule 3007-1. To the extent this Objection does not comply in all respects with the requirements of Local Rule 3007-1, the

undersigned believes such deviations are not material and respectfully requests that any such requirement be waived.

NOTICE

28. No trustee or examiner has been appointed in the Debtors' chapter 11 cases. The Debtors have provided notice of this motion to (i) the U.S. Trustee, Attn: Jane Leamy, Esq.; (ii) counsel to the Committee; (iii) counsel to the agents under the Debtors' pre-petition credit facilities; (iv) counsel to the Ad Hoc Group of Second Lienholders; (v) counsel to the indenture trustees under the Debtors' pre-petition indentures; (vi) each of the claimants whose claim is subject to this Objection; and (vii) any parties entitled to notice pursuant to Local Rule 2002-1(b). In light of the nature of the relief requested in this Objection, the Debtors respectfully submit that no further notice is necessary.

- 1. I am the Senior Vice President, Chief Financial Officer, and Treasurer of Quicksilver Resources Inc. ("Quicksilver" and, together with its affiliated Debtors, the "Debtors"). I have been employed in this capacity by Quicksilver since January 2015 and previously served as Quicksilver's Vice President Treasurer since September 2009. Accordingly, I am familiar with Quicksilver's day-to-day operations, business, and financial affairs.
- 2. I submit this declaration (the "<u>Declaration</u>") in support of the *Debtors' First* (Non-Substantive) Omnibus Objection to Certain Claims that are (A) Duplicative of a Claim

- 4. The proofs of claim subject to the Objection were carefully reviewed and analyzed in good faith using due diligence by the appropriate personnel including the Debtors' employee personnel, Deloitte Transactions and Business Analytics LLP personnel, Akin Gump Strauss Hauer & Feld LLP personnel, and GCG personnel. These efforts resulting in the identification of the Noteholder Claims, the Equity Claims, or the Late Claims (collectively, the "Disputed Claims") and identified respectively in **Exhibit A**, **Exhibit B**, and **Exhibit C**, to the Objection.
- 5. The information contained in the Objection and **Exhibit A**, **Exhibit B**, and **Exhibit C** to the Objection is true and correct to the best of my knowledge and belief.
- 6. The Debtors have determined that the claimants asserting the Noteholder Claims identified on **Exhibit A** to the Objection were filed by individual noteholders and are duplicative of one or more of the Indenture Trustee Claims. Accordingly, to prevent the claimants who filed the Noteholder Claims from receiving an unwarranted double recovery, the Debtors seek to disallow the Noteholder Claims identified on **Exhibit A** to the Objection in full.

7. The Debtors have determined that the claimants asserting the Equity Claims identified on **Exhibit B** to the Objection were each filed by a shareholder based on the ownership of equity securities in one of the Debtors.³ Because the equity interests asserted by holders of the Equity Claims are not valid claims against the Debtors, the Debtors seek to disallow the Equity Claims listed on **Exhibit B** to the Objection in full.

8. The Debtors have determined that the claimants asserting the Late Claims identified on **Exhibit C** to the Objection were filed after the General Bar Date and were not specific amendments to timely-filed claims. Accordingly, to prevent the claimants who failed to timely file their claims and receiving an unwarranted recovery to the detriment of the Debtors and creditors who complied with the Bar Date Order and timely filed proofs of claim in these chapter 11 cases, the Debtors seek to disallow the Late Claims listed on **Exhibit C** to the Objection in full.
