**ORDER DISALLOWING CERTAIN CLAIMS THAT ARE
(A) DUPLICATIVE OF A CLAIM FILED ON THE CLAIMANT'S
BEHALF, (B) FILED ON ACCOUNT OF EQUITY INTERESTS, OR (C) LATE FILED**

Upon the Objection² of the above-captioned Debtors (collectively, the “Debtors”), pursuant to Bankruptcy Code sections 105 and 502, Bankruptcy Rule 3007, and Local Rule 3007-1, to certain (A) Noteholder Claims, (B) Equity Claims and (C) Late Claims, all as further described in the Objection; and the Court having jurisdiction to consider the Objection and the relief requested therein in accordance with 28 U.S.C. §§ 157 and 1334; and consideration of the Objection and the relief requested therein being a core proceeding in accordance with 28 U.S.C. § 157(b)(2); and venue being proper in this District pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Objection being adequate and appropriate under the particular circumstances; and the Court having found and determined that the relief sought in the Objection is in the best interests of the Debtors, the Debtors’ creditors, and other parties in interest and that the legal and factual bases set forth in the Objection establish just cause for the relief granted

herein; and after due deliberation and sufficient cause appearing therefor, it is hereby ORDERED:

1. The Objection is sustained to the extent provided herein.
2. The Noteholder Claims listed on the attached **Exhibit A** under the heading labeled “Duplicate Claim to be Disallowed” are disallowed and expunged in their entirety.
3. The Equity Claims listed on the attached **Exhibit B** under the heading labeled “Claim(s) to be Disallowed & Expunged” are disallowed and expunged in their entirety.
4. The Late Claims listed on the attached **Exhibit C** under the heading labeled “Claim(s) to be Disallowed & Expunged” are disallowed and expunged in their entirety.
5. The Debtors’ rights to (i) file subsequent objections to any claims listed on **Exhibit A**, **Exhibit B**, or **Exhibit C** attached hereto on any ground; (ii) amend, modify, or supplement the Objection, including, without limitation, the filing of objections to further amended or newly-filed claims; (iii) seek to expunge or reduce any claim to the extent all or a portion of such claim has been paid; and (iv) settle any claim for less than the asserted amount are expressly preserved. Additionally, should the grounds of objection stated in the Objection be denied, the Debtors’ rights to object on any other grounds are preserved.
6. The objection by the Debtors to each claim, as addressed in the Objection and as set forth in **Exhibit A**, **Exhibit B**, or **Exhibit C** attached hereto, constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014 and Local Rule 3007-1. This Order shall be deemed a separate Order with respect to each claim that is the subject of the Objection. Any stay of this Order pending appeal by any claimants whose claims are subject to this Order shall only apply to the contested matter that involves such claimant and shall not act to stay the

applicability and/or finality of this Order with respect to the other contested matters addressed in the Objection and this Order.

7. The Debtors, the claims and noticing agent, GCG, and the Clerk of this Court are authorized to take any and all actions that are necessary or appropriate to give effect to this Order.

8. This Court shall retain jurisdiction over the Debtors and the claimants whose claims are the subject of the Objection with respect to any matters related to or arising from the Objection or the implementation of this Order.
