1 Pursuant to this Court’s order of October 25, 2018, Doc. 602, Defendants  
2 Edison International, Southern California Edison Company, the Southern California  
3 Edison Company Benefits Committee, the Edison International Trust Investment  
4 Committee, the Secretary of the SCE Benefits Committee, SCE’s Vice President of  
5 Human Resources, and the Manager of SCE’s Human Resources Service Center  
6 (collectively, “Defendants”) hereby submit their plan of allocation for allocating the  
7 \$13,161,491 judgment awarded by the Court (the “Judgment Amount”), plus any  
8 interest accrued thereon. In connection with this Notice of Filing of Plan of  
9 Allocation (“Notice”), Defendants further state as follows:

10 1. On October 25, 2018, the Court entered Judgment in this case. Doc.  
11 602.

12 2. The Court ordered Defendants to “allocate the amount deposited in the  
13 Plan’s trust account to class participants according to a plan of allocation,” and  
14 further ordered Defendants to, “file their plan of allocation, and . . . concurrently  
15 serve it on Plaintiffs’ counsel, no later than 60 days prior to making the  
16 allocations[.]” Doc. 602 at 2, 4.

17 3. On November 13, 2018, the Court ordered Defendants to deposit the  
18 Judgment Amount into the Court Registry Investment System (“CRIS”), and  
19 provided that, “the Judgment Amount . . . shall remain on deposit [in the CRIS]  
20 until further order of this Court.” Doc. 606 at 2.

21 4. On May 27, 2020, this Court entered an order directing the Clerk of  
22 Court to distribute the Judgment Amount, plus any interest accrued thereon. Doc.  
23 610.

24 5. On June 9, 2020, the Judgment Amount, plus accrued interest, was  
25 disbursed from the CRIS for deposit in the Plan’s trust account. Doc. 612.

26 6. In accordance with the Court’s order of October 25, 2018, Defendants  
27 hereby submit the plan of allocation as Attachment A to this Notice.
