JUDGMENT

On September 26, 2018, this Court granted final approval to the class settlement and entered its Order Granting Final Approval of Class Action Settlement (Final Approval Order).

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:

1. The settlement class is defined as:

All customers (including individuals and businesses) who ordered and paid for food delivered in California through Caviar's website (trycaviar.com) or mobile application from January 20, 2012 through and including August 31, 2015.

2. No Settlement Class Member objected to the settlement.

3. No Settlement Class Member requested to be excluded from the settlement.


4. Plaintiff Spencer Janssen and the settlement class shall take nothing from the complaint in this action except as set forth in (i) the Final Approval order; (ii) the Stipulation Regarding Settlement of

1 Class Action (Settlement Agreement) attached thereto; (iii) the Order Approving Plaintiffs' Attorneys'
2 Fees and Costs; and (iv) the Order Approving Service Award, also filed September 21, 2018.

3 5. Pursuant to the Settlement Agreement, section 664.6 of the California Code of Civil
4 Procedure, and rule 3.769(h) of the California Rules of Court, this Court retains jurisdiction over Plaintiff
5 Spencer Janssen, the settlement class, and Defendant Square, Inc. to enforce the terms of the Settlement
6 Agreement, the Final Approval Order, and this Judgment.

7 IT IS SO ORDERED.
