Thank you for all the documentation you provided; however, the Grace B. Cooke Gas Unit, totaling 134.059 acres, does not include any portion of NE/4 NW/4 in Section 35, T18N, R9W in Webster Parish, LA. Therefore, the referenced Will Seamster lease (LA-4992-A) is not included in the unit.

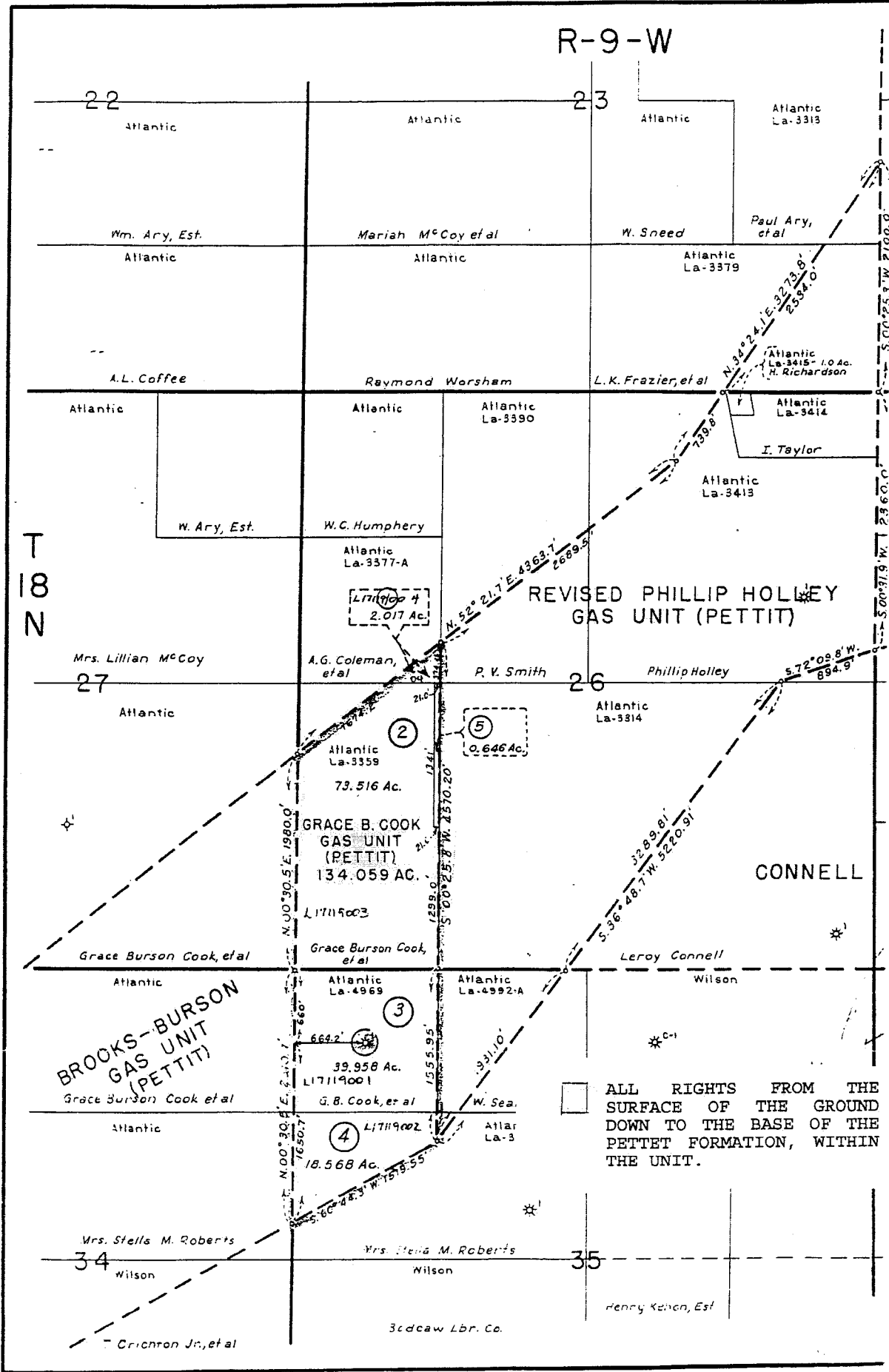

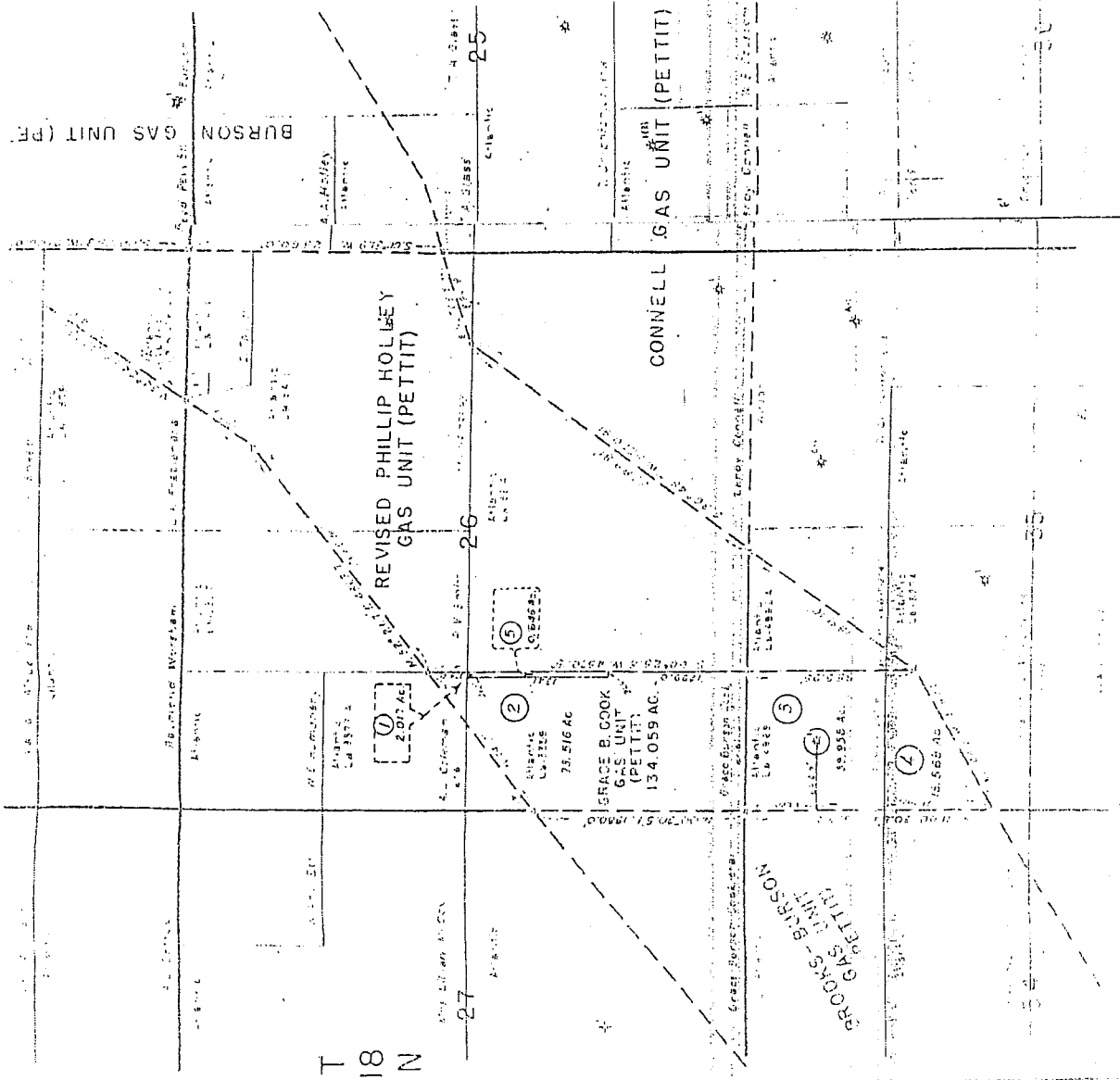
