NOTICE OF SUCCESSFUL BIDDERS

PLEASE TAKE NOTICE that, on September 30, 2016, the United States Bankruptcy Court for the District of Delaware entered the *Order (I) Establishing Bidding Procedures and Granting Related Relief and (II) Approving the Sale of Certain Assets Free and Clear of Liens, Claims, Encumbrances, and Interests* [Docket No. 1425] (the “Bidding Procedures Order”). Capitalized terms used but not defined herein shall have the meanings ascribed to them in the Bidding Procedures Order.

PLEASE TAKE FURTHER NOTICE that, pursuant to the Bidding Procedures Order, the Bid Deadline occurred on October 4, 2016.

PLEASE TAKE FURTHER NOTICE that, as of the Bid Deadline, the Debtors did not receive any additional Bids for the Central Anadarko Assets, the West Anadarko Assets, the East Anadarko Assets, the Williston Assets, or the San Juan Assets other than those previously submitted by the Stalking Horse Bidders. Accordingly, the Debtors will not conduct an Auction for such assets and will seek approval at the Sale Hearing of the sales of such assets to the applicable Successful Bidder as set forth below.
