[Claim No. 784]; Nixon Peabody LLP [Claim No. 83]; Sleep Services of America Inc [Claim No. 497], Surgical Monitoring Associates [Claim No. 505], and Women Medical Wellness (Claim No. 248); and the Court having jurisdiction to

consider the Twelfth Objection under 28 U.S.C. §§ 157(a)-(b) and 1334(b); and upon the record of the hearing held by the Court on the Twelfth Objection on March 16, 2016; and the Court having found and concluded that the legal and factual basis set forth in the Twelfth Objection establish cause for the relief granted herein and that such relief is in the best interest of the Debtors' estate, creditors and other parties in interest; and good and sufficient cause appearning, it is hereby
