ORDER GRANTING SEVENTEENTH OMNIBUS OBJECTION TO CLAIMS

Qugley [Docket No. 1350]; and the Seventeenth Objection having come before the Court for a hearing held on September 14, 2016 (the "Hearing"); and upon the record made before the Court on that date; and, after due deliberation, the Court having found that the relief requested in the Seventeenth Objection is in the best interest of the Debtors' estates, creditors and other parties in interest; and, based on the record herein and for the reasons stated in the Court's bench Ruling at the Hearing, the Court having overruled all objections and responses and having determined that the legal and factual basis set forth in the Seventeenth Objection establish sufficient cause for the relief granted herein, it is hereby

extent set forth below and upon the terms and conditions set forth herein; and it is further

ORDERED, that Claim numbers 840 (Juanita Butte), 1521 (Juanita Butte), 622 (Donald

Carniato), 744 (Salvatore Cerrerta), 461 (Janet Ivanoff), 544 (Laura Johnson), 1418 (William

Quigley), 949 (William Quigley), 832 (Cathleen M. Ronan), 550 (Ceclia Scott), 643 (Daniel

Vallario), and 645 (Ulysses R. Vanderlip) are disallowed and expunged in full; and it is further

ORDERED, that the Claims listed on Exhibit A hereto are hereby disallowed and

expunged to the extent asserted for Health Benefits and Life Insurance, and are reduced and

reclassified to the extent asserted for Severance Payments as set forth in Exhibit A; and it is

further

ORDERED, that distributions shall be withheld with respect to the Claims listed on

Exhibit A hereto unless and until general unsecured creditors, as a class, receive the respective

pro-rata distribution under the Plan set forth in Exhibit A; and it is further

ORDERED, that the Debtors' claims and noticing agent, Garden City Group, LLC., and

the Clerk of this Court are authorized to take any and all actions that are necessary or appropriate

to give effect to this Order; and it is further

ORDERED, that this Order is deemed to be a separate order with respect to each claim

covered hereby; and it is further

ORDERED, that all rights of the Plan Administrator to object to any surviving claims

against the Debtors, whether asserted or unasserted by any of the claimants affected by the

Seventeenth Objection, and to further object to the surviving claims on any other grounds

discovered by the Plan Administrator during the pendency of this case are hereby reserved; and it

is further

ORDERED, that this Court shall retain jurisdiction over any and all issues arising from

or related to the implementation and interpretation of this Order.
